## **BRIEF TESTIMONY AND BACKGROUND OF KACY AND KAAMALA RAY**

### **KACY RAY**

I was saved out of a drug and gang background at the age of 21 after being led to Christ by the man who would become my Pastor, Bryan Dahlke. Shortly after my salvation, I believe that the Lord was calling me into full-time ministry. I enrolled in Massillon Baptist College about 6 months after my salvation and graduated in 2022. Within my tenure in Bible college I took a missions trip to the Republic of Armenia in an evangelistic effort of Iranian Muslims as well as two internships, one with our sending Church and another as a Church planting assistant in Dearborn, Michigan with Missionary David Gates. I followed this training with 2 years on staff at Massillon Baptist Temple in Massillon, Ohio where I served as Assistant Pastor and Assistant Principal. It was during this time that we believe the Lord called us as Missionaries to Muslim people and to plant a Church in the city of Hamtramck, Michigan.

### **KAAMALA RAY**

My wife was saved out of a Hindu High Priest's family at the age of 13. She was led to Christ by reading the Bible on her own in her home county of Nepal. For several years following her salvation, she kept her faith a secret from her friends and family for fear of shunning and abuse. She pursued secular studies and career throughout her teen years until she arrived in the United States at the age of 23. It was then that she finally began to actively attend Church and grow in the things of God. She made the decision not only to publicly be a follower of Jesus Christ, but to marry a Preacher and commit to serve together as the Lord would lead us.

### **OUR FAMILY**

The Lord has given us two daughters, Kelcy, born October 2023 and Kristina, born March 2025. We believe that God has brought us together by His providence to see Muslim people come to know Jesus Christ as their Savior.

## **DOCTRINAL STATEMENT ASCRIBED TO**

### **BY MISSIONARY KACY RAY**

#### **I. The Bible**

A. I believe the Bible was written by holy men of old, as they were moved by the Holy Spirit, in such a definite way that their writings were supernaturally and verbally inspired and free from error, as no other writings have ever been or ever will be inspired.

B. . I believe the King James Bible is the Word of God in the English language.

1. I only use the King James Bible in the English Language

C. Other languages: We use the Old Carey Version Bible in the Bangla Language and the Smith Van Dyke Bible for the Arabic language.

#### **II. GOD**

A. I believe there is only one God manifested in three distinct persons: The Father, The Son, and The Holy Spirit. All 3 persons of the Godhead/ Trinity play a simultaneous, yet distinct role in the redemption of mankind.

#### **III. Jesus**

A. I believe that Jesus is the Eternal Son of God, Creator of the universe in unity with the Father and the Holy Spirit. Jesus left Eternity and Heaven to be born of a virgin, live a sinless life and die for the sins of the world. He is the only Savior of mankind and man's soul. I believe that Jesus will return to Earth one day and literally reign as King for 1,000 years. I believe that Jesus is the Head of every local Church administrating through the Holy Spirit.

#### **IV. The Holy Spirit**

A. I believe the Holy Spirit is a divine Person; equal with God the Father and God the Son and of the same nature; that He convicts of sin, of judgment, and righteousness; that He bears witness to the Truth of the Gospel in preaching and testimony; that He is an active agent in the New Birth; that He seals, endues, guides, teaches, witnesses, sanctifies, and helps the believer.

B. I believe the Holy Spirit indwells the believer upon salvation.

#### **V. Creation**

A. I believe the Genesis account of creation, and that it is to be accepted literally, and not allegorically or figuratively; that man's creation was not a matter of evolution or evolutionary changes of species, or development through interminable periods of time from lower to higher forms; but simply that God said and there was.

#### **VI. The atonement for sin**

A. I believe that Jesus Christ died for the sins of the whole world. He lived a perfect, sinless life and died in the sinner's place. He now offers salvation to all who will call upon Him as Savior in repentance and faith.

#### **VII. The Church**

A. I believe a Church is a local assembly of baptized believers organized together for fellowship and edification in Christ and to fulfill the Great Commission.

B. I believe that the institution of the Local Church began during Jesus' earthly ministry with Himself and His disciples and was empowered by the Holy Spirit on the day of Pentecost as accounted in Acts chapter 2, beginning the "Church" at large.

1. I believe the Church manifests itself as Local Churches globally during this time and will be assembled as one body without division upon the return of Christ (rapture).

#### **VIII. The ordinances**

A. The Lord's Supper

1. I believe the Lord's supper is an ordinance of the Local Church and is symbolic of the death and blood atonement of Jesus Christ on the cross of Calvary.

2. The Lord's supper consists of unleavened bread and unfermented grape juice.

B. Baptism

1. I believe that baptism is only for believers and is a symbol of the death, burial, and resurrection of Jesus in which a believer now identifies.

2. Baptism is by water immersion.

#### **VIV. Missions**

A. I believe the Great Commission was given to the first Church in Jerusalem and is thus inherent for every local Church.

1. I believe that the only authority to send Missionaries falls upon the Local Church.

**Doctrinal Agreeance:** I do not believe Churches, Pastors, and Missionaries have to agree upon every detail of doctrine. A Church or Pastor may not full agree with our doctrinal statement on every point and in every detail. We may not agree with every detail of a Church's doctrinal agreement. However, we are willing to partner with Churches upon the understanding of our position for the furtherance of the Gospel at that Church's discretion and decision.

Dear Pastor,

I had the privilege to lead Kacy Ray to the Lord, disciple him, and see him go off to Bible college to study for full-time ministry. Since his Freshman year in college, he has expressed a desire to preach the gospel among Muslim people groups. I have watched him grow in his knowledge of scripture, his experience in ministry, and his ability to communicate the Word through preaching.

Kaamala came to our church as a single lady who had grown up in Nepal where the Word of God was all but outlawed. She had been saved, but it was illegal for her to be baptized in her home country. Soon after she began attending CCBC, she asked us to baptize her and we did. Kaamala underwent discipleship training and was a faithful member at CCBC.

Kacy and Kaamala met while Kacy was interning at CCBC. It was my honor to be a part of their wedding ceremony and to see them commit not only to each other but to serve the Lord together wherever God called them. After spending two years on staff at another church, Kacy felt God leading him to begin reaching Muslims to Christ.

Recently, Capitol City Baptist Church decided to partner with Kacy & Kaamala and be their sending church. We believe Kacy and Kaamala are well suited for the long and difficult task of trying to build a church in the only Muslim majority city in America. We believe it will take many years of hard work to see the fruit of Muslims coming to Christ and in most cases forsaking their family and community to serve the Lord. Kaamala has endured similar difficulties from her family in Nepal when she got saved and decided to marry a preacher.

I would ask you to prayerfully consider partnering with Kacy & Kaamala and that you do so with the mindset that Kacy is not planting an American church in an American city but with the mindset that Kacy will essentially be planting a church in a foreign culture. We ask that your partnership with them not be for a year or two, but for the duration of their ministry as you would with any missionary going to a foreign field.
