**\*She's being given extra pain medication to help her get through the spinal tap since she has to lie on her stomach. Please keep her in your prayers.**

- As of Wednesday, February 4th - She's doing well! She managed to sit up in a chair for a bit yesterday, which is a big win. She's still feeling quite weak and dealing with some pain, and is sticking to a liquid diet for now. However, the doctor is very pleased with her progress—so much so that she's being downgraded to PCU! Thank you for the continued love and prayers.
- As of Tuesday, February 3rd at 9:30 am - Laura was able to come off of the breathing tube and came completely off of sedation. She is still having a hard time talking and is groggy but she is awake and in good spirits! The Doctor came in this morning and she is running a little bit of a temp, the labs came back that she has a respiratory virus that will have to run its course. The hope is that she will get out of the ICU and be moved to med surg tomorrow. Thank you all for your prayers!
