

Prayer Requests

- **Laura Carr - As of Tuesday, February 17 - After monitoring her condition over the last 24 hours, the medical team has decided to move forward with surgery.**
 - **Timeline: Surgery is scheduled for approximately 3:00 PM today.**
 - **The Goal: The surgeons are going back in to locate and repair the source of the issue and will be placing a drain to help manage the infection in her abdomen.**
 - **Next Steps: We expect to have a much clearer picture of her recovery path once the procedure is complete.**

As of Monday, February 16 - She is currently being cared for in ICU Room 2 as the medical team manages several serious complications:

- Infection & Potential Surgery: Doctors have identified an infection in her abdomen. They are currently monitoring her for the next 24 hours to determine if there is a bowel leak. If a leak is confirmed, she will require surgery to repair it and clean out the infection.
- Blood Clots: She is dealing with a Deep Vein Thrombosis (DVT) in her right leg, superficial clots in her left leg, and small pulmonary embolisms (clots) in both lungs. She is on blood thinners to address these.
- Blood Health: Her hemoglobin and iron levels are critically low, and her body's blood production has slowed. The team is placing a PICC line to administer blood transfusions and necessary medications.
- Pneumonia: She is also being treated for a "touch of pneumonia," further complicating her respiratory recovery.

 - As of January 19th at 2:30 pm - Mrs. Terri is in the ER and has a blood clot in her lung. They are giving her a high dosage of heparin to help dissolve the clot. They are hoping that she gets to go home tomorrow.
- Vickie Lucas, Dawn Katzer's Mom - As Vickie's health declines, she is moving into hospice care to ensure she is as comfortable as possible. They anticipate a journey of several months ahead. Please pray for Dawn's strength and for Vickie's medical team as they coordinate the best plan for her comfort and care.
