

# You Must Reject Abortifacient Birth Control and Fetal Tissue Vaccines

December 5, 2020. Ekklesia Muskogee

## Introduction

1. **Just before my wife and I were married in October 2003, she did what most of her** Christian women friends did and started on chemical birth control. She asked her doctor for an IUD because many of her friends were using them not to have babies. Her doctor would not prescribe IUDs. She said she was a Christian, and because IUDs cause embryos to be sloughed off the lining of the uterus, they would kill the baby. This was news to us. Why hadn't our Christian community said anything? She said other birth controls did this as well, but she believed it was a much smaller percentage. So we moved to the patch. A patch is replaced every week and not worn during the week of the cycle. When her cycle didn't come, she afraid to put the patch back on. Sure enough, we ended up pregnant with our first child. We always wondered if we put the patch back on, would we have lost the baby, and did we lose others before?
2. **A little while later, while in Seminary at Southwestern, Dr. Albert Mohler spoke to us** young seminarians about abortifacient birth control that kills babies in the womb. He warned us that many of us were killing our children without knowing. Around 2012, our church in Fort Worth wrote a statement informing the body about BC. Many were shocked and didn't know.
3. **My prayer is that many of you will not be shocked at this information, but my guess** is you will. What follows is the most in-depth presentation I've ever given on abortifacient birth control and vaccines made of aborted babies.
4. **My aims today are:**
  - a. **(1) to work out a couple of devastatingly widespread, but mainly obscured,** implications of God's command to "rescue those being taken to death."  
**Overwhelming numbers of Christians are guilty of participating in murderous** schemes and devices, mostly by unintention, that carry our preborn neighbors to the slaughter.
  - b. **(2) to minister the gospel of our sovereign King and gracious Savior.** You need to know that the accomplishments of Christ on the cross extend to all your sins. God's truth proclaimed produces God's will obeyed and enjoyed in God's church.
5. **MAIN IDEA: We must rescue those being carried off to slaughter by rejecting** murderous medicines (abortifacient BC) and murder-sourced medicines (vaccines containing aborted fetal tissue).
6. **OUTLINE: (1) We didn't know!?" Unintentional Sins; (2) You Must Reject Murderous** Medicine; (3) You Must Reject Murder-sourced Medicine; (4) God knows and will repay.

## 1. “We didn’t know?” Unintentional Sins Prov 24:12

### 1. In Proverbs 24:11, God commands us to “rescue those being taken away to death.”

But there are some in verse 12 who, upon hearing this command announce their ignorance, **“Behold, we did not know this.”** “We didn’t know people were being led to slaughter! How could we rescue them if we didn’t know about them? Even more, how can we be held responsible for their deaths if we didn’t know the details surrounding their death?

- a. It’s hard to know if this is willful ignorance, or legitimate ignorance. It’s like the guy who tells the police officer, “I didn’t know I was speeding!” and the officer cocks his head sideways, “You saw none of the signs. Didn’t check your speedometer. Didn’t question yourself? You do understand how driving works? Either way, whether willfully or legitimately ignorant, you’re still breaking the law.”
- b. **Here’s the trouble with our alleged ignorance.** Those who think little about the holiness of God, think little about the sinfulness of man. They should’ve been thinking much more of both.

### 2. There are three general categories of human sin. Sins of:

- (1) **Commission or Omission:** In thought or desire, word or deed, did you act in sin (commission), or fail to do what you should’ve (omission)? The Apostle Paul abhors his tendency to both of these sins in Romans 7:14-20.
- (2) **Intentional or Unintentional:** In thought or desire, word or deed, did you mean to sin or not. Did you know you were sinning or were you ignorant that you were sinning?
- (3) **Personal or Corporate:** How many are involved in the sin? Just you, many, the whole church?

### 3. Some Examples:

- a. **Personal sins of intentional commission.** These are sins a person intentionally takes action to commit, whether in thought or desire, word, or deed. I know what I’m doing is sin. Adam and Eve’s eating. King David’s adultery. Peter’s denial and Judas’ betrayal.
- b. **Personal sins of intentional omission.** These are sins in which I knew I should’ve done something good but refused to do it. **James 4:17** “*So whoever knows the right thing to do and fails to do it, for him it is sin.*” This is Ananias and Saphira knowingly withholding what the Holy Spirit told them to give to the church (Acts 5:1-11; cf Luke 10:30-37).<sup>1</sup>
- c. **Sins of unintentional omission.** These are sins in which we should have done something good but didn’t because we did not know we should’ve acted.

- d. **Sins of unintentional commission.** These are sins we unintentionally take action to commit, whether in thought or desire, word or deed. We acted sinfully but didn't know it was sin when we did it. A *corporate example* is the Jews' murdering Jesus (Acts 3:17; 13:7; 1 Cor 2:8).<sup>2</sup> A *personal example* is Paul's killing of Christians before his conversion (Acts 26:9; 1 Tim 1:13).<sup>3</sup>
4. **Let's get to the heart of the theme of this conference. I will make open statements of the truth directly to your conscience, then support the assertions.**
- a. **Personal sins of unintentional commission:** killing your preborn child by using abortifacient birth control and partaking of vaccines made from murdered children. Pastors, you're responsible before God for informing Christ's bride under your watchcare of these personal sins of unintentional commission. You cannot remain silent or tickle itching ears on this topic.
  - b. **Corporate sins of unintentional commission:** A local church killing its preborn by using abortifacient birth control and aborted fetal tissue laden vaccines because it lacks a faithful undershepherd to preach the truth.
  - c. **Many Christians are legitimately uninformed** (they really don't know) or are misinformed (they were wrongly told), or are willfully uninformed (they don't want to know) about chemical birth control and vaccines.
5. **Why all this talk of intentional and unintentional sins? Why not just leave us alone in our unintentional sins? Isn't it better if we don't know we're sinning? Here's why.**
- (1) **12b God weighs our hearts. Does not he who weighs the heart perceive it?**
- (a) **The LORD looks on the heart (1 Sam 16:7). He knows the secrets of the heart** (Psa 44:21). God weighs the heart, tests it in comparison to His holiness. He analyzes it and evaluates your thoughts and desires, words, and deeds against His holy perfection. Prov 16:2 **"All the ways of a man are pure in his own eyes, but the LORD weighs the spirit."** People's ways seem right in their own opinion, but God evaluates the motives.
- (2) **12c God knows our sins. Does not he who keeps watch over your soul know it,**
- (a) **God, who is holiness defined, meticulously knows of all deviations in this universe from His holiness.** The omniscience of King Jesus extends over all aberrations from His holy standard in all His creation. Nothing is hidden from Him.
- (3) **12d God will respond/judge. And will he not repay man according to his work?**
- (a) **Not only does God know, but because He is holy and just, He will respond.** Jer 17:10 **"I the LORD search the heart and test the mind, to give every man according to his ways, according to the fruit of his deeds."**

**(b) According to the gospel, there is a coming day when King Jesus will disclose the purposes of the heart, bring to light the hidden things, and judge men's secrets (Rom 2:16; 1 Cor 4:5).**

6. **So the argument, “We didn’t know the preborn were being led to slaughter!? What could we do?!” will not clear our record before God. If you did not know until now, God has providentially brought you within the sound of my voice to remove any notion of excuse from your defense.**
7. **TRANSITION:** God knows the truths I’m about to expose to you. God’s glorious, unmatched goodness and freedom of life with Christ is found in our joyful obedience and holiness. So, open your hearts and minds to receive the truth.

## **2. Murderous Medicine: Chemical Birth Control**

**Many Christians are legitimately uninformed** (they really don’t know) or are misinformed (they were wrongly told), or are willfully uninformed (they don’t want to know) about chemical birth control.<sup>4</sup> **Even still. To rescue those being carried away to slaughter, we must reject the murderous medicine, chemical birth control.**

### **1. Conceiving Lies: Deadly Doublespeak**

1. **Edward S. Herman, in his book, *Beyond Hypocrisy*, describes** doublespeak: It’s “the ability to lie, whether knowingly or unconsciously, and to get away with it; and the ability to use lies and choose and shape facts selectively, blocking out those that don’t fit an agenda or program.”<sup>5</sup>
2. **You have been lied to by the Birth Control Industrial Complex. You’ve been a victim of deadly doublespeak. Here’s how.**
3. **Origins of the Birth Control Industrial Complex:**
  - a. **Around 1914-16, Margaret Sanger coined the term “birth control” and started** the first birth control clinic and the American Birth Control League, which later became Planned Parenthood. In the ’50s, Sanger persuaded scientists to create a hormonal birth control pill. In 1960, amidst major ethical concerns, the Food & Drug Administration approved the pill for contraceptive use. In just seven years, over 6.5

million American women were on the pill. By '67, it was used by over 13 million women worldwide.<sup>6</sup>

- b. **Before the 1960s, “fertilization” and “conception” were synonymous terms** defining the beginning of pregnancy. Fertilization occurs at the moment of egg-sperm membrane fusion and the formation of the one-celled embryo (zygote). From that moment and afterward, the embryo formed exhibits all the characteristics of a new, genetically distinct human organism. Biologically and biblically speaking, life begins at fertilization. Fertilization takes place within hours of ovulation.
  - c. **However, in the 1960s, the American College of Obstetrics and Gynecologists** defied biology and Scripture and divorced the two terms and redefined “conception” to be “the completion of implantation,” after the embryo travels down the fallopian tube and attaches to the uterine wall.<sup>7</sup>
  - d. **The ACOG also simultaneously redefined pregnancy. If the embryo did not** implant, they waived the hand and claimed, “a woman was not pregnant.”
  - e. **The effect was that a drug or device that kills an embryo (embryocide), thereby** terminating a pregnancy before the completion of implantation, wouldn’t be termed “abortifacient.” This is why most medical literature and physician advice, and Planned Parenthood don’t talk much about “abortifacient birth control.”
  - f. **There’s another term of deadly doublespeak, and that’s “fertilized egg.”** In medical literature, a human embryo traveling to the uterus, which has not yet implanted, is commonly called a “fertilized egg.” This doublespeak effectively downgrades the moral outcry of killing a human being, an embryo through abortifacient birth control to merely the prevention of a “fertilized egg” from implanting.
  - g. In other words, the consciences of everyone playing along in this game of words can walk a little lighter since it’s just a clump of cells, a fertilized egg, not a baby they’re killing with their medicine that conveniently controls birth.
4. **TRANSITION: These deadly redefinitions served to obscure and radically increase the** immeasurable number of helpless preborn image-bearers carried off to death by chemical birth control. Imagine the scene at judgment day.

## **2. At Best Potential Murderers: All Contraceptive Drugs Have a “Fail” Rate**

1. **You need to know something very important: All contraceptive drugs and devices** “fail” at a certain rate. This is incontrovertible, undeniable evidence that fertilization--thus

the formation of a human embryo--and implantation occur with all modern methods of contraception.<sup>8</sup>

2. **Chemical birth control is intended to create an environment for the embryo that will terminate its survival.** In essence, chemical birth control at least burns down the preborn's home, and at worst, burns the preborn, too.
3. **So, at best, all women using chemical birth control are potential murderers.**

### 3. Murderous Mechanism of Action: How Chemical Birth Control Works

1. **Hormonal birth control,<sup>9</sup> whether single hormone (Mini Pill) or a combination of hormones utilizes man-made (synthetic) estrogen<sup>10</sup> and progestin (Levonorgestrel) to inhibit a woman's natural hormones to prevent or terminate pregnancy.<sup>11</sup>**
2. **The *Physician's Desk Reference* lists hormonal contraceptives as having three mechanisms of action:**
  1. **Attempt to delay or hinder ovulation (release of an egg).**
  2. **Thicken cervical mucus to prevent the sperm from passing through the cervix and entering the fallopian tube to find the egg.**
  3. **Thin the lining of the uterus (endometrium) to prevent the human embryo from implanting on the cervical wall and instead be sloughed off in the woman's period.**
3. **If and when it occurs, the third action is embryocidal or abortifacient since a new human being has been created, but this human being is killed because she is prevented from receiving the nourishment provided by her mother's uterine wall.**
4. **Scientists and medical professionals do not have certainty about how often the abortive mechanism takes place.** Thus, a sexually active woman taking the pill risks aborting a child. To our knowledge, according to the medical literature and medical inserts, combined contraceptives<sup>12</sup> and progestin-only contraceptives<sup>13</sup> all perform the above three mechanisms of action, so are abortifacient.<sup>14</sup>

**An Intrauterine Device (IUD) is a piece of metal or plastic placed inside the uterus in direct contact with the endometrial lining, what is basically the “wallpaper” of the uterus, or womb. It’s well-documented that IUDs function by causing chronic inflammation of the endometrial lining, inhibiting the embryo from implanting, thereby causing embryocide.<sup>15</sup>**

5. **So, with respect to questions surrounding chemical birth control measures,** please understand that Scripture forces us to make every effort not to destroy a human embryo, our preborn neighbor, created in the image of God. After fertilization, we should respond to this most vulnerable human being by providing him/her the safest context for survival.

#### **4. LNG 85% Abortifacient?!?**

1. **“Plan B One-Step” is an FDA approved emergency contraceptive containing the man-made, progestin hormone Levonorgestrel.** It’s technically known as “Levonorgestrel Emergency Contraceptive, LNG-EC.” It’s a pill given within 72 hours of intercourse.<sup>16</sup>
2. **Levonorgestrel is a potent synthetic (man-made) progestin hormone used not only in Plan B but also in many birth control pills for over 35 years,<sup>17</sup> i.e., Mirena (IUD), Kyleena, Lultera, Skyla, Liletta, Aviane, Seasonique.<sup>18</sup>** For years it’s widely been claimed by the FDA and in the medical literature that LNG worked by performing the three MOAs to prevent fertilization.<sup>19</sup> But, recent scientific studies have proven this claim spurious.
3. **In 2016, a peer-reviewed study found that LNG had “no ability to alter sperm function [MOA #2] . . . and has limited ability to suppress ovulation [MOA #1].** Our analysis estimates that the drug’s ovulatory inhibition potential could prevent less than 15 percent of potential conceptions, thus making a pre-fertilization mechanism of action significantly less likely than previously thought.”<sup>20</sup>
4. **In other words, LNG’s primary method of birth control, up to, or over 85% of the time is post-fertilization, by aborting the preborn human embryo.**

5. **This study focused specifically on LNG used in Plan B, but the findings also apply to** LNG's use in hormonal birth control. LNG has little to no effect on preventing ovulation or altering sperm function. It works by aborting a human embryo over 85% of the time.
6. **Stop using hormonal birth control. It kills babies.**

## Conclusion

1. On the day of judgment, multitudes of Christians since the mid-1900's will, for the first time, meet their children slaughtered by abortifacient birth control.

2. There are numerous vaccines cultivated and grown in aborted human tissue or human diploid cell strains (HDCS).

*Albert Sabin publishes a paper about cultivating polio virus in human tissue. In 1954, Enders, Weller, and Robbins win the Nobel Prize in Medicine for cultivating polio in tissues, including embryonic.*

1962

### WI-38

*Cell line taken from lung of 12-week old gestation female. It took a minimum of 19 abortions to obtain.*

*Currently used in Adenovirus, MMR-II, MMRV*

1966

### MRC-5

*Cell line taken from lung of 14-week old gestation male. It took a minimum of 1 abortion to obtain.*

*Currently used in DTaP-IPV, DTaP IPV/Hib, Hep A, Hep A/Hep B, MMRV, Rabies, Varicella, Shingles*

1967

### RA 27/3

*"Rubella Abortus 27th Fetus 3rd Tissue Explant" A minimum of 64 abortions were used in the research & development of the rubella vaccine.*

*Currently used in MMR-II and MMRV.*

1975

### IMR-90

*Cell line taken from lung of 16-week old gestation female. It took a minimum of 1 abortion to obtain.*

*Cell line taken from lung of 3-month old gestation female. It took a minimum of 9 abortions to obtain.*

*Made specifically for cultivating viral vaccines. Not yet used in any vaccines.*

1. **DR. PLOTKIN:** Dr. Stanley Plotkin, known as the Godfather of Vaccines, consultant to vaccine manufacturers, vax patent holder, emeritus Professor of Pediatrics at University of Pennsylvania, under deposition on Jan 11, 2018. Personally used 77 aborted fetuses on
