Six Ways to Give at Salt House

1. The Joy Jar

Give in person by putting your gift into the Joy Jar located near the entrance to the sanctuary. Look for gold painted mason jar—you can't miss it!



2. Text-To-Give

Give easily and intentionally with your mobile phone or smart device.

Text to any amount to 84321.

When you give for the first time, you'll be directed to a registration



page where you enter your credit card or bank info. Going forward you can give via text easily and quickly.

3. Give Online

(set up recurring giving)



Go to salthousechurch.org/giving to access our giving portal in Planning Center. You can make a one-time donation, set up recurring giving, change your giving method and giving schedule, manage your profile, choose your communication preferences, and see your giving history.

4. Amazon Smile

Do you use Amazon for shopping? Consider using Amazon Smile

5. Employer Matching for Microsoft Employees

You can donate via the Microsoft Online Giving tool directly or, if you first give to Salt House and wish to have it matched by Microsoft, please indicate on your gift that the money is restricted to the Community Initiatives fund to ensure proper accounting.

6. Gifting Stock

Gifts of stock to Salt House Church are accepted. There are considerable tax-advantages, especially if you have realized capital gains on your original investment. You will need to consult your tax and/or investment adviser for advice specific to your financial situation.

How is my gift to Salt House used?

Gifts made to Salt House Church are automatically applied to the general fund, unless designated for another fund listed below.

Salt House Funds

General Fund

Ministry Programs, Operations, Staff Salaries and Benevolence.

Reparations Fund (1% of Benevolence)

This fund is specifically for reparations for BIPOC individuals. The fund is allocated for distribution on a scheduled bi-annual basis and overseen by a board of directors. salthousechurch.org/reparations

Queer Fund (1% of Benevolence)

This fund is be used towards ministries and activities that celebrate and empower Queer people of faith, particularly those who have been rejected by their faith communities.

Community Initiatives (Restricted Fund)

Donations to this fund are set-aside for non-ministry investments in our community (i.e., restricted fund). Donations may be matched by employers.
