Prayer: Releasing the Spirit

Boldness to Share God's Word is not just for preachers

Acts 4:31 (NASB95) describes a pivotal moment for the early church: "And when they had prayed, the place where they had gathered together was shaken, and they were all filled with the Holy Spirit and began to speak the word of God with boldness."


The undeniable evidence of the healing of the beggar stood before them, the accusation against Peter and John was that they stirred up the people by preaching about Jesus's resurrection. The religious authorities observed two notable things about them. First, despite lacking formal education, the apostles demonstrated a remarkable command of the Scriptures. Second, the authorities recognized they were Jesus's disciples. While the undeniable healing of the crippled man served as clear evidence of a miracle and the authorities could not refute it, the court threatened the apostles and ordered them to stop preaching and teaching in Jesus's name.

Leaving the court, Peter and John gathered with other disciples and after sharing their testimony, they began to praise God and pray. Their prayer included a request: "grant that Your bondservants may speak Your word with all confidence," asking God to extend His hand to heal and to allow more signs and wonders to take place in Jesus's name. When the believers finished praying, God responded immediately. The place where they met was shaken, and everyone present was filled with the Holy Spirit. As a result, they all began to speak the word of God with boldness.

An unknown author in *The Kneeling Christian* writes that we should "take of God" in prayer and allow the Holy Spirit to "stir us up." By following this example and giving ourselves to steadfast prayer, as the apostles did in Acts 6:4, we allow the Holy Spirit to empower us.

Praying for Boldness

To fulfill the commission of proclaiming the Gospel, we must not rely on our own strength or strategies. Instead, we need the guidance and power of the Holy Spirit, so we may speak God's word with confidence. Apostle Paul asked others to pray that he might speak the Word boldly (Ephesians 6:19) and with clarity (Colossians 4:3-4). Therefore, pray for your pastor, and for yourself, that you may speak God's Word with boldness. Release the Spirit of God in your life through prayer.
