- Restricted funds
- Unrestricted funds

# Two categories of funds

- Restricted funds
- Unrestricted funds

#### **Restricted Funds**

Used only for the specific ministry or event that the funds are designated for.

## Examples:

- Missionary support
- Ministry support (YAC, children's ministry, mission trips)

#### **Unrestricted Funds**

Can be used for any church purpose

## Examples:

- Staff salaries, benefits and taxes
- Facilities (mortgage, utilities, insurance, repairs)
- Other operating costs (supplies, copying, telephone, etc)
- Special events (men's and women's conferences, outreach)

### Sources of Unrestricted Funds

- Tithes and offerings
- Rental income
- CCBC tuition and housing
- Events and other


# Potential property sale

Selling the "Price Ministries" property in the NW corner, 58th and 232nd.

- Elimination of mortgage payment (\$18,808 per month)
- Provide funds for deferred maintenance (carpet, exterior paint, etc.)
- Minimal reserves
- At current giving levels, should allow us to survive (but not thrive)
