

The Greater Exodus Plagues. Pt. 8  
The 10<sup>th</sup>-Plague: Death of the Firstborn.

Ex. 11: 1-10 - 12: 51:

- I. This plague is probably the most familiar of all the Exodus encounters as it is connected to Pesach, which from the text in chapter 12 we know begins sundown the 13<sup>th</sup> of Nissan and ends sundown the 14<sup>th</sup> while the Festival of Unleavened Bread begins at sundown the 14<sup>th</sup> beginning the 15<sup>th</sup> and ends sundown the 22<sup>nd</sup>. What is quite interesting is the timing of this latter event coupled with the previous 9<sup>th</sup> Plague of Darkness!

(First, bear in mind that much controversy surrounds the following supposition as any remote connection to Yahshua as the Pesach Lamb had to be avoided by all Jewish commentators)

Now, pay attention to Exodus 12: 3 where Israel is commanded to bring a lamb into their house on the 10<sup>th</sup> of Nissan and for 4-days it is examined until the Priest declares *"I find no fault in him"* where it is then slaughtered *'between the evenings'* on the 14<sup>th</sup>. In addition, from the account of Abraham in Genesis 17 and 18, we can see a parallel of the Passover account. Abraham and his house are circumcised on the 10<sup>th</sup> and he is sitting under the Oak of Mamre 3-days latter when the Messiah appears with 2 angels and Abraham prepares the Pesach meal.

As we continue to look at Ex. 12 it seems reasonable that Israel would have followed the same pattern in order to fulfill the commandment. Thus, it is my opinion that the Plague of darkness that lasted 3-days would have coincided with the Circumcision of Israel beginning on the 10<sup>th</sup> and ending or lifted afterwards on the 14<sup>th</sup> in time for the Blood of the Pesach Lamb to be applied to their door posts.

This would have been a perfect 'cover' because during any other time where there was a need for healing Israel would not have been allowed 3-days off work, as in this case, had it not been for the Plague of darkness just prior to the slaughter of the First Born.

Neither would they have been able to walk out of Egypt if they were circumcised that same Pesach evening (According to the Rabbis) an event which would be negated by Ps. 105: 37 *He brought them forth also with silver and gold: and there was not one feeble person among their tribes.* Feeble comes from the Hebrew word

H#3782, כַּשָּׁל, kawshal, to stumble, be feeble, weak, to be injured, especially a weakness of the legs.

Let's take a side trip here:

Kawshal has a gematria of 350, the same as the Hebrew word H#6083, עֶפָר, `aphar, that is rendered 'dust' and first seen in **Gen. 2:7** where Adam is formed of the dust of the Adamah! The Translators struggle with the origin of `aphar, defining it as 'dust, fine particles, dry, and powder'.

However, the context – i.e. being formed, יָצַר, yatsar, squeezed, formed or fashioned – from the Adamah, seems to indicate that `aphar was the residue of the Adamah, a word whose root, 'dam' indicates blood; thus prior to the fall the dam would have been the *light substance housing life* – The DNA or building blocks of creation! (**Lev. 17:11** ...*the life of the flesh is in the blood...*) as a result, Israel, following the pattern would have left Egypt in a regenerated condition, born again if you will and circumcision became the physical sign of the cutting off of the dead flesh!

Now, before we get too far ahead of ourselves we need to readdress the 10<sup>th</sup> plague and frame it according to context within the scope of the previous 9-plagues.

Death of the 1<sup>st</sup>-Born:

- II. We all know that YHVH doesn't mince words. Therefore, the choice of the words in **Ex. 11: 1** is notable: And YHVH said unto Moshe: **אל-פרעה ואל-מצרים** **עוד נגע אחד אביא**... 'od nega 'echad 'avi 'al-Paroh v'al-Mitsrayim... The KJV renders this 'Yet I will bring one more plague upon Pharaoh and upon Egypt...'

However, the intentional use of the word 'nega' indicates this to be the 1<sup>st</sup>-time or 1<sup>st</sup> strike of this sort, though we had 9 previous plagues. H#5061, נָגַע, nega, a word meaning a strike or blow, a mark or spot as in leprosy and to lay the hand upon. *It also points toward lying with a woman carnally.*

Curiously, the word **עוֹד**, `OD can also indicate 'to witness', to certify or testify. By connecting our extrapolated definitions of `Od and nega – something entirely different is seen because now the verse could read: And YHVH said unto Moshe "Testify or certify of the sexual immorality and I will bring one Strike or Plague upon Pharaoh and Egypt"! Did Moshe have critical information condemning Egypt and Pharaoh to this 'Death of the Firstborn strike?'

Pay close attention here: נגע, Nega has the same letters as H#6026, ענג, Oneg, meaning ‘delight’ and used to describe the Shabbat. Oneg does indeed mean delight, but more appropriately describes the alluring, enticing and romantically amorous appeal of women. Hence, the Sabbath is called the Bride and should have the appeal to all who guard her! This fervent desire was created by YHVH and given to the Man-Adam for his Woman-Ishshah and solely intended for that Union! There is a unique intimacy reserved for the Sabbath above all other days!

Again, ergo, the reason for the Sabbath being called the ‘Bride’; that we might delight ourselves in YHVH! (Is. 58:14) To contravene the intent of that Union means that what was once a ‘delight’ now becomes a curse and invokes a NEGA – Plague – Strike from YHVH upon that union! The same can be said for not keeping the Sabbath! Is there a connection to this strike perhaps being against the firstborn – offspring of an illicit union?

Allow me to get a bit esoteric for a moment. It is evident that YHVH viewed sexual immorality as an abomination. In this Exodus context Israel stands in the same place as Adam; I.E. the ‘firstborn’ son in His (YHVH’s) image. From Gen. 1 forward the intent is for the Firstborn to produce sons of YHVH to continue His Great Name.

In this vein, Adam was created with the ability to ‘reproduce’ by speaking – wording sons into being! It is *after the fall* that the fleshly or carnal view of sexual reproduction takes place. Anything outside the confines of the Union/Marriage of the Echad Man and the Echad Woman results in a curse/plague/nega upon the union! It was exactly this Oneg-Delight – perversion of carnal appeal - issue that caused both the first Pharaoh and Abimelech to pursue Sarai and later, Rebekah!

Notwithstanding, the ability to produce Sons in the Image of YHVH is the bridge between the spiritual and physical, that bridge is the foundation upon which creation sits. The Mystics call this the Yesod, the 9<sup>th</sup> sephirah or node of the Tree of Life. The Hebrew word עֹד, `OD – to witness or certify, testify – has a gematria of 80, the same as יסוד, Yesod! Thus, this evidence seems to convey that this Exodus NEGA is a direct result of sexual abomination!

We Have To Look Closer Here At This Latter Hypothesis!

- III. This position of ours is engrossing to say the least. The law of first reference finds this word ‘Nega’ initially used in Genesis 12: 17 to describe the events that took

place when another Pharaoh took Abram's wife Sarai into his house. Unfortunately, tradition has clouded our perspective of this incident, which leads to a precedent setting, serious release of great plagues (nega) upon this first Pharaoh and Egypt because of Sarai, Abram's wife. Perhaps it will reveal more of why this particular word is used in **Ex. 11**?

Perchance, did the **Genesis 12** account find Pharaoh lying sexually with Sarai? Did I hear a collective gasp? Most dare not consider this! Yet, we want the truth right?

To form our answer, there are 2 other accounts (Witnesses?) of similar instances where a 'Sister/Wife' scenario occurs: **Gen. 20:1-18** another incident with Abram and Sarai, where we're told unequivocally that Abimelech did not have sex with Sarah and in **Gen. 26: 6-11** where we find Isaac - posing the same as Abram – as the 'brother' of Rebekah, who is also taken into Abimelech's house.

In these 2 latter cases, the text makes it plain that nothing happened. Though in both cases it is also made plain *before an incident*, that extra-marital sex would result in a serious plague – BUT SUCH WARNING IS NOT GIVEN IN GENESIS **12**? The plagues promised in the other 2-examples do not happen, yet in this first case they do! Why? YHVH is a fair judge. It seems highly likely that Sarai in fact, slept with Pharaoh!

Undoubtedly, as we examine this first account in **Genesis 12** it parallels the Exodus account rather remarkably! For instance, as with Moshe, Abram is called to stand before Pharaoh. Additionally, the theme of both is the "letting go" of Abram, Sarai and later, Israel – i.e. a 'Shalach' [H#7971](#), to send away, let loose and to be **divorced!** Is it possible that by taking Sarai into his harem that an Egyptian marriage ceremony occurred causing an adulterous situation? \*Remember the ancient Threshold Ceremony – carrying one across indicating marriage!

Another interesting connection to which the Sages somewhat allude, is that Sarai was also known as Ischah based on the interpretation of **Genesis 11:29**: *And Abram and Nahor took them wives: The name of Abram's wife was Sarai; and the name of Nahor's wife, Milcah, the daughter of Haran, the father of Milcah and the father of Ischah.*

- Ischah, [H#3252](#), **יִשְׁכָּה**, Yischa, translated as "One who looks forth" or Sees. To watch. However, the root stem is notable: Samech-Kaf-Hey gives us Sukkah. As a noun it indicates a covering or hiding place. Yet the Psalmist uses it's'

verbal form in **Ps. 139:13** *For thou hast possessed my reins: thou hast covered-*  
*H#5526, סַכַּךְ, sakak, me in my mother's womb.*

- Sakak in its' verbal form hints at the formation or weaving of a baby in the womb. As a young woman the prophetic name of Yischa hints that she could then 'SEE' – Prophecy of the Promised Seed to be formed in her womb. This seed was to be the Promised Seed or Firstborn much like Israel would later be the Firstborn of YHVH. Thus anointed, and armed with such foreknowledge, any compromise with Pharaoh would have resulted in a NEGA – Strike just as in **Genesis 3**!

This is also ostensibly confirmed when YHVH changes both Abram and Sarai's' names, adding the Hebrew letter "Hey – ה" which indicates breath, breathing, mouth, spirit and revelation. When you transliterate ה into English you have **הא** – an exclamatory word meaning 'See! Behold! Surely! To bring emphasis to something being declared! It seems YHVH is correcting the way Sarai 'SEES'! Name change equals status change!

#### Side Bar - The Shalach Connection:

- IV. It is worth noting here that the Parsha entitled V'Yishlach – And He Went Out – comes from the above root – shalach. It reminds us of the ancient archenemy of Israel: Amalek, a grandson of Esau. *This was the lineage that despised the Birthright. The Firstborn! Esau was cut off from inheritance, as was the firstborn of Egypt.* It was Amalek who first made war against Israel after the Exodus, preying on the weak and elderly at the back of the camp.

\*Note: During this battle Israel only wins if Moshe's hands are held up (Implying an acknowledged return to Torah during the coming Greater Exodus) by Aaron and Hur; The One Who carries/wombs the Light and the Burning One respectively, while Joshua – Yahshua fights the Battle!

The battle is fought at Rephidim, **H#7508**, and **רַפִּידִים**, is translated 'rests' or stays, but literally means balusters or stair supports. This was the location of Jacob's vision of the Stair or ladder – the DNA of Creation I believe. Rephidim comes from the root rapah, indicating to reinvigorate, to restore, bring to life and is associated with Giants or Nephylim!

We will see a battle over this same DNA and the attempt to replicate or restore the DNA of the Fallen Ones incorporated into weaponized vaccines and EMF as Amalek seeks to destroy the weak and elderly first!

Rephidim has a value of 344, the same as H# 5614, רפדס, sephard, and meaning exiled, separated, cast out. From this we get Sephardic, the root of which is Sepher – Book! People of the Book! This is the season when the Maqowm – The Place of Separation becomes more visible as the struggle over the Firstborn inheritance escalates!

As we continue, out of the Amalekite nation comes Agag, their King, a Giant whose name אגג, A- Gog, seems to mean ‘from the top’ or the apex. Ironically, this root is seen in Exodus 30:3 denoting the top – H#1406, אג, gag, of the Altar of Incense. Daniel speaks metaphorically of a male goat (ESAU?) (Gog and Magog) whose one horn become four horns towards the four winds of heaven, which, rather than 4-nations, seems to infer instead, a worldwide altar (Daniel 8:8) in the 3<sup>rd</sup> –Temple uniting the worlds’ religious Triad: Jews, Christians and Islam.

It should come as no surprise that Amalek now occupies the 2<sup>nd</sup>-highest office of the corporate UNITED STATES OF AMERICA at present and will probably soon occupy the 1<sup>st</sup>: Kamala = Amalek.

- V. Now, as we’ve discussed in our previous teachings on these plagues, the Fallen Angelic and/or Demonic Beings that they held to be ‘gods’ enthralled Pharaoh and the Egyptian nation. It is my opinion that Pharaoh and Egypt engaged in a seed transfer i.e. producing offspring from that unholy union!

In fact, the language of Genesis 6 and that of Genesis 12 bear striking similarities in their description of how the Nephylim and the Egyptians perceived the daughters of men and Sarai and Rebekah. Please note the following phrases consistent to both texts:

*And it was when – saw how lovely/beautiful – took – this latter word is H#3947, לקח, to seize, acquire, marry, take a wife, take possession of. Is it possible that a similar event is taking place with the intent to compromise the SEEDLINE promised through Abraham?*

\*Remember Sarah is approximately 25-30 years younger at this time than when Isaac is born and yet, her womb will be made barren all these years! Did YHVH

intervene to prevent a compromise? Barrenness was often seen as a curse related to adultery (Numb. 5: 11-31) though not in every instance.

Following this line of thought it helps put into perspective what has always troubled me and that's how Sarah convinced Abraham to take an *Egyptian* slave woman – Hagar – as his wife. Why would Sarah do so and later change her mind? The etymology of Hagar escapes most scholars. Yet, it seems the Hey attached to the Gimmel-Resh - **הגר**, is a preposition 'the' while the Gimmel-Resh derives from *gerar*, indicating to press into service, forcible servitude, to drag out or away.

There is a close cognate with the identical letters: **גרה**, *gerah*, meaning to inflame, to be angry. The verbal form means to strive or agitate strife, obviously not by means of one singular assault but rather by repeated provocations and withdrawals. Ironically, the gematria of Hagar is the same as that of Isaac – 208? Was this to be a counterfeit? Was this one act of many in the retribution of Sarah against Egypt and Abram perhaps? Was it merely coincidental that Abimelech who took Sarai captive after Pharaoh, was King of Gerar, as in the above paragraph?

To help me substantiate this further, it is patently evident that the 10<sup>th</sup>-plague – Death of the First Born – was the plan of YHVH from the moment He first spoke to Moshe in **Exodus 4**. Why? What had happened over the past 430-years to cause YHVH to take such drastic measures?

#### Another Side Bar:

Once more, let me call your attention to the central phrase of our text: `Od nega – specifically `Od – **ודע** whose value of 80 we connected to the word Yesod **יסוד**, indicating a foundation or base. This word was used to indicate the base of the Altar where the blood of sacrifices was poured.

Incidentally, the number 430 above also connects us back to this Altar foundation, because the 'animal soul' or Nephesh is associated with this Yesod. Is it possible that the future 3<sup>rd</sup>-Temple Altar will receive the compromised DNA – blood of Chimera or hybridized animals consistent with Gene manipulation intended to reintroduce the Nephylim and/or other monstrosities? Remember the Anti-Messiah will offer Pigs' flesh upon this foundation.

Throughout history a great paradox has existed regarding the prohibition of Swine's flesh. Even today it is routinely dismissed as having been made clean by

Jesus. However, the reality is that Torah expressly forbade its' consumption, yet early Christian records indicate that not only did they consume it, they offered it on their holy days; i.e. Easter Ham! Such conduct exposes a brazen effrontery that is both anti-Semitic and anti-Torah! Why is pig flesh or swine considered such an abomination and what does it have to do with out 10<sup>th</sup> Plague?

Here's where we touch something I've not seen before. Swine comes from H#2386, **חזיר**, khazeer, translated as swine, yet it's root indicates to enclose, to come back, to return, its' origin is seen also in words indicating sight, to forecast, prophecy, vision, etc. It is always linked to 'abomination' H#8262, **שקצ**, shawkats, to loathe, pollute, to be filthy and to be IMPURE and represents an ALTERNATE PRIESTHOOD founded by Rome/Esau!

Further, Chet-Zayin-Yod-Resh is cognate with Kaf-Zayin-Yod-Resh. Khazar, The plural form being Khazarim. It is often postulated that most Ashkenazi Jews are descended from this group. The name Ashkenazi derives from the Son of Gomer, the son of Japheth, in effect fulfilling **Genesis 9:27** *YHVH shall enlarge Japheth, and he shall dwell in the tents of Shem; and Canaan shall be his servant.*

Indeed, the Sons of Japheth – the Ashkenazi now dwell in the Shemitic tents!  
\*NOTE! One of Japheth's' sons is also MAGOG!

As we continue, the Shin-Qoph root is cognate with the Samech-Kaf root of Tabernacle/Sukkah. It is my opinion that Esau now masquerades as Jacob in an attempt to usurp the Birthright! The 10<sup>th</sup> plague dealt with those usurpers who thought to access the Firstborn birthright of Israel!

Like Egypt, the imposters of Esau/Rome will fulfill Nebuchadnezzar's' vision of the Iron mixed with Miry clay and attempt to occupy Firstborn status! By the way, Khazeer-Swine has a value of 225, the same as *h'nephylim*, and 'because of them' the phrase used to reference the earth being filled with violence explaining why YHVH would destroy the earth in **Gen. 6**. This is worth calling attention to. Because throughout Torah whenever YHVH killed men, women and children as this Firstborn plague would most assuredly do, it was always linked to the compromised SEEDLINE of the Fallen Ones!

In View of This:



Was the intent to judge this Pharaoh as He did the nemesis of Abram and Sarai? Did the Exodus Pharaoh comprise the Bride of YHVH – Israel – in a sexual manner and thus, merit the destruction of the seed of that union?

\*See **Ex. 4: 22-23**. *And thou shalt say unto Pharaoh, Thus saith YHVH, Israel is my son, even my firstborn: And I say unto thee, let my son go, that he may serve me: and if thou refuse to let him go, behold, I will slay thy son, even thy firstborn.*

Look at the Hebrew word for ‘slay’: **H#2026, הרה**, rendered hawrag, is translated here as slay or kill. It’s interesting to note the 2-letter root stem Hey-Resh, rendered ‘mountain’, mound and figuratively indicating a ‘rounded abdomen’ as in a pregnant woman. The Gimmel is the ‘lifted up’ letter, the by-product or 1<sup>st</sup>-born son of the union of Alef & Bet.

Its’ gematria – 208 – is the same as Isaac, the 1<sup>st</sup>-born of Abraham and Sarah and the Promised Seed! Again, did Egypt attempt to eradicate the House of Abraham-Isaac-Jacob by comingling their seed that seems clearly to have been abominably tainted with that of the Nephylim?

Further, the other 9-Plagues seemed as if they were supplemental additions to the ultimate 10<sup>th</sup> plague judgment upon Egypt – shown here as a specific strike upon Pharaoh, the representative of Egypt, as well as, the entire Nation of Egypt – in this 10<sup>th</sup> event. Why? Again, it seems a revisit of the earlier accounts of the use of the word nagah is needed.

First, by way of reminder, Abram was told: **Gen. 15: 13,14** *And He said unto Abram, Know of a surety that thy seed shall be a stranger in a land that is not theirs, and shall serve them: and they shall afflict them four hundred years; and also that nation, whom they shall serve, will I judge: and afterward shall they come out with great substance.*

YHVH is basically saying that He would separate the Sons of Abraham from the sons of Pharaoh-Egypt after a multi-generational scattering! In addition, those who have been scattered, seemingly outcasts, a Nation whose ancestral patrimony would be called into question by those Elitist who falsely claim blood rights, would become a Nation who, in the Last Days would be gathered from the 4-corners of the World for a Greater mass Exodus with one goal in mind – accessing the Promised Inheritance!

Their return to Torah coupled with an indefatigable will to keep the Sabbath and other Holy Convocations would become certifiable evidence attested to by the Manifestation of Supernatural demonstrations of majesty and power identifying them as the aboriginal pure stock – The Sons of Elohiym - and thus able to access their Inheritance as Firstborn! Absolutely, this sounds much like the Promise to gather the outcasts of Israel and bring them into the Promised – Debar [The place where words become seed] Land.

### Once More, Why Kill The Firstborn?

- VI. Scholars have wrestled with such for millennia. For instance, Israel was later told to go into the Promised Land a.k.a. ‘The Land of Canaan’ and kill all the men, women, children as well as, the cattle of the 7-Nations, an event that provokes people to call YHVH a harsh and brutal Deity. Yet, it is evident that He was cutting off the seedline of the Nephylim to prevent Israel from comingling their seed.

Is it possible that this 10<sup>th</sup> plague specifically targeted the hybridized seed – offspring of the Pharonic, Egyptian and Fallen Ones Union? Could this be why Moshe is called to certify, witness against them? To this end, even some of the Sages teach that the Egyptians had engaged in natural, physical adulterous affairs and as a result there were often several ‘firstborn’ in each house. Children from different fathers!

If what we’ve alleged is true, then there should have been ‘firstborn’ within the housed of Israel who merited this plague as well, perhaps, including such notables as Miriam, the Eldest sister of Moshe and Aaron. Again, the names suggest as much.

Kindly note: Miriam, [H#4813](#), מִרְיָם, Miryam, whose name even the translators render as ‘Rebellion’. If we break it apart we have Mar-rebellion or Mar - bitter and Yam – waters. This reminds us of the test of marital fidelity in [Numbers 5](#), where the wife accused of adultery is given the bitter waters of judgment to drink.

This ‘Cup of Jealousy’ was a concoction consisting of a ‘handwriting of ordinances’ – i.e. the accusation of law breaking – written upon parchment – skins and water comingled with the Ashes of the Red Heifer and dust of the Tabernacle floor which was poured over the parchment washing or blotting out the accusations

into a cup of ‘bitterness’ which she was made to drink. If guilty, her belly and thigh rots out, if not, she conceives seed!

A hidden clue is found in the primordial rite of ‘Threshold Covenanting’ an act demonstrated in the Pesach ritual of applying blood to the doorposts and lintels of each Israelite house. The ritual had its roots in ancient Near Eastern Marriage Covenant terminology.

At this time, YHVH took to Himself the Virgin of Israel as His Bride, in effect doing more than bypassing each house with blood while actually entering in to her. Much as Ezekiel speaks: **Ezek. 16: 8** *‘Now when I passed by you, and looked upon you, behold, thy time was the time of love; and I spread my skirt over you, and covered thy nakedness: Yes, I sware unto you, and entered into a covenant with you, saith YHVH, and you became mine!’*

In Israel’s case, though, there is controversy here regarding the specific Hebrew letter formed by the blood of the Passover Lamb applied to the lintels of the house, some saying Chet, some Tav, it is my opinion that it could have been in the form of the letter ‘Hey’ – ה – in effect, applying the same breath, breathing, spirit, and declaration of renewal as the letter ה added to Abram and Sarai! This changing of names demonstrated an exchanging of positions, a new status for the participants! Thus, the Paschal blood like the Ashes of the Red Heifer protected the Guilty Bride from death as the Lamb and the Red Heifer die in their stead!

Following the above pattern, as our Messiah Yahshua is scourged before His execution, it is my opinion that His SKIN – PARCHMENT representing the written Law-Torah - was comingled with His own blood and later, water, with the dust of the original ADAMAH, and poured out upon the Altar of the Earth-Adamah to eradicate the guilt of the Niddah Bride and to restore the truth of the Accusation of Adulterous Bride and bastard sons by testifying to the world with the inscription upon the stake: **Yahshua H**’notzri **V**’Meleck **H**’Yehudiyim! In effect giving us the 4-letter Tetragrammaton YHVH!

As we continue to look at the Firstborn Miriam, מרים, we see that her name is only one letter removed from Egypt – מצרים, the letter Tzade. It is said that Tzade represents righteousness and judgment. The Sages say it has two heads: Indicating choice. It also connotes the Tzadeq One – Messiah Yahshua who, like Israel went down into the Womb of Miryam – the belly of bitter waters – to rectify the choice

made in the garden to that of serving YHVH. The letter Tzade is connected to the Zodiacal sign of Aquarius, the Water Bearer! The One Who Drinks The Cup of Jealousy for us!

It is my contention that this 10<sup>th</sup> plague – death of the 1<sup>st</sup>-born – was a direct response to the attempt of Pharaoh and Egypt to compromise the seed of Israel and became the tool used to bring about their restoration as both Bride and Firstborn Son!

As we fast-forward to the coming Greater Exodus, I assert that the spirit of Pharaoh and Egypt, both evincing an Anti-Messiah typology, rests upon the Elite of the world and in particular, the powers-that-be who currently govern the enslaved of the UNITED STATES OF AMERIKA!
