Why	nonprofit?	
	Nonprofit business is separated from commerce because it deals with meeting important needs of society.	
	Commerce aims to generate financial profit for its owners and investors.	
	Nonprofits aim to generate service, relief and betterment of society.	
I.R.S	.'s view of nonprofits:	
	A nonprofit is an organized entity of business that generates no financial benefit to a person or persons.	
	A nonprofit satisfies the standards of serving society as a whole or a specified portion of society in life services and needs.	
When do you get a nonprofit going?		
	Immediately begin and operate the ministry of your calling.	
	You need to be doing what you are called to do before you organize a ministry and do business as a nonprofit.	
When	n do you absolutely need a 501-c-3?	
	When you have already been doing the ministry of your calling.	
	When you have anyone giving \$25,000.00 or more in one year with an expected tax deduction.	
	When you want to receive donations from government agencies, corporations, trusts, grants, etc.	
	When you want to receive donations of land or real property.	

What is a 501-c-3?
The IRS is ruled by and rules the citizens of the US by a code called the Internal Revenue Service's Code.
□ Religious nonprofits are diagramed in section 501 under paragraph c, section 3 of the IRS Code. This is how you find the basic rules and information about a nonprofit organization.

Acronyms for nonprofit organization:

I.R.S. – Internal Revenue Services
☐ The federal government agency that oversees the taxation of
individuals and business entities.
E.I.N. – Employer Identification Number
☐ Or sometimes referred to as Tax Identification Number. This is like a
social security number for a business entity.
SS4 Form is the form used to apply for an E.I.N.
☐ Each individual ministry must have its own EIN that distinguishes it. If
you do not have one of these, please go to irs.gov and complete the
online SS4 application. This will give you an EIN, and you can then
complete this form. This is a 9-digit number. No dashes, please.
