# STUDY GUIDE INSTRUCTIONS

## Instructions for “Discuss: Instruction/Application” questions in the study guide.

- 1** First, look up the ‘Instruction’ passage in the Law and briefly summarize it in one or two sentences. (The instruction passage is the part of the law that instructs Israel on how they were to act, believe, or live. Do not use commentaries. Instead, simply look up the verse and summarize its instruction to Israel.)
- 2** Next, look up the ‘Application’ passage (THE APPLICATION PASSAGE IS NOT YOUR APPLICATION. IT IS THE PASSAGE IN WHICH THE LAW MUST BE APPLIED OR UNDERSTOOD IN ORDER TO CORRECTLY BE INTERPRETED) and briefly summarize it in one or two sentences.
- 3** Finally, explain why/how the instruction passage relates to / impacts the interpretation of the ‘application’ passage. For example, “The Law instructs Israel not to do X. Israel is doing X. That is bad.”

**Instruction (Deut 19:15)** – Number of Eyewitnesses Required

**Application (Matt 18:16, 20)** – Requirement for the Future Church

## INSTRUCTION AND APPLICATION

### **Deuteronomy 19:15 in John 8:3-4**

**Instruction (Deut 19:15)** – Requirement of Eyewitnesses for Trial

**Application (John 8:3-4)** – Claims Regarding Adulthood

## INSTRUCTION AND APPLICATION

### **Deuteronomy 19:16-20 in John 8:7**

**Instruction (Deut 19:16-20) – Qualification for Eyewitnesses**

**Application (John 8:7) – Must be “without sin”**



## INSTRUCTION AND APPLICATION

### **Deuteronomy 20:1-9 in Luke 14:15-24**

**Instruction (Deut 20:1-9) – Laws of Soldiers for Battle**

**Application (Luke 14:15-24) – The Invitation of the Feast**



## DISCUSSION QUESTIONS

1. Now that you have worked through the first study guide question, Read 1 Kings 2:1-9. David's charge to Solomon addresses the situation with Joab.

**How does this passage help in your understanding of the narrative?**

**How does 1 Kings 2:1-9 help you evaluate David's rule?**

## DISCUSSION QUESTIONS

2. The requirement of two or three witnesses is not only an Old Testament requirement (i.e., Deut 19:15), but it is found in the instruction to the church (i.e., Matthew 18:15-20).

**However, should not the law of the malicious witness (Deut 19:16-20) is be considered when confronting another of sin?**

**How might this apply?**

## DISCUSSION QUESTIONS

3. In Luke 14:15-24, Jesus is responding to a statement recorded in verse 15. His response explains that not all invited into the kingdom (portrayed throughout the Old Testament prophets as a wedding feast) will attend. In like manner, Deuteronomy 20:1-9 records the response of one who is fearful that they will not get to enjoy their temporalities and therefore forgo their victory.

**How does such a focus on the temporal cause us to lose our focus on the eternal?**
