STUDY GUIDE INSTRUCTIONS

Instructions for "Discuss: Instruction/Application" questions in the study guide.

- First, look up the 'Instruction' passage in the Law and briefly summarize it in one or two sentences. (The instruction passage is the part of the law that instructs Israel on how they were to act, believe, or live. Do not use commentaries. Instead, simply look up the verse and summarize its instruction to Israel.)
- Next, look up the 'Application' passage (THE APPLICATION PASSAGE IS NOT YOUR APPLICATION. IT IS THE PASSAGE IN WHICH THE LAW MUST BE APPLIED OR UNDERSTOOD IN ORDER TO CORRECTLY BE INTERPRETED) and briefly summarize it in one or two sentences.
- Finally, explain why/how the instruction passage relates to / impacts the interpretation of the 'application' passage. For example, "The Law instructs Israel not to do X. Israel is doing X. That is bad."

Application (Matt 15:14; 19:19; Mark 7:10; 10:19; Luke 18:20; Eph 6:2-3; Col 3:20) – Jesus' Explanation of the Law



Deuteronomy 5:18, 6:5-6 in Matthew 5:20, 27-28

Instruction (Deut 5:18; 6:5-6) – The Performance of the Law

Application (Matt 5:20, 27-28) – Jesus' Explanation of the Law

DISCUSSION QUESTIONS

1. Watch the brief video introducing Judges 17-21. Now, read Judges 17:1-6 together.

In light of Deuteronomy 5:7-21 and Deuteronomy 23:21-23, what problems do you see?

How is the author of the Book of Judges informing the reader that the Levites (or priests) are failing to do what was "good and right in the eyes of the LORD?"

DISCUSSION QUESTIONS

2. Watch the brief video introducing the concept of "Honor your mother and father..."

Now, read Exodus 20:12, Deuteronomy 5:16; 27:6, Ephesians 6:1-4, and Colossians 3:16-25.

Why is Paul teaching the Ephesians and Colossians about the roles of family members in the body of Christ?

How ought this impact parents and their commitment to knowing and then teaching the Word to their children?

3. Watch the brief video introducing the Sermon on the Mount.

Now, read Matthew 5:17-48 in light of Deuteronomy 5 and Deuteronomy 6.

How was the "Law of Moses" supposed to relate to one's heart?

Now read Deuteronomy 30.
