- 1. Have you ever made a purchase only to regret it later? Have you ever indulged in the short term only to have to pay severely in the long term? Give us an example of when you really "paid" for something that you bought or ate on an impulse. Would you do it again? Why or why not?
- 2. With your Bible or Bible App, read Luke 19:1-10

Jesus entered Jericho and made his way through the town. There was a man there named Zacchaeus. He was the chief tax collector in the region, and he had become very rich. He tried to get a look at Jesus, but he was too short to see over the crowd. So he ran ahead and climbed a sycamore-fig tree beside the road, for Jesus was going to pass that way. When Jesus came by, he looked up at Zacchaeus and called him by name. "Zacchaeus!" he said. "Quick, come down! I must be a guest in your home today." Zacchaeus quickly climbed down and took Jesus to his house in great excitement and joy. But the people were displeased. "He has gone to be the guest of a notorious sinner," they grumbled.Meanwhile, Zacchaeus stood before the Lord and said, "I will give half my wealth to the poor, Lord, and if I have cheated people on their taxes, I will give them back four times as much!"Jesus responded, "Salvation has come to this home today, for this man has shown himself to be a true son of Abraham. For the Son of Man came to seek and save those who are lost."

When Jesus saw this,[d] he said, "How hard it is for the rich to enter the Kingdom of God! In fact, it is easier for a camel to go through the eye of a needle than for a rich person to enter the Kingdom of God!"Those who heard this said, "Then who in the world can be saved?"He replied, "What is impossible for people is possible with God."Peter said, "We've left our homes to follow you." "Yes," Jesus replied, "and I assure you that everyone who has given up house or wife or brothers or parents or children, for the sake of the Kingdom of God, 30 will be repaid many times over in this life, and will have eternal life in the world to come."

  - T Trust God
- 9. Which of these steps is the hardest for you to live out in your own life? The easiest? What's missing?
- 10. Where did Jesus find you? if you trust Jesus for salvation, what's stopping you from trusting Him to help you avoid and eventually get out of debt?
