Dear Friends and Partners,

A year ago, in February, Guy was diagnosed with Lewy Body Dementia with Parkinsonian symptoms. We had never heard of it until then and were told it was a very progressive disease. As his condition continued to deteriorate, we hoped that he would be well enough to travel to Washington, DC, in October for the Intercessors For America's 50th Anniversary Gala. Guy had been a part of this ministry for almost two decades, serving on the board and as the Executive Director for nine years. Guy had resigned from the Board in September of 2022 due to his health. Then I was asked to serve as a board member in November of 2022. The Board meeting this year, during the Gala, was the first meeting that I attended as a board member. Guy was well enough to travel to DC and to attend several of the sessions. The Gala was a tremendous success. The speakers were gifted and inspiring. God blessed us with His presence and granted us a joy and a love for each other that I had rarely experienced.

October 2nd was opening day of the current session of the Supreme Court. I went to Washington, DC, to be a part of a prayer event sponsored by Justice Action Group. We lined up at 7:00 am to be admitted to the Court. We prayed quietly during the hearing for such things as the Justices to make righteous decisions, to walk in the fear of the Lord, and to be blessed with safety and good health. We also prayed for anything that the Lord might put on our hearts for an individual Justice.

In mid-October, FIRE International held its annual missions conference at our local church. Guy was only able to attend a few of the sessions. The annual conferences are always a great time of sharing, reconnecting, and learning about the amazing things God is doing throughout the earth in our lifetime.

In January, I attended the March for Life in Washington, DC. My daughter, Debby, flew out from Seattle to go with me as Guy was not able to travel. There were about 5 inches of snow on the day of the March, yet many people came to participate

despite the cold and snow. We also attended a prayer and teaching event at Lou Engel's Justice House of Prayer and then went to the Supreme Court to pray.

Guy entered into home hospice care this January. He is pretty much bed-ridden now as he walks with great difficulty and loses his balance easily

Please keep us in your prayers. We can both use God's strength, patience, and comfort.
