[CBS Quietly Deletes Grammy Tweet Saying 'We Are Ready to Worship' Satanic Sam Smith Performance \(breitbart.com\)](#)

CBS has deleted its Grammy Awards tweet proclaiming “we are ready to worship” pop star Sam Smith’s Satan-themed performance after the post provoked widespread ridicule and accusations that the left-wing network engages in Satan worship.

On Sunday afternoon, Sam Smith tweeted rehearsal photos for what was eventually revealed to be a fire-and-brimstone-themed performance of his single “Unholy,” a collaboration with male-to-female transgender singer-songwriter Kim Petras.

“This is going to be SPECIAL,” Smith tweeted.

CBS replied: “...you can say that again. We are ready to worship!”

It remains unclear when CBS deleted the tweet but the post was gone by Monday.

As Breitbart News [reported](#), Sam Smith attempted to shock Grammy viewers with his Devil-inspired performance of “Unholy” during which he and his backup dancers donned form-fitting red outfits and cavorted among pyrotechnic effects and intense red lighting.

But instead of shock, the demonic sequence inspired widespread mockery over Smith’s strenuous efforts at transgression and his very noticeable weight gain.

Sunday’s live telecast turned out to be a [ratings fiasco](#) for CBS, drawing just 12.4 million viewers. While the number represents a slight improvement over the past two years, the Grammys are still way down compared to 2020 when it attracted 18.7 million viewers.

[Ramzan Kadyrov](#), a key ally of [Russian President Vladimir Putin](#), has begun rattling off threats about attacking [Poland after Ukraine](#).

Kadyrov, the head of Chechnya, suggested Monday that Russia should “[denazify and demilitarize](#)” Poland next.

“What if, after the successful completion of the NMD, Russia begins to denazify and demilitarize the next country? After all, after Ukraine, Poland is on the map! I will not hide that I personally have such an intention,” Kadyrov said on Telegram. “I personally have such an intention, and I have repeatedly stated that the fight against Satanism should continue throughout Europe and, first of all, on the territory of Poland.”

Kadyrov warned Tuesday that the time has come for the West to fall to its knees before Russia, predicting that the so-called “special military operation” in Ukraine, would be over by the end of 2023.

“The special [military] operation will be over before the end of this year. European countries will admit they have been wrong, the West will fall to its knees, and, as usual, European countries will have to cooperate with the Russian Federation in all spheres,” Kadyrov said, according to [TASS](#). “There should not and will never be an alternative to that.”

It isn't clear that the war will indeed be over by the end of the year. [Russia is preparing to mobilize between 300,000 to 500,000 troops](#) for a new offensive in Ukraine, according to a new Ukrainian military intelligence bulletin. [U.S. officials have warned](#) that Russia is likely gearing up for a new onslaught as well.

It's not the first time that Russia or Putin's cronies have suggested that Poland is on their list of targets in Europe. [Belarus, a close Russian ally, has threatened to go after Poland](#) with a “cruel” response over what the country said were “provocations” from Poland. Kadyrov himself threatened Poland on multiple occasions last year.

“After Ukraine, if we're given the command, in six seconds we'll show you what we're capable of,” [Kadyrov said](#) of potentially attacking Poland in May of last year.

Tensions have already bubbled up over the prospect of Russia attacking Poland. In November, [a stray missile fell into Polish territory near its border with Ukraine and killed two](#), raising questions about whether Russia had deliberately attacked Poland, a member of the North Atlantic Treaty Organization (NATO), and whether wider war was

about to break out. When one member of NATO is attacked, NATO can consider it an attack against all members.

[An investigation](#) into that incident revealed it was a Ukrainian air defense missile that had been fired to defend against a Russian attack. But if Russia follows through on threats to expand the war in Ukraine to include other territorial goals, including those in Poland, Moscow could end up ensnaring NATO members and touch off a wider war.

Polish authorities are concerned that Russia is still eyeing Poland. Marek Magierowski, the Polish ambassador to the U.S., warned just this week that Russia might set its sights on Poland next.

“Russia has always been our neighbor. It is our neighbor and it will remain so. It will not vanish miraculously in the foreseeable future. So we have to prepare,” Magierowski told [NPR](#). “We have to be prepared for any eventuality. Poland might be the next target.”

Warsaw is taking the threat seriously. On Tuesday, the Polish military is conducting [anti-aircraft drills](#) in an effort to demonstrate to would-be aggressors that Poland should be considered off-limits, according to Polish Defense Minister Mariusz Błaszczak.

“We all realize there is a war on our eastern border. But with these exercises, we will show—we will deliberately show—these exercises are to deter an aggressor,” Błaszczak said. “And so we demonstrate the combat readiness of the Polish military.”

Later this week, a group of soldiers from the 3rd Warsaw Air Defense Missile Brigade will leave for training in the United States as well, according to Błaszczak. The United States, in turn, leads the enhanced Forward Presence Battle Group in Poland and deploys a rotational Armored Brigade Combat Team there, with approximately 10,000 troops stationed in Poland.

In a recognition that Poland will be dealing with Russian aggression for some time, Poland has also taken steps to build up its military long-term. Polish Prime Minister Mateusz Morawieck announced just weeks ago that [Poland will increase defense spending](#) to 4 percent of gross domestic product. And due to the public’s anxiety about the conflict, [Poland has been training civilians as soldiers](#).

The search for survivors grew more desperate, the homeless problem more acute and the death toll rose to more than 16,000 Thursday as rescuers labored to find signs of life amid the rubble of Monday's [earthquakes and aftershocks](#) that laid waste to a wide swath of Turkey and Syria.

In addition to 12,873 people killed in Turkey, the country's disaster management agency said more than 60,000 have been injured. On the Syrian side of the border, 3,162 have been reported dead and more than 5,000 injured.

The total of 16,000-plus fatalities, the largest worldwide for an earthquake event in more than a decade, is expected to rise. Experts says the survival rate in an incident of this magnitude is below 25% after 72 hours, and the frigid temperatures make the chances even slimmer.

Dale Buckner, CEO of McLean, Virginia-based [Global Guardian](#), said his international security firm has clients in the region, and his team is helping with medical evacuations, transportation and the delivery of food, water and power supplies in and around the earthquake zone. It will take months to stabilize the region and years to recover from the disaster, he said.

"The size and scale of the destruction our team has witnessed is difficult to describe," Buckner told USA TODAY. "Some infrastructure will never be replaced. The damage is so widespread it will be uninhabitable for years to come."

That assessment stands in sharp contrast with Wednesday's vow by Turkish President Recep Tayyip Erdogan that homes in the 10 most affected provinces would be rebuilt within a year and that his government "will not leave any of our citizens uncared for."

Developments:

▶ Twitter CEO Elon Musk said he was told by Turkey's government that access to the platform would be restored soon after complaints it had been restricted. Some trapped survivors have used Twitter to communicate with rescuers and loved ones, while others have tweeted complaints about the response.

▶ A 13-year-old boy was rescued from the rubble on Wednesday, 55 hours after the quakes first struck, Turkish rescuers said. The boy was saved in Kahramanmaras, the quakes' epicenter, after three hours of intense digging.

▶ Turkish Airlines said it evacuated 19,050 people from the region Tuesday and planned to evacuate 30,000 more Wednesday. Airline official Yahya Ustun urged residents to "wait their turn ... calmly."

▶ More than 40,910 people had been injured in Turkey, according to the nation's Disaster and Emergency Management Authority.

▶ Opposition leader Kemal Kilicdaroglu blamed the devastation on Erdogan's two-decade rule, saying he had not prepared the country for a disaster and accusing him of misspending funds.

Snowfall in Syria compounds disaster

Fresh snowfall in Syria on Wednesday has compounded the disaster in the region, the United Nation's top humanitarian official in the country said.

"We have already a very vulnerable situation; people (are) already vulnerable, not capable of taking care of themselves...and all of a sudden comes this," said El-Mostafa Benlamlah, U.N. resident coordinator for Syria.

Benlamlah said in a video briefing Wednesday that 10.9 million people in Syria have been affected by the earthquake across five northwestern governorates.

About 100,000 people in Aleppo are believed to be homeless, Benlamlah added. But he stressed that while 30,000 have found shelter in schools and mosques, the remaining 70,000 "have snow, they have cold and they are living in a terrible situation."

Erdogan defends disaster response

Most of Turkey sits above major fault lines and the country is frequently shaken by earthquakes. Close to 18,000 were killed in similarly powerful earthquakes that hit northwest Turkey in 1999.

Erdogan on Wednesday inspected relief efforts in Kahramanmaraş province, where Monday's two powerful quakes and aftershocks were centered. Damage was spread over at least nine other provinces, affecting more than 13 million of his nation's 86 million people.

Erdogan toured a tent city and pledged that no one would "be left in the streets." He acknowledged the response had started slowly but dismissed criticism that the government needed to do more.

"It is not possible to be prepared for such a disaster," Erdogan said. "The state is working with municipalities, especially (disaster agencies) with all its means."

Finding occasional rays of hope

In the Turkish city of Adana, about 100 miles southwest of the epicenter in Kahramanmaraş, volunteer Bekir Bicer found a blue-and-yellow bird alive inside a crushed birdcage in the wreckage of a flattened 14-story building, almost 60 hours after the earthquakes hit.

"I was very happy," Bicer said. "I nearly cried."

Such rare instances provide hope for the loved ones of those still missing -- who are likely buried under the debris of some of the more than 5,600 buildings that have collapsed -- even though the chances of finding survivors are diminishing.

Suat Yarkan, 50, said his aunt and her two daughters lived in an apartment on the building's fourth floor. He was clinging to hope they could be rescued.

"Look at the bird. Sixty hours," he said. "It makes me feel like maybe God is helping us ... I have to believe that they will recover everyone."

White helmets mourn their own, seek funding help

The British government pledged more funding for Syria's White Helmets volunteer civil defense organization. The opposition-controlled White Helmets were organized in 2014 during the Syrian civil war to help with civilian evacuations and rescue operations after bombings in rebel areas. Now the group has been pressed into earthquake relief duty. At least four of its own members died in the quake, the group said Wednesday.

"We still hear the cries and moans of those trapped under the rubble asking for help, thousands of victims and thousands of missing people," the group said in [a Twitter post](#). "Please help in our response to save more lives by donating."

Winter cold adds to woes of those left homeless

The cold made life miserable for those who lost their homes. Many survivors have had to sleep in cars, outside, or in government shelters with temperatures dipping into the low 20s.

"We don't have a tent, we don't have a heating stove, we don't have anything. Our children are in bad shape. We are all getting wet under the rain and our kids are out in the cold," said Aysan Kurt, 27. "We did not die from hunger or the earthquake, but we will die freezing from the cold."

International teams join thousands of local first responders

Search teams from more than two dozen countries have joined tens of thousands of local emergency personnel, and [aid pledges have poured in](#) from around the world. Searchers from France, Spain and Russia were among foreign teams tweeting photos of their efforts on the ground. The U.S. sent two teams of about 80 persons each.

But the scale of destruction from the 7.8 magnitude quake and its powerful aftershocks was so immense – and spread so wide, including in areas isolated by Syria’s ongoing civil war – that millions are still waiting for help.

Adana restaurateur provides food, shelter

A kebab restaurant owner in southern Turkey’s Adana province opened three restaurants for survivors of the earthquakes. He told the Turkish news agency [Anadolu](#) he believed it was the safest place for people left homeless.

“It was raining,” Salih Oral said. “We saw people waiting in their cars, sitting on the pavement or just milling around without a place to go.”

Oral said he has been providing free food, soup and tea to people whose homes were damaged or destroyed. Oral said he also is sending food to nearby cities affected by the quakes.

Didem Incekuran, 24, has been staying at the restaurant since Monday, saying she was thankful to Oral.

“We don’t want to go back home yet. We feel safe here,” Incekuran said.

God created our faces in his image, but in 2020 the biomedical fascists sought to erase our faces and turn us into faceless AI bots. From rape victims being denied care for not wearing the dirty face diapers to crying children being dragged off planes and teens being handcuffed in school, the masking regime was perhaps the most barbaric, inhumane, and illogical idea ever conceived by government and permeating the so-called private sector. There is no time like the present to bury this evil forever.

We knew, and Fauci knew from day one, [based on 10 randomized controlled trials](#) of the flu, that masks never worked. Yet three years later, the information concerning the harms and ineffectiveness is so solid, it's time for every state legislature to ban permanently any mandate, anywhere, forever, with the threat of criminal penalties, so that this never happens again. Sadly, only a few states have meaningful protections in place even for schoolchildren. It is disgusting how long this was going on in schools in deep red states, and to this day, people are still being forced to wear them in hospitals in all states. Florida intends to ban it when the legislative session begins.

[A new randomized controlled trial](#) with a sample size of 40,000 children wearing masks in community settings in Guinea-Bissau showed that the control group actually did slightly better (not statistically significant) than the mask group. We already knew that masks do not stop spread, but some posited a bizarre theory that they could reduce viral load and therefore help with critical illness. Instead, the study results showed eight hospitalizations with COVID-like illness in the mask group, compared to three in the control, and 57 all-cause deaths in the mask group compared to 32 in the control. The study did not differentiate the causes of death, but clearly there was no benefit.

The study was conducted between July 2020 and January 2021. This was before any vaccination, so questions of vaccine efficacy or negative efficacy playing a role in confounding the study of mask efficacy were not applicable. The results were posted in the prestigious Lancet.

This study was published around the same time that [a new, rigorous Cochrane analysis](#) of 11 RCTs and a total of 78 studies with 600,000 people concluded, "Wearing masks in the community probably makes little or no difference to the outcome of influenza-like illness (ILI)/COVID-19 like illness compared to not wearing masks." The authors also found there is no evidence of efficacy of mask-wearing against contracting the flu or COVID.

Furthermore, as we've long known, N95s don't make a difference either. "The use of a N95/P2 respirators compared to medical/surgical masks probably makes little or no difference for the objective and more precise outcome of laboratory-confirmed influenza infection." This was the conclusion of an 8,000-person-sample study of N95 masking both in health care and community settings. Checkmate. As lead author Tom Jefferson later said in an [interview](#), "There is just no evidence that they (masks) make any difference. Full stop. My job, our job as a review team, was to look at the evidence; we have done that."

So here we are coming full-circle to what U.S. government officials [knew in March 2020](#), but lied their way into controlling people and instilling perpetual fear. How can we just walk away from this as if it never happened? How can we unsee the things we saw and experienced by just being happy that we currently don't have to wear masks, without an effort to permanently ban mandates? Just think about the damage to [children's speech, development, and emotions](#). How can we not push for permanent bans on this barbaric practice? Moreover, in states like West Virginia, health care workers like Amber Robinson [are still being fired for not wearing one of these all day](#).

It's bad enough that these things are forced upon us even though the government knew for years they don't work against respiratory viruses. But what are the harms of wearing a moist cloth for hours on end in school? Last year, a [preprint Italian study](#) found that even short-term surgical mask usage was associated with an increased inhaled CO₂ level greater than 500ppm in 90% of 10- to 18-year-olds in the sample. "Shortly after wearing surgical masks, the inhaled air CO₂ approached the highest acceptable exposure threshold recommended for workers, while concerningly high concentrations were recorded in virtually all individuals when wearing FFP2 masks," concluded the authors. "The CO₂ concentration was significantly higher among minors and the subjects with high respiratory rate."

Not to mention the fact that numerous [studies](#) have found masks to be bacteria traps, especially for young children.

It's time for public policy to catch up with the science and morality. It's appalling how, so far, [only 11](#) states have attempted to ban mask mandates in schools (some are tied up in court), and only Florida is attempting to ban them in hospitals and all private settings permanently. Kansas, Nebraska, South Dakota, North Dakota, Montana, Idaho, Wyoming, Kentucky, Indiana, Ohio, Missouri, Alabama, Mississippi, New Hampshire, and West Virginia are all states where Republicans currently have the political power to ban mask mandates, but three years into this saga have still failed to do so.

Every Republican-controlled legislature must permanently ban all mask mandates in public and private settings, and there must be criminal penalties for those who forcibly mask children. It would also be worthwhile to place human breathing as a right in the state's constitutions so that the people can vote on this at the ballot box.

In truth, even if masks did work, the fact that someone else is not wearing one should not negate your decision. That should be his problem. It is never OK to force another human being to take a medical action on or to his body to accommodate another person. But in this case, they don't even work. At some point, facts have to matter and policies need to be adjusted with as much energy behind the truth as the frantic and vicious coercion behind the lies in 2020.

No red state can leave this year's legislative session without permanently prohibiting the coercion of a human being to cover his or her breathing holes in any setting beyond a limited occupational hazard, such as various forms of construction or operating rooms. Full stop. Additionally, Congress must permanently ban the federal government from recommending or imposing a mandate in the future, such as the airplane fiasco.

In 2020, it was established that under the guise of public health, there is quite literally nothing government cannot do to our life, liberty, and property. Everything, including our noses, is fair game. Power to government, once ceded, is never given back on its own. It's time for us to rip that power back, beginning with control of our own breathing.

Move has been criticised by conservatives, who have warned that ‘male and female imagery is not interchangeable’

For decades, the gender of God has [prompted debate within the Church](#), with many calling for male pronouns He and Him, as well as reference to Our Father, to be scrapped in favour of either gender neutral or female alternatives.

Now, in what would mark a departure from centuries of tradition, bishops are to launch a project “on gendered language” [referencing God](#) in church services later this year.

The move has been criticised by conservatives, who have warned that “male and female imagery is not interchangeable”. However, liberal Christians have welcomed it, claiming that “a theological misreading of God as exclusively male is a driver of much continuing discrimination and sexism against women”.

Details of the plans emerged in a written question to the Liturgical Commission, which prepares and promotes forms of service and religious worship in the Church, at General Synod, the Church’s lawmaking body, which is sitting this week.

Any permanent changes or rewriting of scriptures with gendered language would have to be agreed by a future meeting of Synod.

‘Develop more inclusive language’

The Rev Joanna Stobart, from the Diocese of Bath and Wells, asked what steps were being taken to offer congregants alternatives to referring to God with male pronouns and if there was any update “to develop more inclusive language in our authorised liturgy”.

She also asked bishops “to provide more options for those who wish to use authorised liturgy and speak of God in a non-gendered way, particularly in authorised absolutions where many of the prayers offered for use refer to God using male pronouns”.

In response, the Bishop of Lichfield, the Rt Rev Michael Ipgrave, replying as vice-chairman of the Liturgical Commission, said: “We have been exploring the use of gendered language in relation to God for several years, in collaboration with the Faith and Order Commission.

“After some dialogue between the two commissions in this area, a new joint project on gendered language will begin this spring.”

The precise details of the project remain unknown, with Dr Ipgrave declining to comment further.

Prof Helen King, the vice-chairman of the Synod's gender and sexuality group, said: "Questions around gendered language and God have been around for decades, if not centuries, but still have the power to bring out strong reactions.

"For some, God as father is helpful because of their own positive experiences of a loving parent. For others, God as father may reinforce a bad experience of a strict disciplinarian as their father. If we dig deeper, clearly God is not gendered, so why do we restrict our language for God in gendered ways?"

A spokesman for Women and the Church, a national campaign group for gender equality in the Church of England, also welcomed the move "to look at the development of more inclusive language in our authorised liturgy".

'God is not sexed, unlike humanity'

However, the Rev Ian Paul, a member of the General Synod and the Archbishops' Council of the Church of England, warned against any departure from the original scriptures, saying: "The use of male pronouns for God should not be understood as implying that God is male – which is a heresy. God is not sexed, unlike humanity.

"The Bible uses feminine imagery and metaphors of God, but primarily identifies God using masculine pronouns, names, and imagery. Male and female imagery is not interchangeable.

"The fact that God is called 'Father' can't be substituted by 'Mother' without changing meaning, nor can it be gender-neutralised to 'Parent' without loss of meaning. Fathers and mothers are not interchangeable but relate to their offspring in different ways.

"If the Liturgical Commission seeks to change this, then in an important way they will be moving the doctrine of the Church away from being grounded in the Scriptures."

A spokesman for the Church of England said: "This is nothing new. Christians have recognised since ancient times that God is neither male nor female, yet the variety of ways of addressing and describing God found in scripture has not always been reflected in our worship.

"There has been greater interest in exploring new language since the introduction of our current forms of service in contemporary language more than 20 years ago.

"As part of its regular programme of work for the next five years, the Liturgical Commission has asked the Faith and Order Commission to work with it on looking at these questions. There are absolutely no plans to abolish or substantially revise currently authorised liturgies, and no such changes could be made without extensive legislation."

The news comes [amid tensions](#) within the Church of England as the Synod prepares for a historic vote on blessings for same-sex couples later this week.

Eagles QB Jalen Hurts, Super Bowl Bound, Says John 13:7 Inspired Him: It's 'My Favorite Verse' - Michael Foust (christianheadlines.com)

The quarterback who guided the Philadelphia Eagles to an NFC title and an appearance in the Super Bowl says he has been inspired by a Bible verse that includes the words of Jesus.

Jalen Hurts passed for 121 yards and rushed for 39 yards and one touchdown Sunday in Philadelphia's 31-7 victory over San Francisco in the NFC Championship, advancing the Eagles to Super Bowl 57 against the Kansas City Chiefs. It will be played on Feb. 12.

Hurts, who began his college career at Alabama before transferring to Oklahoma, quoted Scripture in a postgame news conference.

"I went through a lot of stuff in college and it kind of stuck with me – [John 13:7](#). 'You may not know now, but later you will understand.'"

Hurts called it "my favorite verse."

It wasn't the first time Hurts has quoted the passage. In his final season at Alabama, [he posted it on Twitter, writing](#), "Jesus replied, 'You do not realize now what I am doing, but later you will understand' – [John 13:7](#). Just let God work his magic."

Hurts' story is legendary in college football. He led Alabama to the College Football Playoffs during his freshman (2016) and sophomore (2017) seasons before getting benched in 2018 in favor of rising star Tua Tagovailoa. Hurts, though, never griped. He came off the bench in the SEC Championship in 2018 to lead Alabama to another conference title. He then transferred to Oklahoma, where he guided the Sooners to a Big 12 championship in 2019 and an appearance in the College Football Playoff. The Eagles drafted him in the second round.

He often discusses his Christian faith on social media. In September, he posted a photo of himself on [Instagram](#) in an Eagles uniform, kneeling in prayer. Hurts wrote, "He Who Kneels Before God, Can Stand Before Any Man."

Hurts' Instagram bio reads, "In God I Trust."

"God is everything, and He's worthy of praise," [Hurts told CBS Sports](#) earlier this year. "You have to put Him in the center of everything that you do. And that's what I believe. ... I've been blessed to grow, learn things, and just mature. And I know God has been there the whole entire way."

- The new Berlin startup has already preserved the bodies of about 10 deceased humans.
- Liquid nitrogen is the main ingredient used to ensure cryopreservation.

The waiting list for [Tomorrow Biostasis](#), a cryopreservation startup based in Germany, is in the hundreds. And the company already has about 10 bodies preserved in a lab. What comes next is the real issue.

According to a [report from Tech.Eu](#), the company's "standby ambulance" has already been busy, with cofounder Emil Kendziorra working to launch Europe's first cryogenics company (there are already a handful of them in the United States). Kendziorra's goal: As soon as somebody dies, Tomorrow Biostasis immediately responds to preserve the person's body and/or brain in a state of stasis. Then, once future advances materialize, the company will treat and reverse the person's original cause of death and bring them back from the dead to enjoy a life extension.

That's the plan, anyway.

Kendziorra says his company has "about 10 people" already cryopreserved for training purposes and hundreds more on the waiting list. The company's typical clientele are 36 years old on average and tend to work in tech, which is perhaps the least surprising development of all. Many of these people just want their brain preserved, thinking their future selves may prefer a new 3D-printed body ... or maybe not even a body at all.

When the bodies get transported to Rafz, Switzerland for long-term storage at the European Biostasis Foundation—the process is technically considered a scientific body donation, to make it legal—they get cooled to -196 degrees Celsius and placed inside an insulated tank with liquid nitrogen to lock in the preservation.

Of course, waiting for medical advancement to progress to the point it can reverse what caused your death isn't the only hurdle in this entire cryopreservation concept. There's still the small issue of nobody knowing how to actually revive a dead cryopreserved human. Sure, they can freeze the brain to preserve cells and tissues, but bringing a previously dead brain back to life with regular function and memories isn't quite a thing in our world—yet.

And those are just the big questions. There are also plenty of smaller issues, such as who makes the decision on the revival, because, well, you can't freeze up on the right timing.
