4. Discrimination is NOT what God is about!

--The Father is completely impartial

--Jesus is completely impartial

--The Holy Spirit is impartial

5. Discrimination is.....sin!

--There is no "justified" discrimination in the church

--Discrimination is not a "lesser sin"

¹⁰ For the person who keeps all of the laws except one is as guilty as a person who has broken all of God's laws. ¹¹ For the same God who said, "You must not commit adultery," also said, "You must not murder."^e So if you murder someone but do not commit adultery, you have still broken the law.

--We will be held accountable for the way we treat people
