FEAST = CORPORATE VS TABERNACLE = INDIVIDUAL

VS 10-16] WHY INSERTED HERE? MAYBE THE TIMING

“WHAT DID HE SAY” [11] NOT SURE BUT WE KNOW WHAT HE DID AND HIS
BACKGROUND [ISRAELITE / EGYPTIAN]

HE DID 2 THINGS BLASPHEMY AND CURSING

1] BLASPHEMY *nāqab* = TO VIOLENTLY PUNCTURE

BLASPHEMED “THE NAME” HA-SHEM VS 11, 16

******* BLASPHEME IS TAKING YAHWEH’ NAME IN VAIN AND MISREPRESENTING
HIM BY TRYING TO USURP HIS POWER

2] CURSED VS 11, 14, 15, 23

CURSING SOMEONE WAS A GRAVE SIN

CURSING A DEAF MAN LEV. 19:14

CURSING AN ELDER EX. 22:27

PARENTS EX. 21:17 [CAPITAL OFFENSE]

BUT TO CURSE SOMEONE BY INVOKING THE NAME OF YAHWEH IT WAS A
CAPITAL OFFENSE WHY? “THE NAME” VS 15 “BY HIS ELOHIM”

A NAME OF A PERSON WAS BOUND UP INTIMATELY WITH HIS CHARACTER, SO
THAT IN THE CASE OF GOD, BLASPHEMY WAS IN EFFECT AN ACT OF DENYING
WHO YAHWEH IS BY USURPING HIS POWER. AND IN EFFECT MAKES YAHWEH
OUT TO BE SOMEONE HE IS NOT.

[VS 15 “BY” HIS ELOHIM]

VS 10-11] 2 THINGS

1] PHYSICAL FIGHTING

2] ONE PERSON WAS OF MIXED PEDIGREE

THE BIBLE IS MAKING A POINT HERE AND IT’S NOT A RACIAL ONE IT’S A
SPIRITUAL ONE.....THE EGYPTIANS WOULD CURSE OTHERS BY THEIR
DIFFERENT GODS 1 SAM 17:43-45

THE POINT IS THE SPIRITUAL HABITS OF THE WORLD SHOULD NEVER BE
MIXED WITH THE HOLINESS OF YAHWEH

VS 12] MOSES HAD THE WISDOM TO HEAR FROM YAHWEH ON HOW TO PROCEED WITH THIS CASE WHY?

IF MOSES MADE THIS DECISION ON HIS OWN UNDERSTANDING, HE WOULD BE COMMITTING BLASPHEMY....THIS IS CALLED WISDOM

[JESS AND HELL]

VS 13-16] THIS IS YAHWEH' JUDGMENT NOT MOSES

***** HOWEVER OR WHATEVER THE GUY SAID HAD TO BE SO EXTREME FOR YAHWEH TO BRING THIS JUDGMENT BECAUSE HE ALWAYS SHOWS MERCY BEFORE JUDGMENT**

**[VS 14] OUTSIDE THE CAMP = HOLINESS
ALL THOSE WHO HEARD**

**VS 17-21] WHY INSERTED HERE? RELATED TO LEGAL PROCESSING OF DEALING JUSTLY
JUST BECAUSE GOD DELT THIS WAY WITH THIS MAN...IT DOESN'T MEAN ALL CASE ARE THE SAME **EXPLAIN PROCESS**
AN ANIMAL'S LIFE IS OF VALUE BUT NOT EQUAL TO A HUMAN'S LIFE
EYE FOR AND EYE.... = THE ANIMAL HAS TO BE REPLACED, THE COMPENSATION MUST EQUAL TO THE INJURER INFLICTED
MAT 5:38-42**

YESHUA TEACHING TO US IS GO BEYOND WHAT IS REQUIRED BY THE LAW.....WHAT IS THIS CALLED? [FLY IN] MERCY & GRACE

VS 22] THIS IS A CLUSE WITHIN THE TORAH TO REMOVE ANY PREJUDICE AGAINST ANY NON-ISRAELITE **LEV 19:33-37**

VS 23] THIS WASN'T A HAPPY DAY

EZE 33:11
