Brothers and Sisters in Christ,

Thank you for turning out in large numbers for the Voters Assembly on Sunday, August 4. For those not able to attend, it's important that I provide a recap of the meeting so that all in the congregation are informed. Three action items were taken up by the voters:

1. Authorization for the Board of Directors to spend insurance proceeds to begin repairs at the Temple campus. Included in this motion was authorization to use ILM cash on hand to pay the insurance deductible. Motion passed unanimously.

2. Authorization for the Board of Directors to spend insurance proceeds to begin repairs at the Belton campus. Included in this motion was authorization to use ILM cash on hand to pay the insurance deductible. Motion passed unanimously.

3. Resolution Regarding Facilities Evaluation and Planning. For brevity, I'm not providing the complete text of the resolution here, but in summary, the resolution states that ILM will engage a 90-day evaluation of ILM facilities to ensure the ministry has considered all options for how best to grow the Kingdom. Out of 124 votes cast, 90% voted in favor of the resolution.

Work has already begun on developing the process by which the facilities evaluation will take place as well as how to be sure as many as want to be involved in the process are able to do so. While I said in the meeting that we would need to limit the number of participants on the Facilities Evaluation and Planning Team, I have since revised my thinking. We should involve as many members as possible in this process.

I am thankful for the many members who have already volunteered to serve on the team. I encourage you as well. It is important that you let me know you want to participate so that I can be sure we are properly prepared to accommodate everyone for the meetings.
