- 5. How is reconciliation between believers a good witness?
- 6. What are some modern examples that would be our equivalent to the questions concerning "diet" and "days" (Romans 14:1–7)?
- 7. According to Romans 14:7–8, what is the guiding principle in navigating these issues? How can these issues cause stumbling?
- 8. What faith practices are you willing to forego for the sake of a brother or sister in Christ?
- 9. What is the reason we should not judge or look down on our fellow believers?
- 10. From these verses, share several responsibilities Christians have toward fellow believers.
- 11. How would you summarize Romans 14:1–15:7 in a single sentence?
