Pastor's Report - 2022

At the risk of stating the obvious, the past three years have been challenging in so very many ways. But you know what? They are behind us and it is time to write new chapters in the life and times of Spirit of Hope! We've spent the last three years in survival mode and we did survive. Not always in the way we necessarily wanted to but we're still here, Bringing Christ's Love to Life. And thus, it is now it is time to move forward.

It is true we are in a difficult financial situation. This past year has been the worst year in Spirit of Hope history as far as financial results go. Like most households, we had higher expenses with lower income which in combination with a tough stock market, left us with a \$75,000 deficit for the year. These are not results that anyone wanted nor is anyone happy about it. Clearly, this is not sustainable.

While that is beyond disappointing, there are some good points to highlight and there is always hope for the future. We're still here making a difference in our community and our cash position remains strong thanks to the sale of the Prince of Peace property. We can't rely on our cash reserve for the long term but it gives us some breathing room as we answer the question, "Who Will We Be in 2023?"

"Who Will We Be in 2023" is an idea that your leadership came up with as a way to look at ways we will celebrate God's work in our community, ways we can strengthen our faith together as the body of Christ, and ways to move forward into the coming year.

With those goals in mind we created the intention cards that we then gathered as an act of offering in our worship. The participation level returning the intention cards was high and we have a tremendous foundation to continue our work as Spirit of Hope Lutheran Church. Nearly every intention card wished to be intentional about generosity and nearly every intention card highlighted a desire to strengthen their faith through intentional prayer, Bible study, and worship. This forms a great foundation to work from!

With those intentions in mind we will continue building on the many successes that God led us to in 2022. And make no mistake, there were many successes and it was God who was guiding us. Having a bunch of campers at Camp Carol Joy Holling was a big success. Continuing to feed 100+ people every other month at Matt Talbot Kitchen & Outreach was a big success. Providing weekly worship and monthly drum circle for the memory care and assisted living residents at Fallbrook Assisted Living Center was a big success. Delivering weekly meals through meals on wheels. Sending nearly 100 quilts to places locally and across the globe. Having two worship services on Sunday and mid-week worship services during Advent and Lent. Hosting a blood drive. The list goes on but you get the idea. We're still "Bringing Christ's Love to Life" in many ways! We'll continue to do these outreach activities while we continue to listen for the Holy Spirit to work and guide us toward new opportunities.

We'll also continue to look at ways to be intentional about our prayer time, worship gatherings, Bible study and reading, generosity, and the ways we serve on ministry teams. Stay in touch through ministry opportunities, the eNews, and social media posts for the details on these areas that we'll be growing in during the coming year. Life as the Body of Christ is rarely easy but it does make a difference in people's lives as we Bring Christ's Love to Life!
