The Oscar Worthy Arrests of "The Squad" and the Durham Report Update



In their overzealous support of killing babies, New York Rep. Alexandria Ocasio-Cortez, Ilhan Omar, and other prominent members known as "the squad" were arrested during a pro-abortion overturning of Roe V. Wade protest Tuesday outside the Supreme Court. According to the <u>Epoch Times</u>, Omar tweeted this in response to her arrest, "Today I was arrested while participating in a civil disobedience action with my fellow Members of Congress outside the Supreme Court.
