# In the News (Topic 1 of 6) JOE BIDEN TO VISIT EAST PALESTINE

#### **Key Talking Points:**

- Joe Biden is set to visit East Palestine, Ohio a year after the disaster occurred.
- The gateway pundit reports the reason for the visit is because it's an election year.
- If you remember, a train derailed in February of 2022 in a small town in midwestern Ohio, with train cars dumping vinyl chloride in the town, a cancer-causing substance that also caused a chemical explosion that formed a gigantic toxic cloud over the town.
- Donald trump visited the town and brought supplies to help residents shortly after the disaster occurred, telling the townspeople they were not alone or forgotten.
- One Ohio business owner said about the upcoming Biden visit, "The leader of our country did not show up to the greatest catastrophe of 2023. And now, he's going to show up because it's an election year... the polls show president trump came and supported us when he didn't have to."
- To add to this point, according to Breitbart, the East Palestine mayor just endorsed Donald trump for president.
- Even two years after the explosion, one resident told real America's voice that they have received nothing from the federal government and have been referred to Norfolk southern, the train company, for compensation for damages.
- The town still suffers from contaminated conditions, including in their water.
- Biden is set to visit east Palestine sometime in February. It will be interesting to see how he is received.

- In other Biden news, Tara Reade, who claims to be a sexual abuse victim of the president, just filed a tort claim against the FBI for stalking her during operation Cassandra.
- The gateway pundit reports that per dr. Jonathan levy, reads attorney, that Reade filed a tort
  complaint with the U.S. department of justice seeking 10 million in damages for invasion of privacy,
  emotional distress, and violation of state and federal constitutional rights.
- This stems from a 1993 then senator Joe Biden's alleged sexual assault on Reade in which her case was suppressed by congressional investigators to protect senator Biden and the records of this investigation remain sealed.

- When Reade spoke out in 2019, she was immediately subjected to an ongoing FBI operation to revictimize her a second time. The FBI operation "Cassandra" was opened in order per her attorney to retaliate, intimidate, discredit and if possible, eliminate Reade as a threat to President Biden.
- Dr. Levy stated, "the United States should not have a two tiered justice system, if president trump and Mr. Giuliani can be assessed tens of millions in damages for their words; a weaponized FBI that seeks to silence, intimidate, and eliminate Joe Biden's victim, Tara Reade, must also be held accountable; failing to do so means our justice and legal system has become an instrument of political oppression and suppression."

#### **Key Talking Points:**

- Speaking of a two-tiered system of justice, this clip here is of pro-life activists who peacefully protested outside an abortion clinic. Their crime? Praying and singing hymns outside of a Nashville abortion center. They will now face up to 11 years in prison.
- Per the gateway pundit, Chester Gallagher, 73 and Paul Vaughn 55 of Tennessee, Heather Idoni, 58, Calvin Zastow 57 and Caroline Davis, 24 all of Michigan, Coleman Boyd, 51 of Mississippi, and Dennis green 56 of Virginia—were arrested in October of 2022 after the pro-life activists staged a peaceful protest at an abortion clinic.
- One of the activists, Paul Vaugn, was later arrested in front of his family including his children at
  gunpoint as if he was a violent criminal. The agents also failed to give their names when requested by
  Vaughn's wife who later posted footage of the arrest.
- Retired FBI agent Steve gray commented on the raid and stated, "This force used by the FBI to effect
  this arrest is unacceptable and unnecessary. I've been on numerous gang and organized crime arrests
  within the NY FBI. We never brought or displayed rifles to make those arrests. The agents should have
  given their names when requested."
- On Tuesday six of the abortion activists were convicted on federal felonies and are facing 11 years in prison. As the gateway pundit points out, these senior citizens could die in Joe Biden's prison for praying outside an abortion clinic. Their sentencings are scheduled for July 2nd per the U.S. attorney's office.

- In another case of Christian persecution, the military veteran who tore down the satanic idol in the lowa state capitol has now been charged with a felony hate crime.
- The western journal reports Michael Cassidy was charged after beheading the satanic statue on December 14th of 2023 after it was placed in the Iowa capitol before Christmas. He discarded the head in a nearby trash can and then turned himself into the capitol security.
- The Polk County prosecutors are now charging Cassidy with a hate crime that they say violates the civil rights of the satanists because he made statements to the public and law enforcement that he destroyed the property because of his Christian religion.
- Cassidy told the sentinel, "I saw this blasphemous statue and was outraged. My conscience is held captive to the Word of God, not to bureaucratic decree. And so, I acted."
- Cassidy became a navy pilot after the September 11th attacks and ran for the Mississippi house seat last year but lost to his democratic opponent.
- Iowa republican gov. Kim Reynolds has faced pressure to pardon Cassidy but has not yet responded to the requests.
- A give send go campaign was organized for Cassidy's legal fees and around 90,000 had been raised by the public to cover his expenses. One anonymous donor stated, "stay strong, may God bless you for your action against evil.
- Cassidy will be interviewed on a take five episode soon so be sure to keep a lookout for that.

- In world news, Biden is considering the ultimate betrayal of Israel.
- The western journal reports according to a report in Axios, Biden's state department is currently reviewing possible options to recognize Palestine as a sovereign state.
- Apparently, secretary of state tony Blinken has "asked the state department to conduct a review and present policy options on possible U.S. and international recognition of a Palestinian state after the war in Gaza."
- As Axios put it, "even considering such options signals a shift in thinking within the Biden administration on possible Palestinian statehood recognition, which is highly sensitive both internationally and domestically."
- British prime minister David Cameron said on Monday that recognition for Palestine is under consideration in the U.K. as well.

- Meanwhile, Israeli Prime Minister Benjamin Netanyahu is stridently opposed to any recognition of a Palestinian state either by individual countries or in the U.N.
- Upon the release of the Axios report, Jason d. Greenblatt, who served as an adviser to former president Donald Trump, publicized it on the social media platform x with the comment that this "would be a huge mistake, a betrayal of Israel & make things much more complicated to achieve something real down the road that could benefit everyone... it will make an intransigent Palestinian leadership in Ramallah even more so, and embolden Hamas & other terrorists to continue their bloody rampage."
- As the western journal points out it's only been a few months since Hamas' despicable attacks. Which included rape crimes and the murder of men women and children—even infants.
- Rewarding the group now would send exactly the wrong message, and it's beyond absurd.

- Gina Carano stated, "Today is an important day for me—I am filing a lawsuit against [Lucasfilm and Disney]. The truth is I was being hunted down from everything I posted to every post I liked because I was not in line with the acceptable narrative of the time. My words were consistently twisted to demonize & dehumanize me as an alt right wing extremist. It was a bullying smear campaign aimed at silencing, destroying & making an example out of me."
