Key Talking Points:

- In medical news, Florida state surgeon general Joseph Ladapo calls for a complete halt in the use of covid 19 mRNA vaccines.
- Per the gateway pundit Ladapo sent a letter to FDA commissioner Califf and CDC director Mandy Cohen pressing for greater transparency about the potential for DNA integration into the human genome—a concern that could have far-reaching implications.
- In his letter he noted the following concerns:
 - Questions regarding the safety of Pfizer and Moderna vaccines due to nucleic acid contaminants and billions of DNA fragments per dose with their associated potential risks.
 - Concerns with lipid nanoparticle efficiency in delivering contaminant DNA and the potential risk of simian virus 40 (sv40) DNA integration into human cells.
 - Concerns regarding the FDA's lack of evidence of DNA integration assessments.
- In September, Ladapo issued a warning to Americans about the new covid vaccine, saying: "There's
 essentially no evidence for it. There's been no clinical trial done in human beings showing that it
 benefits people. There's been no clinical trial showing that it is a safe product for people..."
- Ladapo now joining the growing ranks of healthcare professionals calling for a complete halt to covid shots.

- In world news over 100 were killed my multiple terrorist explosions during a parade.
- The western journal reports at least 103 people were killed and dozens more wounded by two
 explosions in quick succession on the fourth anniversary of the death of Iranian general Qasem
 Soleimani.
- State broadcaster Irib quoted Kerman's deputy governor as saying the deaths were the result of a "terrorist attack," though it was unknown who was behind the bombing and no group had yet claimed responsibility.
- Possible suspects included the Islamic state group, Arab separatists, and "other Sunni jihadist groups,"
 all of whom have claimed in recent years to have successfully killed security forces in the Shia-majority
 state.
- The BBC cited video footage of "hundreds of people" gathered, apparently to mark the anniversary of the death of Soleimani, who had been considered the second-most powerful man in Iran prior to his death in a U.S. drone strike in 2020 under President Donald Trump.
- Fox reported that the explosions led to "up to 141" people being injured, in addition to 103 confirmed fatalities.

- In other legal news, Derrick Vargo becomes the first j6er to sue the capitol police after they pushed him off a ledge. The event was caught on tape.
- The gateway pundit reports the viral video has shown that Vargo was viciously pushed off a 30-foothigh ledge of the us capitol by a dc police officer named Bryant Williams.
- Vargo just filed his paperwork meeting the statute of limitations in the nick of time- January 6th, 2024, marked the three years anniversary of the capitol protest and expiration of filing a lawsuit against the police.
- Vargo initially held back on filing a lawsuit for three years because he was fearful of retaliation and arrest by the Biden regime.
- Vargo stated: "I have accepted the fact that they may arrest me and throw me in D.C. Gitmo only to retaliate for me suing them. But I now realize if I do not do it no one else will."
- Vargo is suing capitol police officer Bryant Williams "in his official capacity as a capitol police officer".
 Williams was seen on video shoving Vargo from a high wall and watching him plunge to what could very well have been his death.

 - O And the LORD spoke to Moses in the plains of Moab by the Jordan across from Jericho, saying:

 2 "Command the children of Israel that they give the Levites cities to dwell in from the inheritance of their possession, and you shall also give the Levites common-land around the cities.

 3 They shall have the cities to dwell in; and their common-land shall be for their cattle, for their herds, and for all their animals.

 4 The common-land of the cities which you will give the Levites shall extend from the wall of the city outward a thousand cubits all around.

 - vv. 3–8, ³ So the children of Israel gave to the Levites from their inheritance, at the commandment of the LORD, these cities and their common-lands:
 - ⁴ Now the lot came out for the families of the Kohathites. - "Matthew stresses Jesus' identity as the royal Davidic Messiah, introducing his Gospel with a genealogy identifying Jesus as the 'son of Abraham' and the 'son of David' (1:1). His 'fulfillment formulas' repeatedly stress Jesus' fulfillment of the Hebrew Scriptures (Matt 1:22–23; 4:14–16; 8:17; 13:35). 'Son of David' becomes Matthew's favorite messianic title, appearing 10 times. In fulfillment of Micah 5:2, Jesus is born in Bethlehem to a descendant of David and heir to the Davidic throne (1:20; 2:1)."1

Mark

Emphasizes Jesus as: The (Suffering) Servant & Son of God

Though Mark does not shy away from the title—his opening line identifies his volume as "the beginning of the good news of Jesus the Messiah"—he takes great pains to show that the Messiah is the "Son of Man, who came not to be served, but to serve and to give his life a ransom for many" (10:45)."2

- Luke provided an "orderly account" of the life and ministry of Jesus Christ for a Gentile audience to prove that Jesus is the promised Messiah for Israel and is indeed the Son of God who became the Son of Man in order to provide the way for the Gentiles to enter the Kingdom as well as Israel. "Jesus' role as the Messiah is linked to Luke's purpose throughout Luke—Acts to show that the message rooted in the Hebrews Scriptures is good news for all people... All along it was part of God's plan that the Messiah would be a 'light of revelation for the Gentiles' (Luke 2:32; Acts 13:47; Isa 42:6; 49:6) and that this message of salvation would go forth from Jerusalem to the ends of the earth (Acts 1:8)... Luke especially emphasizes Jesus' role as end time prophet."³

But He is also the divine Son who was came to reveal the Father and to bring grace and truth to a lost world."4
