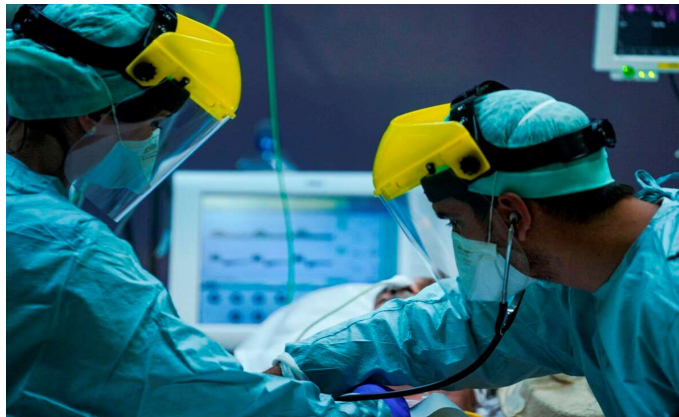

Germ-Wars Scenario Predicts Bioengineered Monkeypox Outbreak May of 2022 But There's Nothing to See Here

Julie Green, a frequent guest on His Glory, [prophesied](#) on March 27th that “Monkeys will be in your news; listen for the words and what they are saying about them. They are giving themselves away.”

Amanda Grace, of Ark of Grace Ministries, on her recent [interview](#) with Clay Clark on June 6th, stated she received this word from the Lord on April 8th of 2021 that “there would be an outbreak of an antiquated virus.” She explains monkeypox and smallpox are very closely related and antiquated in this word means “weaponized” or “manipulated and brought back.”

Since May in the news, out with COVID-19, enter monkeypox. What if I told you there was a 2021 germ-wars scenario where the biological weapon in the mock situation is monkeypox and it's set to hit the world in May of 2022, then POOF magically it happens. Julie and Amanda's words come to mind “they are giving themselves away” and “there will be an outbreak of an antiquated virus.” You literally cannot make this stuff up.

The Epoch Times [reported](#) that a world-wide discussion ensued on monkeypox and smallpox as potentially the next “pandemic” when Bill Gates was quoted in 2021 as stating, “It'll take probably about \$1 billion a year for a pandemic Task Force at the WHO level, which is doing the surveillance and actually doing what I call “germ games” where you practice.” He continues, “You say, OK, what if a bioterrorist brought smallpox to 10 airports? You know, how would the world respond to that?”

The Epoch Times [article](#) continues stating that in 2021, the Nuclear Threat Initiative (NTI) and the Munich Security Conference initiated a germ-war scenario where a strain of monkeypox, a close relative to smallpox, is released in May of 2022. It had been altered as a biological weapon, to be resistant to vaccines. In the hypothetical event, within a year of its release, 271 million people are dead, and the nemesis behind this catastrophe turns out to be a civilian biolab. Not a monkey or a bat? Imagine that.

On June 4th, Dr. Richard Bartlett appeared on Grace and Glory to discuss the NTI germ-war event. He stated that NTI has ties to Bill Gates and explained that natural occurring Monkeypox is not a significant threat to the world. This suggests the hype by the media, Center for Disease Control (CDC), and World Health Organization (WHO) does not match a normal natural occurring monkeypox scenario. Dr. Bartlett brought up the fact that the travel advisory being elevated to a level 2 did not match the risk. The number of deceased in the germ-wars scenario could only be realistic if the strain is bioengineered in a lab to cause more significant harm on a much greater scale. The Epoch Times [reported](#) that the CDC is already sending vaccines to people suspected of being exposed to Monkeypox. Health care workers in Massachusetts were among some of the first to receive these vaccines due to treating confirmed cases. Dr. Rochelle Walensky, CDC Director, states that the U.S. has been preparing for a viral infection event for decades and has millions of doses of vaccines available.

One approved monkeypox vaccine is ACAM2000, which the Epoch Times [reports](#) as restricted to military personnel due to safety risks including the following: blindness, fetal death, encephalitis, vaccine shedding, myocarditis (here we go with that term again), and pericarditis. The other vaccine is Jynneos, manufactured by Bavarian Nordic, approved for use in 2019. According to the CDC, gay and bisexual people make up the majority of confirmed cases.

A [press release](#) from the WHO, dated June 4th, confirmed 780 cases of monkeypox from 27 member states, combined. The release also stated that the geographic areas of these cases were “atypical”, and not from an endemic area, where monkeypox is more prevalent. As such, they assessed the risk at the global level as “moderate.” They also stated early data and PCR tests indicated this particular strain of monkeypox outbreak to have origins from West Africa.

The WHO [release](#) also reported that symptoms of this monkeypox outbreak is not typical for how it historically presents in patients. Examples include the initial onset of a “genital or perianal rash” which sometimes never spreads to any other body part. The location of this rash suggests close physical or sexual contact. Another atypical symptom is the appearance of “pustules” before constitutional symptoms such as a fever, as well as “having lesions at different stages of development.”

The [WHO's](#) press release from June 4th, warns that the risk for the general public, while seemingly low at that time, due to underreporting and the fact that the virus is presenting itself in non-endemic countries, had the potential to become “high risk” as a “widespread human

pathogen.” But not to worry the document goes on to explain THE PLAN and suggestions for member states to follow.

The WHO stated under the [press release](#) section titled, *Risk Communication and Community Engagement*, “It is also important to prevent the spread of rumors and misinformation around monkeypox. It is important for public health authorities to systematically listen to and analyze public health concerns, including through social media, identify key questions and information voids, and build resilience to misinformation. Members of the public should be encouraged to get information only from verified and credible sources.” In essence, trust the WHO implicitly; do NOT entertain the idea of doing your own research. Also, this should be policed by “public health authorities.”

The WHO goes on to state that “Large gatherings may represent a conducive environment for the transmission of monkeypox virus if they entail close, prolonged, and frequent interactions among people, which in turn could expose them to contact with lesions, body fluids, respiratory droplets and contaminated materials.”

While the WHO does not recommend cancelling events or international travel at present time, they encourage precautions be taken to quickly contain any outbreaks. The Who’s Interim Guidance came out on June 14th and [stated](#) that “mass vaccination” is not required at the present time.

The Epoch Times [reports](#) that the World Council for Health (WCH) has accused the WHO of having no scientific basis regarding monkeypox to “justify further human rights violations.” They go on to allude to an increase in shingles cases in people who have taken the COVID-19 vaccine, and suggest monkeypox as being used as a cover for vaccine injury. Another interesting theory.

Fox news [reported](#) on June 14th, that WHO Director Ghebreyesus stated, ““The outbreak of monkeypox is unusual and concerning. For that reason, I have decided to convene the emergency committee under the international health regulations next week to assess whether this outbreak represents a public health emergency of international concern.” Fox goes on to report that scientists have asked the WHO to change the name, Monkeypox, because it is discriminatory in nature. Not surprisingly, the WHO has agreed to comply with this ridiculous request. Maybe they should ask the Monkeys how they feel about it.
