JESUS ROSE FROM THE DEAD. IMPOSSSIBLE? (EASTER 2014)

- >>>>This "Not a Sermon" played all over the DC area these past 2 weeks
- >>>& it went along with posters on buses & in metro stations **SLIDE**
- >>All asking the same Q:NAMELY—"DID J REALLY RISE FROM THE DEAD?"
- I- & so—let's <u>answer</u> that Q right now
- A. While J was here on earth--He was constantly telling pple—tht He was going to rise from the dead
- B.He said this **TO HIS ENMIES**(Mt 12:40) "Fr as Jonah was in the belly of the fish fr 3 days & 3 nights, so the Son of Man (ic, self) will be in the heart of the earth for 3 days & 3 nights"
- C. He said it **TO HIS FRIENDS**(Mt 16:21)

 "Frm tht time on, J began to show-his disciples tht He must go to Jeru...& be killed, & <u>BE RAISED TO LIFE AGAIN</u> on the 3rd day"
- D. He said it **TO THE CROWDS**(Jn 2:18)
 - 1. "I said, 'Destroy this temple, & in 3 days, I will raise it back up.'"

- 2. V. 20-Then the crowd said, "It has taken 46 yrs to build this temple, & U will raise it up in 3 days?"
- 3. V. 21-"But J was speaking of the temple of His body."
- E. In fct, <u>as J hung on the cross</u>, his enemies <u>taunted</u> him by saying (Mt 27:40)-"U who are going to destroy the temple & rebuild it in 3 days, come down frm the cross & we will believe in U"
- F. When R's went to Pilate to ask fr Rmn soldiers to guard J's tomb (Mt 27:63)-"Sir, we remember tht when he was still alive, this deceiver said, 'After 3 days, I will rise again"
- G. **PT**: *Everybody* in Is knew full well ab J's claim to rise from the dead
- H. But real Q is: "DID J DO IT?"
- J. Well--I believe He DID!
- K. & I've got 4 pieces of compelling evidence I'd like to offer U
- L. #1-COMPELLING EVIDENCE OF THE ROMAN SOLDIERS
 - 1.Mt 27:63(Jwh ldrs to Pilate)-"Sir,

- we rem tht when he was still alive, tht deceiver said, 'After three days I will rise again."
- 2. V. 64-"So please command the his tomb be made secure until the 3rd day, lest his disciples come by night & steal his body, & say to the pple, 'He has risen from the dead.' & then, this last deception will be worse than the 1st."
- 3. V. 65-"Pilate said to thm, 'Take a squad of Rmn sldrs & make the tomb as secure as U know how."
- 4. V. 66-"So they went & made the tomb secure by putting a seal on the stone & posting the guard."
- NOW--a Rmn security team like this consisted of 15 enlisted mn + 1 officer
- 6. & these sldrs had <u>a deeply vested</u> interest in making sure the nobdy stole J's body
- 7. **BEC**--if a Rn sldr lost his prisoner *EVEN HIS **DEAD** PRISONER... *He lost his life!

ILLST: ACTS 16--AP in jail in Philippi—angel came & blew open prish doors *Acts 16:27-"The jailer (Rmn soldr) awoke, & seeing the prish doors open, he drew his sword & was abt to kill hmslf, supposing for sure the prisoners had escaped"

*WHY was this Rn sldr gnna kill self?

- *Well bec he <u>knew--tht</u> if the prisners had escaped--<u>his superiors</u> were going to kill him...
- *So he figured <u>he'd save thm trouble!</u>
- *This=why P cried out(V. 28)-"Don't hurt yurself, for we're all here!"

AP:NOW--in lght of this--do we rlly think *Tht a bunch of unarmed wmn & fishermen

- *Cld've gotten past these battlehardend sldiers ...
- *Who knew their lives on the line
- *& stolen the body of J?

*PREPOSTEROUS--IMPOSSIBLE! M. #2-COMPELLING EVIDENCE OF J'S

ENEMIES

1. When the msg tht <u>I had risen frm</u>

the dead bgan spreading thru Jer 2.R's were dtrmnd to stop it atallcosts 3. It startd on the vry day of J's resur *Mt 28:12-"Then the R's gave the sldrs a great sum of mney & said, 'Tell ple tht His disciples came at night & stole his body away while U were sleeping."

* 4: It continued after J's ascension *Acts 4:1-"As Ptr & Jhn were speaking to the crowd, the R's were greatly disturbed bec they were preaching J & His resurrection from the dead"

*So they arrested them twice...

*& beat them

*& commanded thm nvr to preach ab J's resur'n again

- 5. SO I ASK MYSELF: "Why did these Rabbis spend ALL this money... *& go to ALL this political trouble *To try & <u>discredit</u> J's resurr?
- 6. Think abt it—all they had to DO... *Was to produce J's dead body... *To put it on a cart & roll it thru

Jeru for everybody to see
*& finito/it's settled/end of story!

- 7. SO WHY didn't they do this?"
- 8. $\underline{\mathbf{A}}$ (of crse)=thre $\underline{W}\underline{A}\underline{S}$ no dead bdy
- 9. & we've alrdy agreed... RIGHT??

 *Tht bec of the Roman sldrs...

 *No hn bng cld've taken J's body...

10. So whre did it go--if NOT fr resr?

N. #3-COMPELING EVIDENCE OF THE EYEWITNESSES

- 1.1 Cor 15:3(AP)-"Fr I delivered to U the msg tht I also received: tht Chrst died for our sins acc to the Scriptures, & tht IIe was buried, & tht He rose again on the 3rd day acc to the Scriptures."
- 2. V. 5-"& tht He was seen by Ptr, thn by the Twelve (apostles)."
- 3. V. 6-"Aftr tht, He was <u>seen</u> by over 500 brethren at once, most of whom are still alive to this day."

ILL: P="If U don't blve me, go ask thm"

APP: Why wld P_dare issue this kinda

Challenge--if he cldn't back it up?

[BUT P'S STILL NOT FINISHED—LOOK]

4. V. 7-"After tht, He was <u>seen</u> by James, then by all the apostles.

5. V8-"& last of all, He was <u>seen</u> byme

L: This wk I ready thru a # of bks on

IL: This wk--I ready thru a # of bks on "Evidence" currently used by Law S's

*I found thre's a growing trend to <u>minimize</u> eyewitness testimony

*Bec it can often be <u>contradictory</u>

*& bec DNA testing has <u>overturned it</u> in a number of cases

AP: <u>BUT</u>—in these books—the discussion was always abt <u>only a few eyw'tnsses</u> ... <u>whose testimonies disagreed!</u>
*Nevr ab <u>more than 500 eyewitnses</u>

*Whose testimonies all **AGREED!!**

ILLUST: <u>BAYES' THEOREM</u>—math'cal formula tht calculates how "likely" it is that an event really happened *Hcrc's the formula: **SLIDE**

*T = "number of <u>eyewtness acc't's</u> tht <u>agree</u> with one another"

*[AS U CAN CLEARLY SEE] the higher
"T" is—the greater the probability
tht the event in qustion rlly hpnd
IL: Dr. John DePoe (Western Mich Univ)

O. #4-COMPELLING EVIDENCE OF
EYEWTNESSES' MARTYRDOM

1.I trust U knw—tht virtually evry eyewitness of J's resurr B mentions *Died as a martyr...

*Rather thn recant their testimony *Tht J had risen frm the dead

ILLUST: Ap James killed by Herod(A12)

*Stephen was martyred in Jeru (A 7)

*Thomas was martyred in India

*Ihn Mark was martyred in Egypt

*Philip was martyred in Turkey

*Matthew was martyred in Ethiopia
*AP was beheaded in Rome by Nero(66)
*& Nero crucified Ptr upsde dwn sameyr
ILLUST: BUT NOT JUST THE APOSTLES

*Tacitus..writing ab Rme under Nero:

"Chr's were crucified or set on
fire so tht, whn darkness came,
thy burned like torches in the nite

APP: Now—pple don't <u>do this</u> fr a scam

* <u>Somebody</u> breaks/cracks/<u>TURNS</u>

[WE'VE ALL SEEN "LAW & ORDER"!!]

- 2.But Ptr/Jmes/Matt/ P & 100's of other early Chr's didn't turn
- 3. **BEC**—they weren't <u>running</u> a "con"
- 4. They'd really <u>seen</u> the Risen Christ
- 5.& were wllng to die rthr thn deny it

P. SUMARIZE—COMPELING EVIDENCE

#1-Evidnce of Rn sldrs—whch mkes
hn tampering w/J's body imposs
#2-Evidnce of J's enemies—who clda
stopped Chr'ty"dead in its tracks"
by just producing J's dead body
—but they didn't ...bc they cldn't

- #3-Evidnce of the eyewtneses—100's of whm <u>agreed</u> thy'd seen Risn Chst #4-Evidnce of eyewitnesses' mrtyrdm their willingness to die rather thn recant their testimny abt resurr
- Q. Can I prove to U in a "test-tube" tht the resurr of JC is true? NO, I CAN'T!
- R. BUT--can I give U such a strong prepondernce of EVIDENCE...that even Judge Judy wld be convinced?

S. WELL----I JUST DID!!!! CONCLUSION

- >In closing—rem the awesome promise J made us ab the aftrlife(Jn 11:25)-"He who belves in Me shall live(in aftrlfe) even if he dies(here on erth)"
- >But U knw--Budism/Islam/Mormonism
 -----/Hindism/Scientology they all
 make great promises abt afterlife too
- >><u>SO--how do we know who's right</u>?
- >>><u>Well, it's very simple, my frnds</u>:
 "WHO ROSE FROM THE DEAD?"
 - *Budda didn't rise from the dead
 - *Mohammed ...rise from the dead
 - *Jo. Smith didn't rise from the dead

- *L. Ron Hubbard didn't rise frm dead *No Hindu holy man ever rose...
- >>BUT B says(Acts 17:31)--"Gd has givn us PROOF [J is right/one to fllw/can bck up his promises abt the afterlife]
 Gd has givn us PROOF by raising
 Him (J) frm the dead"
- >>So here's J's promise: "The prsn who blieves in me shall live evn if they die
- >>> The Q: "Are U prepared to take him up on it—if U've never done so?"
