# STUDY GUIDE INSTRUCTIONS

## Instructions for “Discuss: Instruction/Application” questions in the study guide.

- 1** First, look up the ‘Instruction’ passage in the Law and briefly summarize it in one or two sentences. (The instruction passage is the part of the law that instructs Israel on how they were to act, believe, or live. Do not use commentaries. Instead, simply look up the verse and summarize its instruction to Israel.)
- 2** Next, look up the ‘Application’ passage (THE APPLICATION PASSAGE IS NOT YOUR APPLICATION. IT IS THE PASSAGE IN WHICH THE LAW MUST BE APPLIED OR UNDERSTOOD IN ORDER TO CORRECTLY BE INTERPRETED) and briefly summarize it in one or two sentences.
- 3** Finally, explain why/how the instruction passage relates to / impacts the interpretation of the ‘application’ passage. For example, “The Law instructs Israel not to do X. Israel is doing X. That is bad.”

Rebellious Children**

**Application (1 Sam 2:14-36) – Eli's Sin and the Sins of His Sons**



## INSTRUCTION AND APPLICATION

### **Deuteronomy 22:22-24 in John 8:5**

**Instruction (Deut 22:22-24) – Stoning for Adultery**

**Application (John 8:5) – Pharisees Presenting Law Requirement**



## INSTRUCTION AND APPLICATION

### **Deuteronomy 23:21-23; Numbers 6:2-21 in Judges 14:8-9**

**Instruction (Num 6:2-21) – Nazarite Requirements**

**Application (Jdg 14:8-9) – Samson’s Nazarite Vow and the Lion**

## DISCUSSION QUESTIONS

1. The first “*fat portions*” offering in the Bible is recorded in Genesis 4. In Genesis 4, Abel brings an offering from the firstborns of his flock and from their “*fat portions.*” This offering serves as a substitute until the Promised First-Born Sacrifice would be offered on Calvary.

**How does this help you understand both the significance of the fat portions and the magnitude of Eli’s sons’ offense?**

## DISCUSSION QUESTIONS

2. Last week we began looking at the incident in John 8 with Jesus and the adulterous woman. The law does say that someone guilty of adultery should be stoned.

**Who is missing from the accusation in the John 8 account?**

**What does Deuteronomy 17:6-7 and Deuteronomy 19:15-21 have to do with the situation in John 8?**



## DISCUSSION QUESTIONS

3. Read Judges 13-16.

**How much does Numbers 6 (Nazarite vow, also Deuteronomy 23:21-23) have to do with the Samson story?**

**Can you identify any other issues in Judges 13-16 that are relevant to Moses's instruction in Deuteronomy?**
