## **BANANA REPUBLIC USA**

declaring this 'People's Republic' and vowing that they will return power to the populace as soon as the government / country is rid of political cancer. The FBI broke all American precedent to seize documents whose turnover was in the process of being negotiated between the DOJ and the Trump Team, all without a prior subpoena. This was completely out of step with how other former presidents and high-ranking government officials had been treated in the past. This FBI raid marked the FULL WEAPONIZATION of the FBI as the enforcement arm of the Biden REGIME, a destiny they were moving toward for some time now.

Of course, this is all about neutralizing the political threat

represented by President Trump. Former Hillary Clinton lawyer, Marc Elias cited US Code Title 18, Section 2071 which states, "Whoever, having the custody of any such record, proceeding, map, book, document, paper, or other thing, willfully and unlawfully conceals, removes, mutilates, obliterates, falsifies, or destroys the same.... shall forfeit his office and be disqualified from holding any office under the United States." But Elias did admit that making that case stick may be difficult – but still problematic to a Trump candidacy.<sup>1</sup>

It is hard not to see the political motivation. Hillary Clinton acid-washed 30,000 emails with no repercussions and the FBI didn't even take notes during her interview. Immunity was being passed around like a bong at a college frat party. The evidence on Hunter Biden's laptop was routinely ignored even though it pointed to perceived criminal activity pointing to Hunter as well as the 'Big Guy' then-Vice-President-Joe and his brother. All of that was easily ignored the DOJ & the FBI. Trump aid, Peter Navarro was arrested and detained at an airport – for a misdemeanor – unheard of! Trump's National Security Advisor, Lt General Thomas Flynn, was set up via a 'casual' FBI interview – with notes taken, that resulted in a legal muddle which even the Wall Street Journal describes as "ugly

tactics" employed by "James' Comey's FBI" which resulted initially in a guilty plea to "a felony count of 'willfully and knowingly' making false statements to the FBI. The Journal – as well as many independent

legal scholars at the time, characterized it as "entrapment."<sup>2</sup> The DOJ later dropped the charges against General Flynn when it came out that the FBI had admittedly set Flynn up through a form of entrapment.<sup>3</sup> More recently, the President's lawyer, Rudy Giuliani became a target of a raid. Then there was the Russia-Collusion Hoax that the Agency knew from the get-go wouldn't hold water. James Comey helped create that climate with the aid of stolen documents – never prosecuted – and lied to keep it alive for years. The FBI hung on to that for dear life, looking for a way to bring down the 45<sup>th</sup> President.

Finally, there are the events of January  $6^{th}$  & the reaction to those events. There is a mountain of evidence that the FBI along with other law enforcement was involved in at least allowing, if not encouraging protestors to enter the capital – thereby putting to bed any thought of a legal and orderly examination of the real vote count, fraught as it was with all sorts of irregularities, including secret vote counting with no Republican present. [Yes, nothing speaks American values like secret vote counts of boxes of ballots that you've just 'discovered'!] Add in the crackdown and abandonment of the American justice system that followed January 6 – especially with regard to the J6 protestors – many still locked in the DC jail. The FBI was scooping up Americans that were not even at the Capitol that day. The whole J6 was a brilliant strategy on the part of the Usurpers – if you are looking to establish a One-Party-State, like say, the Soviet Union. So, it should be understood for what it is. When you comprehend it in its' full context, this is nothing less than another Assault on the American Republic.

One-Party-Rule is the hallmark of a failed state. Censorship is a hallmark of a failed state. The harassment and arrest of the political opposition is a hallmark of a failed state. America is checking all of those boxes. Martin Armstrong, who has been described as a "legendary financial and geopolitical cycle analyst," labels the raid as " a real deathblow to the very idea of a democracy." In an interview with Greg Hunter on USA Watchdog, he explained, " This really is unprecedented . . . . In the United States, we are supposed to have civilized transfer of power. That's all coming to an end."<sup>4</sup>

It is easy to see that this is not about equal justice under the law, but rather advancing a political agenda. The judge who signed off on the warrant was Judge Bruce Reinhart. Let's look just a bit at his background to see if he should qualify as an impartial justice. Reinhart was a contributor to President Obama. He was a Federal Prosecutor who left his office "to help employees of Jeffrey Epstein secure immunity deals from the government...after leaving his post in the U.S. attorney's office where he was supposedly helping the government prosecute Epstein and his employees for alleged sex trafficking." He was an open and avid criticizer of President Trump on Facebook. Noting his history, Townhall's Spencer Brown writes, that record "makes Reinhart seem like the kind of guy who would impartially judge the merits of a search warrant request that, if granted, would lead to a raid on Trump's Mar-A-Lago, doesn't it?"<sup>5</sup> It is all political and it is no longer the least bit clever. There is more to come. Using his "Socrates" computer program, Martin Armstrong says Biden has the support of just 12% of Americans. Armstrong states he was "warned that the Democrats have been maneuvering, and the reason they are allowing all the illegal aliens to come in is they intend to allow them to vote."<sup>6</sup> This is not far-fetched. The DOJ is suing Arizona over a law that requires voters to prove their citizenship.<sup>7</sup>

This is so much more than a war against Trump, though they fear him the most. It is a war against Americans and traditional American values. It is a war against conservatives, constitutionalists and Christians. It is a war against the biblical values that underlay the founding of this country. And the warning is this: This war has just begun....And they're coming for you!
