VACCINES

THE EVIDENCE TELLS THE STORY

It is getting increasingly difficult to deny the dangerous nature of the Covid vaccines. Government statistics, medical studies and the reports of insurance companies are painting the jabs as anything but safe and effective. Joe Biden and Anthony Fauci were quadruple jabbed and not protected. And studies are finding that the vaccines are actually wearing down the immunity of those who have put their faith in Moderan, Pfizer et al. Here are some of the specifics.

According to a new study from UCLA and Stanford, as one headline put it, "Risk benefit of vaccines is negative." This from a study undergoing peer review. Natural News put it more bluntly. "Thousands of people are dying 'unexpectedly' every week in the post-covid era." They reported, "For the week ending July 8, 2022, 10,232 deaths were recorded by the United Kingdom's Office for National Statistics (ONS),



432 of which were recorded as being related to the Wuhan coronavirus (Covid-19). This is nearly 1,000 more deaths than normal compared to pre-covid levels, a trend that has been going on for at least the past 11 weeks." The UK's Dr John Campbell has analyzed the Covid phenomenon from the beginning. "This is not just a U.K. phenomenon. This is an international phenomenon.... Dr Michael Yeadon, a former vice president at Pfizer, has also come forward with claims that Chinese Virus injections are, in fact, responsible for the excess deaths

phenomenon now being seen all around the world." Natural News points out that even excluding deaths blamed on Covid itself, the excess death rate in 2022 for England and Wales is 16.6 percent."²

Insurance companies don't fool around. Crossroads Report headline: "Fifth largest life insurance company in the US paid out 163% more for deaths of working people ages 18-64 in 2021 - Total claims/benefits up \$6 BILLION" The name of the company is Lincoln National. Earlier this year One America insurance company reported "deaths among working people ages 18-64 were up 40% in the third quarter of 2021." "The annual statements for Lincoln National Life Insurance Company show that the company paid out in death benefits under group life insurance policies a little over \$500 million in 2019, about \$548 million in 2020, and a stunning \$1.4 billion in 2021. From 2019, the last normal year before the pandemic, to 2020, the year of the Covid-19 virus, there was an increase in group death benefits paid out of only 9 percent. But group death benefits in 2021, the year the vaccine was introduced, increased almost 164 percent over 2020."

Add this. The National Bureau of Economic Research found that "there were conservatively 170,000+ non-Covid excess deaths in the U.S. through 2020 and 2021. The study notes that the real number is likely closer to 200,000 because over 70,000 so called 'unmeasured Covid deaths,' that is people who may have died only with the virus and not from it, were not taken into account."⁴

So, the vaccines are lethal. And the lockdowns were lethal. And now we're finding out the roll-out of 5G is lethal – especially when combined with the vaccine. International insurance giant, Swiss Reinsurance, classified 5G as a "high impact" liability risk. Mark Steele is an engineer and "weapons research scientist" from the UK. He calls 5G a "crime against humanity. The 5G network has the capability to target acquire and attack the vaccinated due to their nano metamaterial antenna Covid-19 vaccine. Lethal Autonomous Weapons Systems (LAWS) require the 5G networks to maintain their geo-position and navigate their environment to the target; these weapons cannot rely on satellite communications due to the potential for inclement weather events and signal latency to disrupt their signals so they must have localized 5G

networks....5G is a compartmentalized weapons deployment masquerading as a benign technological advance for enhanced communications and faster downloads."⁵

Then consider the Pentagon numbers collected through the DMED – or Defense Medical Epidemiology Database. It is considered "one of the best data bases in the world." There numbers showed "a disturbing trend with post-COVID jabs – dramatic increases in medical visits for malignancies, neurological and autoimmune diseases, and infertility. But after being exposed, DMED was shut down and its data spikes washed clean."

Back in February we reported on the initial leak. . Three military doctors have come forward as whistleblowers to reveal the incredible spike in vaccine injuries among the military. First they presented the data from 2016 to 2020 to establish a baseline – and then compared it to the government released data – all from the Defense Department DMED site. Steve Kirsch of Substack reports, "Doctors are mystified by a rash of seizures, rashes, etc. happening to 2 and 3-year-old kids. That same day, another person named Chris Houghton-Rai collapsed while working his job at a Toyota dealership. For 90 minutes, paramedics tried to revive him but were unable to stop his sudden death."

Finally, "3 young doctors have died suddenly in Mississauga (suburb of Toronto) after getting latest mandated booster." This rash of sudden deaths among the young and vaccinated can no longer be hidden. "According to the Royal Australian College of General Practitioners, this new death category is dubbed "Sudden Adult Death Syndrome (SADS)."
