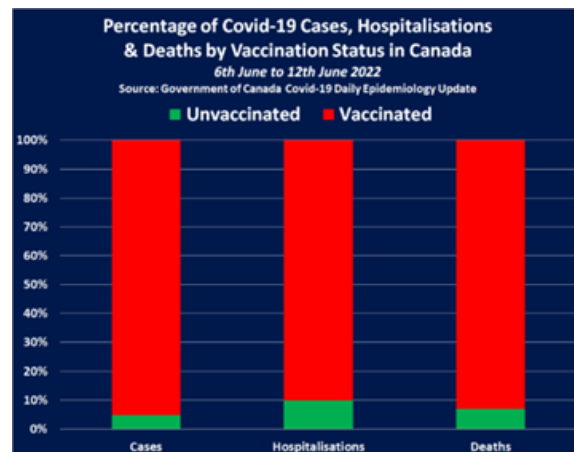


# VACCINE UPDATE

Dr Peter McCullough and Dr Richard Bartlet were on table talk with Joni talking about the Swedish study. Dr McCullough: “The Pfizer vaccine in fact reverse transcribes and installs DNA into the human genome.” Dr Bartlet: “There’s an enzyme that can take that messenger RNA vaccine information and put it into their DNA. And we were told that could not happen... We were told that that messenger RNA could not go into your DNA. But this is showing that in a lab, it can.”<sup>1</sup> Other doctors chimed in on other forums. “That DNA change lasts forever. The entire human genome has been poisoned with a gene that has never been in the human genome ever in history.” The study showed that “within 6 hours the liver cancer cells had converted the RNA into DNA.” Research out of China showed “that the spike protein from the vaccines are producing severe DNA damage, releasing “inflammatory agents” that causes “significant damage” to surrounding cells.”<sup>2</sup>

**THE LANCET: THE VAX COMPROMIES IMMUNE SYSTEMS** – A review of the study published in the Virology Journal on June 5, 2022 reported, “The study showed that immune function among vaccinated individuals 8 months after the administration of two doses of COVID-19 vaccine was lower than that among the unvaccinated individuals. The European Medicines Agency concurred that “frequent COVID-19 booster shots could adversely affect the immune response.” The study also found an “association” between COVID-19 vaccination and shingles,” by reactivating that virus. After viewing the evidence, “hypothesized that there will be an increase in cardiovascular diseases, especially acute coronary syndromes, caused by the spike proteins in genetic vaccines. Besides the risk of infections owing to lowered immune functions, there is a possible risk of unknown organ damage caused by the vaccine that has remained hidden without apparent clinical presentations, mainly in the circulatory system.”<sup>3</sup>
