Expand the definitions of pandemics and health emergencies. Specifically, it introduces 'potential for harm' rather than actual harm. So, the WHO can mandate lockdowns or medical interventions based on the mere suspicion that a virus might cause public harm. Change the recommendations of the IHR from nonbinding to mandatory, so member states must follow and implement the WHO's recommendations.

Solidify the director-general's ability to independently and single-handedly declare health emergencies.

Set up an extensive surveillance apparatus in all member states.

Enable the WHO to share country data without consent.

Give the WHO control over certain resources within member countries, including intellectual property rights.

Force national support for censorship activities directed by the WHO.

Change existing IHR provisions that affect individuals from nonbinding to binding, including provisions relating to border closures, travel restrictions, quarantines, medical examinations and the medication and vaccination of individuals.

Here is Dr. Mercola's summary of the International Pandemic Treaty that the WHO is pushing:

Set up an international supply network overseen by the WHO.

Fund the WHO's health emergency structures and processes by requiring at least 5 percent of national health budgets to be dedicated to health emergencies.

Set up a governing body under the auspice of the WHO to oversee the entire health emergency process.

Expand scope of the WHO's power by emphasizing the 'One Health' agenda, which recognizes that a very broad range of aspects of life and the environment can impact health and therefore fall under the 'potential' to cause harm. This is how the WHO will be able to declare climate change as a health emergency and subsequently require climate lockdowns, for example.

Major dam breached in southern Ukraine, unleashing floodwaters

A major Soviet-era dam in the Russian controlled part of southern Ukraine was breached on Tuesday, unleashing floodwaters across the war zone in what both Ukraine and Russia said was an intentional attack by the other's forces.

Unverified videos on social media showed water surging through the remains of the dam with bystanders expressing their shock, sometimes in strong language. Water levels raced up by metres in a matter of hours.

Ukrainian President Volodymyr Zelenskiy blamed Russia for the damage.

"The destruction of the Kakhovka hydroelectric power plant dam only confirms for the whole world that they must be expelled from every corner of Ukrainian land," Zelenskiy wrote on the Telegram messaging app.

Ukraine's military said that Russian forces blew up the dam.

Russian-installed officials in Kherson said Ukraine struck the dam at 2300 GMT several times, destroying the hydraulic valves of the hydroelectric power station but said the dam was not totally destroyed.

We can grab another clue last December's Washington Post, which ran a story describing in glorious detail how the Ukrainians worked out the best way to destroy the Kakhova dam, "as a last resort":

#### The Washington Post

The two bridges were targeted with U.S.-supplied M142 High Mobility Artillery Rocket Systems - <u>or HIMARS launchers</u>, which have a range of 50 miles - and were quickly rendered impassable.

"There were moments when we turned off their supply lines completely, and they still managed to build crossings," Kovalchuk said. "They managed to replenish ammunition. ... It was very difficult."

Kovalchuk considered flooding the river. The Ukrainians, he said, even conducted a test strike with a HIMARS launcher on one of the floodgates at the Nova Kakhovka dam, making three holes in the metal to see if the Dnieper's water could be raised enough to stymie Russian crossings but not flood nearby villages.

The test was a success, Kovalchuk said, but the step remained a last resort. He held off.

We saw after an offensive by Russia on an ammunition factory that the Ukrainians did this:

A drone attack in Moscow last week appeared to target the homes of Russian intelligence officers, the latest salvo in a psychological campaign against Russian President Vladimir Putin's regime over its invasion of Ukraine, multiple sources familiar with the strikes said.

The drone assault Tuesday was the first on a residential area in the capital since Russian forces launched an invasion of Ukraine on Feb. 24, 2022.

Nazi Symbols on Ukraine's Front Lines Highlight Thorny Issues of History Troops' use of patches bearing Nazi emblems risks fueling Russian propaganda and spreading imagery that the West has spent a half-century trying to eliminate.

The iconography of these groups, including a skull-and-crossbones patch worn by concentration camp guards and a symbol known as the Black Sun, now appears with some regularity on the uniforms of soldiers fighting on the front line, including soldiers who say the imagery symbolizes Ukrainian sovereignty and pride, not Nazism.

In April, Ukraine's Defense Ministry posted a photograph on its Twitter account of a soldier wearing a patch featuring a skull and crossbones known as the Totenkopf, or Death's Head. The specific symbol in the picture was made notorious by a Nazi unit that committed war crimes and guarded concentration camps during World War II.

The patch in the photograph sets the Totenkopf atop a Ukrainian flag with a small No. 6 below.
