The origin of COVID-19—a virus with a death toll surpassing one million Americans and then six million globally—is a question that must be answered. Discovering the origin is vital to providing accountability and protecting Americans in the future. Mounting evidence points to the virus originating from a leak at the Wuhan Institute of Virology (WIV). EcoHealth Alliance, a U.S. National Institutes of Health (NIH) grantee, awarded taxpayer funds to the WIV to conduct gain of function research on bat coronaviruses – research that may have started the pandemic.

Committee Republicans have unearthed emails revealing that top virologists warned Dr. Anthony Fauci, the Director of the National Institute of Allergy and Infectious Diseases, that the virus appeared to be genetically engineered and pointed to a lab leak in Wuhan. Russian Defence Ministry continues to analyse US and its allies military and biological activity in Ukraine and other regions of the world.

I would like to point out that the information we publish has been heard by the foreign media, despite strict Western censorship. Authoritative international publications such as The Times, The Guardian, The New York Post, Sky News published the information on the most high-profile topics: safety violations in American biolaboratories, the enhancement of the functions of pathogens at Boston University and the transfer of unfinished Ukrainian projects to the territory of other countries.

In addition, the operation of United States biolaboratories in Ukraine raises more and more questions among ordinary citizens and political figures in the United States itself.

Thus, specialists from Japan and Nazi Germany were brought to the United States after World War II to 'transfer expertise' in military biological research. The purpose of the project was, '...to develop an experimental weapons programme and to bring in Japanese scientists who are the only ones who have ever used biological weapons...'

THE FBI'S COLLABORATION WITH A COMPROMISED UKRAINIAN INTELLIGENCE AGENCY TO CENSOR AMERICAN SPEECH

The First Amendment to the Constitution of the United States is the bedrock of our political system and guarantees every American the right to speak his or her mind freely and without interference from the government. It is predicated on the understanding that no government official has a monopoly on the truth and that every American is capable of evaluating competing claims and deciding what to believe.

On February 15, 2023, as part of its investigation into the federal government's role in censoring lawful speech on social media platforms, the Committee on the Judiciary issued a subpoena to Meta,² the parent company of Facebook and Instagram, and Alphabet,³ the parent company of Google and YouTube. Documents obtained in response to those subpoenas revealed that the Federal Bureau of Investigation (FBI), on behalf of a compromised Ukrainian intelligence entity, requested—and, in some cases, directed—the world's largest social media platforms to censor Americans engaging in constitutionally protected speech online.

The Committee's investigation has revealed that the FBI, the federal law enforcement agency responsible for disrupting foreign malign influence,⁴ facilitated censorship requests to American social media companies on behalf of a Ukrainian intelligence agency infiltrated by Russian-aligned actors. In so doing, the FBI violated the First Amendment rights of Americans and potentially undermined our national security.

This interim report is based on material obtained by the Committee and the Select Subcommittee pursuant to subpoenas issued to Meta, the parent company of Facebook and Instagram, and Alphabet, the parent company of Google and YouTube. The facts as recounted in this report are merely a subset of the information obtained to date, but they provide a powerful indication of the FBI's failure to respect fundamental American civil liberties.

Why Britain’s most prestigious bank canceled Nigel Farage
UK Prime Minister Rishi Sunak says the prominent Brexiteer’s case raises free speech questions.

He always said the U.K. establishment was out to get him. Now Nigel Farage has the receipts.

Britain’s most prominent Brexiteer has produced a 12,000-word document from the bank Coutts which, according to Farage, reveals the truth behind the forced closure of his account there.

The former Brexit Party leader has been embroiled in a row with the institution — so esteemed it has served successive generations of the royal family — after Coutts

canceled his account earlier this month. Farage said at the time that no reason was given — but subsequent media reports, including on the BBC, cited a minimum wealth threshold Farage no longer met.

Now an internal document from Coutts, obtained by Farage through a subject access request he made to the bank and published in full by the Daily Mail newspaper, shows it wanted to drop him as a client long before — and used his controversial public profile as justification.

A briefing presented to the bank's "reputational risk committee" said Farage is considered by many to be a "disingenuous grifter" with "xenophobic, chauvinistic and racist views" and suggests it could dump him once he paid off his mortgage and dropped below its wealth criteria.

The document cites his comments on Brexit, his friendship with former U.S. President Donald Trump and controversial tennis star Novak Djokovic. It flags his views on the COVID vaccine and un-evidenced links to Russia.

'At Least 25-30' IRS Agents in Tactical Gear Raid Business in Stuart, Florida

Being Christian In An Age of Heightened Hostility

In response to a Breakpoint commentary about the murders in Nashville in March, the Colson Center was identified by a critic as being "proudly, if quietly, Dominionist." To be clear, we aren't, but he was particularly troubled by how the commentary described Christians as victims which, of course, they were.

In that commentary, we wondered aloud whether in fact we have entered a new cultural moment, characterized by an increased hostility toward Christians and others who are, shall we say, culturally non-conforming. The strange and shameful reversal of who is victim and who is guilty in the reporting on the Nashville incident has only continued since, and now there are additional incidents to consider as well.

On March 29, while speaking on abortion at Virginia Commonwealth University, Kristan Hawkins and a group from Students for Life were confronted, threatened, and assaulted by an obscenity-crying crowd who failed to notice the irony of suppressing free speech by screaming "fascists!" Rather than remove those disrupting the presentation, the campus police removed the pro-lifers.

Two days later, on March 31, authorities in Colorado arrested 19-year-old William Whitworth for two counts of attempted murder, in addition to other charges. Whitworth, who goes by the name Lily and was in the process of "transitioning," was planning a series of bomb and gun attacks on several sites in Colorado Springs, including schools and churches.

As with the Nashville shooter who identified as transgender, police have not revealed the "manifesto" that would reveal Whitworth's specific motives. However, there is ample evidence that rhetoric about the so-called "trans genocide" is leading advocates to increasingly violent means to make their point.

Then, on April 6, college swimmer Riley Gaines was physically assaulted while giving a speech at San Francisco State University. As she argued against the inclusion of men in women's sports, she was berated, threatened, and blockaded in a room until she paid a ransom.

Media accounts employed terms like "allegedly" to cast doubt about what happened, but audio and video recordings were plain. Afterward, rather than condemn the violent and threatening acts, the vice president of student affairs praised activists for "defending diversity and free speech."

The California Senate held a hearing last week on AB 1078, a bill to curb the control local school districts have over their own curriculum and allow the State to fine school districts if their curriculum isn't "inclusive and diverse" enough. The legislation was in response to California parents protesting pornographic books found in K-12 libraries as well as school board members from Temecula who oppose Critical Race Theory (CRT) and refused to approve an elementary school social studies curriculum because it included an LGBT historical figure known for having sex with a teenager.

The controversy came to a head two months ago when, Temecula Valley Unified School District Board rejected a new social studies curriculum that included, among other things, material on gay activist Harvey Milk. School Board President Joseph Komrosky opposed the curriculum, calling Milk a "pedophile." Board Member Danny Gonzalez added that the "inclusion of sexually based topics and the glorification of a known pedophile" would be "morally reprehensible and inappropriate."

Governor Gavin Newsom and State Attorney General Rob Bonta publicly criticized Komrosky and issued a press release threatening "repercussions" and expressed "deep concern about the potential discriminatory intent."

Southern California school board rejects curriculum that mentions Harvey Milk
The controversy centered over a three-paragraph mention of the gay rights figure in supplemental materials.

Southern California school board has become the latest proxy for culture wars brewing across the country after a conservative bloc voted to formally reject state-endorsed curriculum that would have mentioned gay rights figure Harvey Milk.

On Tuesday, a heated Temecula Valley Unified School District board meeting dissolved into shouts and jeers as parents, teachers and community members confronted one another over a three-paragraph mention of Milk in supplemental materials for students in grades one through five.

At least three people were ejected from the five-hour hearing and escorted outside by law enforcement officers. In the parking lot, stickers in support of the far-right Proud Boys group mysteriously appeared on cars.

“The curriculum has already been vetted, piloted and approved by an overwhelming majority of actual TVUSD parents and teachers, so stop wasting money playing chaotic political games and stoking the fires of culture wars,” she said. “This never should have been an issue.”

But Tim Thompson, founder of the Inland Empire Family Pac and evangelical pastor at 412 Church Temecula Valley, which hosted U.S. Rep. Majorie Taylor Greene in 2021, said Milk “is not someone who should be celebrated.”

Judicial Watch Sues Over the FBI Investigation of Parents at School Board Meetings

It is staggering to think that our FBI was sent out to investigate parents at school board meetings. Let that sink in. We did, and we acted.

We filed a Freedom of Information Act (FOIA) suit against the Justice Department for all communications from FBI officials regarding investigations carried out after an October 4, 2021, memo from Attorney General Merrick Garland instructing investigators to target American parents due to an alleged “increase in harassment, intimidation and threats of violence against school board members, teachers and workers in our nation’s public schools” (Judicial Watch v. U.S. Department of Justice (No. 1:23-cv-01856)).

Judicial Watch’s legal team is following up on the controversial memo by Garland instructing federal law enforcement to “open dedicated lines of communication for threat reporting, assessment, and response” on possible criminal threats to local school board members over politically charged issues such as Critical Race Theory and other extremism.

Another group likely to be of interest to the FBI is, Turning Point USA, a conservative organization that educates and organizes students. It initiated a project to report indoctrination of school children, “school board watchlist.”

In testimony before the House Judiciary Committee on October 21, 2021, Garland said that he based his memo off of a letter from the National School Board Association (NSBA) (formerly available on its website, now available here) that labeled parents as “domestic terrorists.” The National School Boards Association later issued an apology for the letter. In November 2021, Republicans on the House Judiciary Committee questioned the completeness of Garland’s testimony.

The House committee report concluded that Biden administration officials “colluded” with school board association leaders “to create a justification to use federal law-enforcement and counterterrorism resources against parents.”

The Biden administration sicced the FBI on political opponents – parents who objected to left-wing and sex propaganda being forced on children at schools. The American people deserve to know the full details of how and why their government surveilled Americans accused of being “domestic terrorists” simply for exercising their First Amendment rights to protect their children at school board meetings.

Next Trump indictment could drop as soon as this week
Mr Trump could face more charges against him as soon as Thursday or Friday

Prosecutors could ask a grand jury to return an indictment against Donald Trump relating to the January 6 attack on the US Capitol and his efforts to overturn the 2020 presidential election as soon as this week, The Independent has learned.

A source familiar with the special counsel’s probe and Department of Justice operating procedures told The Independent that the earliest an indictment could be handed down is late Thursday or Friday, after the deadline prosecutors set for Mr Trump to avail himself of their invitation to testify before the grand jury investigating crimes relating to the Capitol attack.

On Tuesday, the twice-impeached, already twice-indicted ex-president, who currently faces federal charges stemming from his alleged unlawful retention of national defence information and obstruction of justice as well as a separate set of felony charges in New

York City, took to his Truth Social website to claim that he has received a so-called “target letter” from Jack Smith, the Department of Justice special counsel tasked with supervising multiple criminal probes into his conduct.
