Oil prices surged Thursday after US President Donald Trump ramped up geopolitical tensions with threats of a military strike on Iran, while safe-haven gold soared to a fresh record near \$5,600.

“With the Middle East tinder box looking set to ignite again, oil prices have moved sharply higher, lifting shares in listed energy giants,” said Susannah Streeter, chief investment strategist at Wealth Club.

Stock markets mostly rose in Asia and Europe as investors also pored over company earnings and the US Federal Reserve’s latest policy update.

London’s FTSE index hit a record in afternoon trading, driven by surging mining shares.

Frankfurt slid almost one percent, however, dragged down by German software giant SAP.

Its share price tumbled nearly 15 percent after the company warned it would see a slowdown in new cloud computing contracts, a key metric for analysts, this year after missing targets last year.

Gold eased after hitting a new record at \$5,595.47 an ounce as investors rushed to assets deemed safe, including silver, which reached its own record of \$120.44 an ounce.

Demand for the precious metals is also being spurred by worries about the weakening dollar, sparked by speculation that Trump is happy to see the world's reserve currency weaken despite the potential risk of pushing up US inflation.

Gold is skyrocketing in early 2026 due to intense safe-haven demand amid heightened geopolitical tensions (e.g., in the Middle East and Ukraine), record central bank purchases, and concerns over U.S. debt and currency debasement. With prices exceeding \$5,000 per ounce, this rally is further driven by expected interest rate cuts and a weaker U.S. dollar.

Central Bank Buying: Major central banks, particularly in emerging markets, are acquiring massive amounts of gold to diversify reserves away from the U.S. dollar, notes

Geopolitical Instability: Conflicts and sanctions (e.g., against Russia) have driven investors to seek safe-haven assets that cannot be frozen or devalued, says Bloomberg.com.

Economic & Policy Uncertainty: Fears over rising U.S. debt (>\$38 trillion), potential inflation, and the independence of the Federal Reserve are fueling the move into hard assets, according to GoldSilver and this

Lower Rates & Weaker Dollar: Expectations of further interest rate cuts by the Federal Reserve decrease the opportunity cost of holding non-yielding gold, notes

Davos Chickens Come Home to Roost

Davos elites' relevance may not quite be at an end, but it's hard to imagine it ever regaining the reputation or status it once had.

The World Economic Forum, an annual gathering of global elites in Davos, Switzerland, has just concluded. Past meetings have not been without their share of controversy and dissension. But this year's forum may devolve into chaos. Last week, at a dinner of many current and former heads of state as well as top CEOs, Secretary of Commerce Howard Lutnick delivered scathing criticism of European economic and social policy. His remarks were so impolitic that high-profile figures, such as European Central Bank president Christine Lagarde, walked out in protest and the host of the dinner, none other than Larry Fink of Blackrock, ended the dinner before dessert.

Then Trump spoke on Wednesday. And while he assured the Europeans that he would not take Greenland by force, he continued to insist that the US would acquire it. The rest of his speech focused on tariffs and his various "economic achievements." On tariffs, at least, Trump has been remarkably consistent. He loves them. They are the perfect policy: negotiating tool, revenue generator, a bone to toss to workers and domestic firms, a lever of power, and a leveler of economic fairness.

Lutnick and Trump are not your ordinary Davos attendees. They refuse to play nice or kowtow to globalist sentiment. They are not on the net-zero green energy bandwagon. They believe in national power. They emphasize building and growing rather than regulating. In short, they are anathema to the Davos orthodoxy. So why are they there?

Perhaps they hope to extend US influence. Afterall, why destroy Davos when you can take it over? When you think about it, Lutnick and Trump are part of the global elite – wealthy businessmen looking to cut a deal and line their pockets. This is their crowd and their kind of machine. If they can turn the event to their own purposes, they will certainly try.

A more likely story, though, is that they came to Davos intending to cut the Europeans down to size. They certainly don't respect the Europeans. And not entirely without reason. What should they respect? Their woke ideology? Their oppressive regulatory regime? Their underwhelming economic growth? Their military prowess? In the President and the Secretary's eyes, the Europeans warrant little praise and much blame.

Then again, the European elite have brought this upon themselves. They began the Environmental, Social, Governance (ESG) crusade several decades ago. They have aspired, often successfully, to be the puppet masters of the global economy. They have foisted costly, sometimes disastrous, net-zero and clean energy goals. They have also pushed identity politics on the rest of the world through Diversity, Equity, and Inclusion (DEI) initiatives and requirements.

People in western democracies have become restless under the administrative boot of these Davos elites. They are unhappy about uncontrolled immigration and the swift demographic changes in their cities. They don't want to be censored by politically correct regulators. They don't want to pay higher prices for food, energy, and transportation. They live in a maze of red tape; and every year is worse than the one before.

As a result, right-wing political parties across Europe have been surging. In Italy, Giorgia Meloni has been the right-of-center Prime Minister for over three years. In France, the right-of-center National Rally party won the largest share of the popular

vote in 2024. In Germany, the far-right AfD party won just over 20 percent of the national vote.

Bill Gates has warned investors that not every company riding the artificial intelligence (AI) wave will succeed. Speaking at the World Economic Forum in Davos, the Microsoft co-founder said some AI-focused firms may struggle to justify their high valuations and could see their stock prices fall. His comments come at a time when global investors are pouring billions of dollars into AI infrastructure and related businesses, pushing several companies to record market values. Gates also cautioned that the effects of AI on jobs will arrive sooner than many governments expect, adding to economic and social pressure.

Church leaders in Israel condemn Christian Zionism as a ‘damaging ideology’

The leaders of the major Roman Catholic, Eastern Catholic, Orthodox, and other churches in the region issue a condemnation of Christian Zionism, which they call one of the “damaging ideologies” being pushed in Israel that “mislead the public, sow confusion, and harm the unity of our flock.”

“These undertakings have found favor among certain political actors in Israel and beyond who seek to push a political agenda which may harm the Christian presence in the Holy Land and the wider Middle East,” say the Patriarchs and Heads of Churches in the Holy Land, who also emphasize their concern that Christian Zionists “have been welcomed at official levels both locally and internationally.”

The Church leaders insist that “they alone represent the Churches and their flock in matters pertaining to Christian religious, communal, and pastoral life in the Holy Land.”

Nick Fuentes, Andrew Tate and other right-wing influencers filmed singing Ye’s ‘Heil Hitler’ at Miami nightclub

The nightclub, Vendome, has apologized for the incident.

A Miami nightclub has apologized and says it fired multiple workers after a large group of far-right influencers, including Nick Fuentes and Andrew Tate, were filmed singing along to Ye’s “Heil Hitler” there on Saturday night.

The footage circulated over the weekend, igniting criticism of Vendome, a Miami Beach hotspot, for hosting the figures who have praised Adolf Hitler, applauded Hamas leaders and promoted Holocaust denial.

In addition to Fuentes and Tate, who moved to Florida last year after being allowed to leave Romania under apparent pressure from the Trump administration, the figures included Tate’s brother Tristan, Sneako, Myron Gaines, Clavicular and Justin Waller. They arrived together and some were also filmed making Nazi salutes, according to clips that circulated widely on social media, including from footage uploaded by Sneako.

Ye's song, released last year, is not available on most U.S. streaming platforms and has been banned in other countries because of its message. The song also includes an excerpt of a speech by the Nazi leader.

Ye apologizes for antisemitism in full-page Wall Street Journal advert

Kanye West, now known as Ye, placed an ad in The Wall Street Journal apologizing to "Those I Hurt" for his past behavior, including his use of Nazi symbolism. He attributes some of his actions to undiagnosed frontal-lobe damage from a car crash 25 years ago and his subsequent mental health struggles.

Ye states, "I lost touch with reality. Things got worse the longer I ignored the problem." He insists, "I am not a Nazi or an antisemite. I love Jewish people," while also addressing the Black community, expressing regret for disappointing them.

He seeks patience and understanding as he works on personal growth and change.

Tucker goes all in.

Palestinian Authority Promised Terrorists More Than \$200 Million in 'Pay-To-Slay' Payments After it 'Scrapped' Program, State Department Tells Congress

The State Department formally determined this month that the Palestinian Authority paid more than \$200 million to terrorists and their families in 2025, the same year PA president Mahmoud Abbas claimed he ended the "pay-to-slay" program, according to a nonpublic notice provided to Congress and obtained exclusively by the Washington Free Beacon.

Rather than ending these payments, the PA shifted to a new system that it hoped to hide from international donors at a time when the Ramallah-based government is jockeying for a role in postwar Gaza, the State Department disclosed for the first time. Israeli intelligence assessed that the PA funneled \$144 million to terrorists and their families in 2024 and committed at least \$214 million through 2025, while the State Department determined that the payments continued from March to August 2025 under a purportedly reformed welfare system.

Trump says U.S. used secret 'discombobulator' on Venezuelan equipment during Maduro raid

President Donald Trump said the U.S. used a secret weapon he called "The Discombobulator" to disable Venezuelan equipment when the U.S. captured Nicolás Maduro. Trump also renewed his threat to conduct military strikes on land against drug cartels, including in Mexico.

Trump made the comments in an interview Friday with the New York Post.

The Republican president was commenting on reports that the U.S. had a pulsed energy weapon and said, "The Discombobulator. I'm not allowed to talk about it."
