Gay 'Church' Finder Reveals America's Confusion About What Defines A Church

More than 6,000 United Methodist churches have left the denomination as of July 6 due to the UMC's stance on ordaining gay-identifying clergy. As the biblical role of LGBT-identifying people in the church continues to fracture protestant denominations, a website called GayChurch.org promotes churches solely on the basis of LGBT inclusion.

GayChurch.org provides a directory to help LGBT-identifying Americans locate "gay-affirming" churches near them. While the church finders offered by the Gospel Coalition or 9 Marks seek to connect Christians with gospel-believing churches, this one identifies churches that "do not view homosexuality in and of itself as a sin."

The website, run by a small volunteer organization called "God's Agape Love (put) Into Practice," holds that "affirming" congregations will ordain LGBT-identifying people to ministry and perform same-sex marriages. The "church" finder limits its scope to "Christian" churches, defining "Christian" using the words of the Nicene Creed.

The "Affirming Church Directory" raises an important theological question. What makes a church a church? Is the purpose of a church to affirm its members' lifestyles without questioning if it's biblical, as GayChurch.org seems to think?

Catholic couple alleges state denied them foster parenting chance over religious beliefs  
A Massachusetts couple alleged the commonwealth denied them the opportunity to foster or adopt children into their family due to their religious beliefs.

Becket, a Washington-based religious liberty law firm, said Aug. 8 it is representing Mike and Kitty Burke, prospective foster and adoptive parents who said they are Catholic and were allegedly denied the ability to participate in the program due to their religious beliefs about marriage, sexuality, and gender.

Mike Burke is an Iraq war veteran, Becket's statement said, while Kitty Burke is a former paraprofessional for children with special needs; the couple run a business and perform music for Mass. They said they began applying to become foster and eventually adoptive parents, but claim the state disqualified them over their religious views.

"After months of interviews and training, and after years of heartbreak, we were on the verge of finally becoming parents," the couple said in a joint statement. "We were absolutely devastated to learn that Massachusetts would rather children sleep in the hallways of hospitals than let us welcome children in need into our home."

Rep. Matt Gaetz Introducing 'National Prayer in School Act' to Defend Religious Freedom

Republican Florida Rep. Matt Gaetz is introducing legislation called the "National Prayer in School Act" to ensure that students and staff can pray in schools without consequences.

The bill is intended to support a ruling from the Supreme Court in 2022 that defended religious freedom in the case of a football coach fired by the school district for praying before games.

The court had ruled, “nothing in the Constitution . . . prohibits any public school student from voluntarily praying at any time before, during, or after the school day.”

“God’s reach does not stop at the schoolhouse gates. Our country’s education policy forbids students and faculty from praying while endlessly promoting degenerate LGBT and anti-White propaganda,” Gaetz told the Daily Caller, which obtained an advance copy of the bill.

“My legislation unlocks religious freedom once again so that in every classroom in America, there will be time for students to pray if they choose,” Gaetz continued.

Texas school district offers free shuttle to raunchy LGBTQ parade, encourages students to wear 'Pride costumes'

A school district in a liberal area of Texas wants its students to attend a sexually charged LGBTQ parade so much that it is offering a free shuttle service to students, staff, and their families to make the experience easier.

This Saturday, Austin Pride will once again host the city's annual Pride festival and parade. This year, the theme is "Keep Austin Queer'd." "From attacks on our Drag community to the fight for trans rights... sometimes it feels that our community is getting pushed from all sides," the organization's website said. "When that happens, WE STAND OUR GROUND! And no matter what, one thing is for certain. We will KEEP AUSTIN QUEER'D!"

Both Pride events are open to people of all ages, and children 6 and under get in the festival free. "Drag Queen Story Time" is listed on the festival's itinerary as well as carnival rides and games. Last year, drag performers Deborah Cox, Fishy Queen Jezebel, Hermajestie the Hung, and Babiboi all appeared on stage. A promotional video for the festival demanded listeners to get the "f\*\*\* out my way [when] you see me/ I'm gonna put the LGBT."

The Austin Independent School District is so anxious to help young students attend that it is offering a free shuttle service to and from the parade. "Staff, students and their families are invited to represent Austin ISD in the annual Austin Pride Parade," a district

website said. "We are #AISDproud to celebrate our LGBTQIA+ students, staff and families and to highlight our commitment to creating a safe, supportive and inclusive environment for all!"

Bombshell new FBI memo shows agency used multiple offices to spy on Traditional Catholics

New documents obtained by Rep. Jim Jordan show that an undercover FBI employee reported on a subject who attended an ‘SSPX-affiliated’ church in California. The documents also show that FBI offices in Los Angeles and Portland were involved in the creation of the FBI’s memo that described Traditional Catholics as potential domestic terrorists.

House Judiciary Committee Chairman Jim Jordan (R-Ohio) released a letter addressed to Wray earlier today announcing that documents he obtained from the FBI last month indicate that its field office in Richmond, Virginia, coordinated with two other offices across the country to spy on Traditional Catholics.

“On July 25, 2023, the FBI produced a version of the Richmond document with fewer redactions than the two previous versions it had produced,” Jordan’s letter begins. “This new version shows that the FBI’s actions were not just limited to ‘a single field office,’ as you testified to the Committee. The document cited reporting from an ‘FBI Portland liaison contact with indirect access’ who informed on a ‘deceased [Racially or Ethnically Motivated Violent Extremist (RMVE)] subject’ who had ‘sought out a mainline Roman Catholic community’ and then ‘gravitated to [Society of Saint Pius X (SSPX)].”

Pentagon ‘whistleblower’ claims Vatican helped US retrieve UFO from Benito Mussolini

The Pentagon “whistleblower” who claimed the US has collected alien UFOs over the years said America retrieved one such saucer from World War II Italian dictator Benito Mussolini after getting a tip from Pope Pius XII.

David Grusch, 36, an Air Force veteran and former intelligence official, claimed the “Vatican was involved” in the first-ever mission of America’s alleged top-secret UFO retrieval program.

Grusch, however, did not provide any evidence for these claims.

“1933 was the first recovery in Europe, in Magenta, Italy,” he told NewsNation Sunday. “They recovered a partially intact vehicle, and the Italian government moved it to a secure airbase in Italy until around 1944-1945”

The Pope back-channeled that and told the Americans what the Italians had and we ended up scooping it,” Grusch said of the alleged post-war mission.

King Charles is under pressure to call on the British government to release information about UFOs

### Peruvian Villagers Claim They Were Attacked By "Predator-Style Aliens"

Peruvian villagers claimed to have been attacked by "Predator-style aliens," The U.S. Sun reports.

Members of the Ikitu indigenous people in rural Alto Nanay claimed to have seen the beast after it attacked a 15-year-old girl. The native people alleged that the mysterious creature "slashed" her across the neck, which required heavy medical attention. Hunters from the tribe claimed to have "fired" at the armored beings. However, they soon discovered that the creatures are "immune to human weapons."

The native people reportedly saw one of the seven-foot beasts disappear and reemerge on the spot. The Ikitu people have detailed that they may be aliens from another planet, while other citizens believe the creatures to be folklore monsters. The outlet reports that the "Predators" could be "drones covered with cloth and masks to scare the locals by illegal miners in a Scooby Doo-style scheme."

"These gentlemen are aliens. They seem armored like the Green Goblin from Spider-Man. I have shot him twice, and he does not fall, but rises and disappears. We are frightened by what is happening in the community," said the community leader.

"Their color is silver, their shoes are round in shape, and with that, they rise up. They float one meter high and have a red light on the heel. Their heads are long... and their eyes are yellowish. With that, they see you well, and they leave. They are experts at escaping."

Another witness to the action detailed that the beasts conceal their identities and can fly.

“They don’t let their faces be seen and their body is floating. They use their arms as balance (when flying), but they walk normally. Every time we arrive, they fly with an activation of something on the soles of their feet. They have wheels with lights,” he told the troops.

'Almost everything is ready for the Third Temple,' claims Israeli TV report about red heifers brought to Israel last year

Arrival of five red heifers continues to cause excitement and consternation in the Jewish state

Israel's TV Channel 12 news released an investigative report about the five red heifers that were brought to the Jewish state last September and the supposed “funneling” of government funds to construct the Third Temple.

Israeli journalist Omri Maniv, who has posted to social media multiple times about the red heifers and their meaning, conducted the investigation.

Last month, the journalist tweeted about an experiment conducted by Bar Ilan University Prof. Zohar Amar who attempted to determine how many people could be ritually purified by one red heifer.

In the study, Prof. Amar said that one red heifer would provide enough ashes to purify 660 billion purifications.

Maniv argued that the government has shifted funds from other accounts for the purpose of preparing for the purification rituals and possibly the Third Temple. Many rabbis have forbidden their followers from going up to the Temple Mount because they are not in a state of ritual purity.

He also argues that the funds are being shifted quietly to not raise tensions internally and with the Arab population.



Just two weeks ago, near the site of the biblical Shiloh, where the Tabernacle was kept during the time of the judges, a group of Jews descended from the tribe of Levi and the priestly families, enacted a practice run of the purification ceremony.

The event occurred at a site called “Ancient Shiloh” affiliated with the Temple Institute, and contained explanations of the priestly functions, including sacrifice. The event also featured a “Temple banquet” containing foods from the Second Temple and biblical periods.

The highlight of the event was the presentation of one of the five red heifers.

“We are yearning for the Temple, and suddenly there is a red heifer here, and we understand what that means...something is about to happen,” stated Kobi Mamo, CEO of Ancient Shiloh.

According to the Book of Numbers, the Tabernacle and the Temple were purified with the ashes of a red heifer.

The Torah commands that a red heifer be without spot or blemish, and never have worn a yoke. Rabbinic law gives several additional stipulations to the requirements of the red heifer, or calf, such as being at least two years of age and having no white hairs.

The oldest of the red heifers brought from Texas last year is just months away from being the required age to sacrifice for the purification ritual.

The use of red heifers for purification has caused consternation for some Palestinians as well as secular Jews.

California Set To Criminalize Passionate Parents At School Board Meetings

Don't even think about going to a school board meeting to question narrative or policies

The California Legislature is moving a bill through the legislative process that could very well criminalize passionate parents that speak up at school board meetings. Indeed, the law could apply to any passionate community partner who dares to voice a contrary

opinion to the powers that be. The bill is “SB 596 School Employees: Protection,” and was last seen in the Assembly’s Public Safety Committee on July 11. It passed with a 6-0 vote.

SB 596 would expand the code to include causing “substantial disorder” at any meeting of school boards, charter school boards, county boards of education, and even the State Board of Education itself. The bill also expands the definition of “school employee” to any official or employees of those boards, and their families

The bill does not provide a definition for “substantial disorder.” However, the bill does define “harassment,” or rather redefines it. Gone is the definition from the penal code which describes harassment as “following,” “stalking,” or making harassing phone calls or correspondence to an individual. In it is “a pattern of conduct composed of two or more acts...evidencing a continuity of purpose.”

Woman at Center of Supreme Court Case Describes Death Threats, Harassment, ‘Doxxing’

United States Supreme Court cases have become fraught with peril for those who differ from leftist ideology: Litigants face potential death threats, protesting, harassment, and “doxing” (putting their personal information, even their addresses, online to encourage harassment). Justices have faced the same—including at least one attempted assassination.

Following the leak of the draft Supreme Court opinion indicating Roe v. Wade would soon be overturned, Catholic churches and pro-life pregnancy centers faced an onslaught of violent pro-abortion attacks.

Justice Brett Kavanaugh’s family discovered that in the middle of the night, authorities had arrested a man just steps from their home—26-year-old Nicholas John Roske, who had traveled from California to Maryland with the express intent of killing Kavanaugh and two other justices.
