'Evangelicals For Harris' - What You Need To Know

A newly-minted political group hosted a recent "Zoom-style rally," as MSNBC put it, touting evangelical support for Harris. "Evangelicals for Harris has sought to offer a counter-narrative to evangelicals' overwhelming support for Trump," proclaimed The Tennessean, a progressive paper in Nashville.

Is this true? Here are a few facts to know about "Evangelicals for Harris."

The Evangelicals for Harris call attracted modest participation, but scant evidence of a growing movement.

A pledge on the Evangelicals for Harris website to support the Harris-Walz ticket in 2024 has already received over 200,000 signatures. The organization claimed on X that "over 200,000 evangelicals joined an effort called 'Evangelicals for Biden'" in 2020, and "that same group is growing and is throwing its support behind @KamalaHarris."

However, this evidence does not show that a growing number of evangelicals are throwing their support behind Vice President Kamala Harris. So far, the evidence shows that a group of approximately 200,000 evangelicals support Democratic nominees for president, whether President Joe Biden in 2020 or Harris in 2024.

The Evangelicals for Harris event featured 18 speakers plus a moderator, with significant diversity among the participants.

Moderator Ekemini Uwan set the overall tone. At a Christian conference in 2019, Uwan declared, "Whiteness is wicked. It is wicked. It's rooted in violence. It's rooted in theft. It's rooted in plunder. It's rooted in power, in privilege." She has called for defunding the police, reparations, a path to citizenship for illegal immigrants, and an end to the Electoral College, according to Fox News.

When asked about these past comments, Uwan responded that she "told the truth about the wickedness of whiteness." She explained, "I preached the gospel and told them there is grace and that the blood covers. I am an anti-racist Public Theologian. I hold up a mirror, make people face the racist reflection staring back at them, and give them hope found in the gospel of Jesus Christ."

Other speakers are known for previous progressive activism within evangelical churches. Among many, Burk highlights Bishop Claude Alexander, chairman of the board of directors at Christianity Today, Rev. Dwight McKissic, "a well-known activist for women pastors within the Southern Baptist Convention," and Jemar Tisby, an anti-racist author and former assistant director at Ibram X. Kendi's Center for Antiracist Research.

Some speakers appear to focus their political engagement on fighting anti-Asian racism. This includes Russell Jeung, Soong-Chan Rah, and Raymond Chang.

Other speakers are not in pastoral ministry, such as Billy Graham's granddaughter, Jerushah Duford, an "LGBTQ+ friendly" therapist. Another speaker was Christian rapper Derek Minor, whose up-and-down faith journey "doesn't fit the mold anymore."

Some speakers did not even seem to fit the standard definition of evangelical. Matt Tebbe is a priest in the Episcopal Church -- by definition a mainline denomination, as distinct from an evangelical one. Lee Scott, of the Coalition for Christian Outreach is ordained as a minister in the Presbyterian Church, U.S.A., another mainline denomination.

The hodgepodge of speakers provides an answer to readers who may be wondering how an "Evangelicals for Harris" group could even form in the first place. How could Bible-believing Christians, who submit their lives to the word of God, support one of the most pro-abortion, pro-LGBT politicians of our time? The answer is that there isn't one answer, but many.

Bureau of Labor Statistics revises numbers.

The Biden-Harris administration's Department of Labor overstated job gains by 818,000 and was forced to revise down the total in its preliminary annual benchmark review.

The DOL previously estimated that the economy would create approximately 242,000 jobs per month. However, a tally of payroll data from April 2023 through March 2024 revealed that only 174,000 jobs were added monthly.

Nearly half of the downward revisions were for the professional and business services sector — a decrease of 358,000 jobs. The DOL also overestimated leisure and hospitality by 150,000, retail trade by 129,000, and manufacturing by 115,000.

The administration's nearly -30% revision of the job numbers marks the most considerable overestimation since 2009. However, the final figures will not be reported until February 2025.

#### Faith Leaders Meet at White House for Climate Goals

The White House hosted more than a dozen faith leaders Tuesday (Aug. 13) to discuss President Joe Biden's climate-related goals and how faith-based organizations can benefit from and support the administration's climate agenda as the presidential election approaches.

One of the meeting's top priorities was to explain how faith communities can better utilize federal funds for clean energy initiatives.

Houses of worship are eligible to use Direct Pay, a provision through the Inflation Reduction Act that helps tax-exempt entities benefit from federal clean energy tax incentives by issuing payments equal in value to tax credits. The system is meant to encourage nonprofits and other entities to proactively build clean energy projects. Religious leaders in attendance from across the country shared stories of the different ways their congregations have used Direct Pay, from increasing energy efficiency to preparing for natural disasters.

"The main thrust of the whole meeting was to help us religious leaders understand the initiatives well enough to go back to our various communities and share how they can get on board," explained the Rev. Betty Holley, a presiding elder in the African Methodist Episcopal Church in the Ohio Conference and professor of environmental ethics at Payne Theological Seminary.

Holley said the event aimed to help faith communities "be good stewards of what God has given us."

"After the meeting, I was ready to go out with a sign saying 'follow me to clean energy!" she said.

Environmental technology and clean energy organizations also presented at the event to highlight collaborations with faith-based partners and seek more.

"We're looking toward sustainability. How can we sustain ourselves on earth?" she said. "You know, we all have but one home and one future, and we need to be able to get on board now, before we are forced to do this."

Cook County State's Attorney Declares that DNC Rioters Will Not be Prosecuted

Cook County State's Attorney Kim Foxx announced on Sunday that none of the rioters who are attempting to disrupt the Democratic National Convention (DNC) will be charged.

As reported by Breitbart, Foxx made the announcement preemptively, ahead of the start of the DNC on August 19. Foxx declared that she considered the rioters to be "peaceful," and further stated that her office will not prosecute even the unruly rioters who commit misdemeanors, including disorderly conduct, unlawful gathering, criminal trespass, and curfew charges.

"Whether it's the O'Hare 40, or the educators at Northwestern, or the students at the Art Institute. We are consistent. We don't prosecute these cases," said Foxx. "So this is not a policy that has been stagnant since 2020. It's certainly a policy that we will continue to take into the DNC."

Foxx is one of several far-left attorneys who was backed by billionaire George Soros to run for prosecutors of major counties and other jurisdictions across the United States, with State's Attorney being Cook County's equivalent of a District Attorney. One of Soros' super PACs donated \$408,000 to her first campaign in 2016.

Michigan Jury Finds Seven Pro-Lifers Guilty Of FACE Act Violations For Preventing Baby Deaths

The Department of Justice (DOJ) continues to hound pro-life activists who go to abortion businesses and try to convince pregnant women not to kill their babies.

A Detroit, Michigan, jury found seven pro-lifers guilty Tuesday of engaging in a civil rights conspiracy and violating the Freedom of Access to Clinic Entrances (FACE) Act for standing and sitting in front of the door of the Northland Family Planning Clinic in Sterling Heights, Michigan, Aug. 27, 2020.

The convicted include Calvin Zastrow, a Michigan preacher, and his daughter Eva Zastrow, 26, a missionary worker; and Chester Gallagher of Tennessee, a former police officer who left his job and joined the pro-life movement when he realized they were trying to stop a "murder in progress," as he often says.

"Yet again, the Biden-Harris Department of Justice has decided to characterize the actions of peaceful pro-lifers as a felony 'Conspiracy Against Rights,' punishable by over a decade in federal prison. After the overturning of Roe v. Wade, we believe the FACE Act to be unconstitutional, and we will continue to advocate on behalf of peaceful pro-life citizens like Chet Gallagher, Lauren Handy, and Paul Vaughn, who have been targeted with harsh prosecution by this Department of Justice," Thomas More Society Senior Counsel Steve Crampton said in a statement. "We also believe that the U.S. Supreme Court's recent decision in Fischer v. United States confirms that the Department of Justice's novel strategy to inflict maximize pain upon peaceful pro-lifers by adding a charge of felony Conspiracy Against Rights cannot be squared with the law and we stand ready to make that case."

Also found guilty were Justin Phillips, a missionary, and Joel Curry, 31, an evangelist, both of Michigan.

Heather Idoni, 59, a mother of 15, including 10 adopted from Ukraine, was also found guilty. Idoni, a former Christian bookstore owner, is currently held in federal prison for a previous FACE Act conviction in Washington, D.C.

Also convicted was Eva Edl, 89, of South Carolina.

Both Edl and Idoni believe they may die before being released from prison. If they are sentenced to the full 11 years, Edl would be 100 at the end of the sentence. These two have another FACE violation for blocking a door at a Saginaw, Michigan, abortion mill on April 16, 2021.

As a child, Edl was taken by train cattle car as a prisoner to the Gakova concentration camp in Yugoslavia, where she faced starvation and was surrounded by death, but ultimately was able to escape.

Former Colorado clerk Tina Peters, one-time hero to election deniers, convicted in computer breach

Former Colorado clerk Tina Peters, the first local election official to be charged with a security breach after the 2020 election as unfounded conspiracy theories swirled, was found guilty by a jury on most charges Monday.

Peters, a one-time hero to election deniers, was accused of using someone else's security badge to give an expert affiliated with My Pillow chief executive Mike Lindell access to the Mesa County election system and deceiving other officials about that person's identity.

Lindell is a prominent promoter of false claims that voting machines were manipulated to steal the election from Donald Trump. His online broadcasting site has been showing a livestream of Peters' trial and sending out daily email updates, sometimes asking for prayers for Peters and including statements from her.

Prosecutors said Peters was seeking fame and became "fixated" on voting problems after becoming involved with those who had questioned the accuracy of the 2020 presidential election results.

The Gateway Pundit's Brian Lupo attended the trial and will post an update on Tuesday.

Tina Peters is the Election Clerk from Mesa County, Colorado. She made a copy of her machines' information before performing the action requested by Griswald, who demanded that all voting machines's election data should be erased (which is against the law) after the 2020 election.

Ms. Peters was attacked for her actions.

Mesa County District launched a criminal investigation against Peters for allegedly posting election system passwords on the internet.

Peters maintains she had nothing to do with the crime she is accused and is being targeted for documenting election fraud in her county.

"We have a secretary of state that is drunk with power. She makes emergency decrees and when we query her – she refuses to answer in violation of the state law," she told the crowd during Mike Lindell's symposium. "When I started having citizens come to me and tell me that something didn't' seem right in our local city elections from years ago to our 2020 election I said if there is a there we will do something about it. I am a Republican — I am a conservative and she's not and she weaponizes her position to attack people who disagree with her.

"I've been persecuted. They are trying to take over our election office. We are the last bastion of freedom in Colorado," the Mesa County. "We have listened to people. They send me things from all over and there are some discrepancies there that I cannot deny or unsee."

The FBI raided her home instead of investigating her claims.

"The FBI raided my home at 6 a.m. this morning, accusing me of committing a crime. And they raided the homes of my friends, mostly older women. I was terrified," "Peters said on the Lindell channel, adding the FBI "used a battering ram" to destroy the front door of one of her friends' homes, according to Colorado Politics.

"Essentially, they were soldiers in combat gear. They were not men in suits with badges," Peters said. "They looked very much like they were in a combat zone — soldiers with automatic weapons and combat gear."

In February 2022, Peters was interrupted at a local restaurant by police and arrested on some garbage charges.

On Monday, Peters was convicted on three counts of attempting to influence a public servant and one count of conspiracy to commit criminal impersonation. Additionally, she faced convictions for first-degree official misconduct, violation of duty, and failure to comply with an order from the Secretary of State—each a misdemeanor, according to CPR News.

The jury found Peters not guilty on three charges: criminal impersonation, conspiracy to commit criminal impersonation, and identity theft.

Peters' defense team argued that her actions were within her authority as she sought to preserve what she believed were critical election records. Defense attorney John Case contended that there was no wrongdoing in copying hard drives, claiming that state officials intended to erase vital information during their updates.

Her sentencing is scheduled for October 3rd.

According to Law Professor David Clements, "The judge refused nearly all of her witnesses and excluded virtually all of her defenses."

US pharmaceutical companies ran drug trials with Chinese military for more than a decade, House committee reveals

US biopharmaceutical companies have been running drug trials with the Chinese military for more than a decade, a House committee shockingly revealed in a Monday letter to the Food and Drug Administration.

Republican and Democratic leaders of the House Select Committee on the Chinese Communist Party wrote to FDA Commissioner Robert Califf, demanding information about the clinical trials for new drugs.

"These collaborative research activities raise serious concerns that critical Intellectual Property is at risk of being transferred to the [Chinese military] or being co-opted under the People's Republic of China's National Security Law," said Chairman John Moolenaar (R-Mich.), Ranking Member Raja Krishnamoorthi (D-Ill.), Rep. Neal Dunn (R-Fla.) and Rep. Anna Eshoo (D-Calif.).

Conversely, there are also concerns with the trustworthiness of clinical trial data produced overseas from [People's Liberation Army] institutions," the lawmakers added.

Hundreds of the clinical trials have taken place in China at Chinese militaryaffiliated medical centers and hospitals, the letter notes, including one ongoing test for an advanced Alzheimer's treatment.

Those include the PLA's General Hospital and Medical School, the PLA's Air Force Medical University and the Hospital of the PLA, which is operated by the PLA's Academy of Military Medical Sciences (AMMS).

A tornado sank a luxury sailing boat off the coast of Sicily. Here's what we know

emergency workers in southern Italy are still hunting for at least one person who remains missing after a tornado sank a luxury yacht early Monday – prompting an air and naval operation off the coast of Sicily.

Twenty-two people are thought to have been on the yacht when the tragedy struck. Fifteen people were rescued from the wreckage, according to Italy's Coast Guard. One body was recovered on Monday and five more were found on Wednesday, after divers struggled to reach deep inside the yacht around 50 meters underwater (approximately 150 feet).

Two Americans and four Britons were among the six initially reported missing – including British tech tycoon Mike Lynch, Jonathan Bloomer, chairman of Morgan Stanley International, and Chris Morvillo, a prominent lawyer. The five bodies found

Wednesday have not been identified, while the body recovered Monday is thought to be that of the onboard chef Ricardo Thomas.

A small waterspout – a type of tornado – spun over the Mediterranean island early Monday, likely capsizing the sailing boat amid lashings of rain and strong thunderstorms.

The British-flagged yacht, called the "Bayesian," was anchored about a half a mile from the port of Porticello, on Sicily's northern coast. The vessel sank after its mast broke in half in the storm, Salvatore Cocina, head of Sicily's Civil Protection, told CNN on Tuesday.

Eyewitnesses described furious gales and hurricane-like winds that left an avalanche of debris near the pier.

More than a dozen survivors were spotted in the area hanging onto life rafts, according to the captain of a nearby boat, who steadied his ship to avoid colliding with the Bayesian.

"We got this strong hurricane gust and we had to start the engine to keep the ship in an angled position," Karsten Bower told reporters in Palermo on Monday. "After the storm was over, we noticed that the ship behind us was gone."

Weather Warfare: Weapons of the Future

Amid climate concerns, states are now devising ways to change and control the weather. However, this initiative could tempt global powers into using weather to gain military advantage. Muhammad Sajjad and Saba Kiran review international frameworks and several studies to demonstrate how weather modification technology can be used in future wars.

Since conflict is impacted by geopolitics, social, technological, financial, environmental, and military advancements, its future cannot be predicted. When we consider warfare, we're often prepared for the most recent conflict, use archaic military metaphors, or focus on historically effective combat tactics that are now or

soon will be obsolete. The picture of international security is fast changing (Dennis, 2008).

Modern weather manipulation (WM) was developed by Langmuir and Schaefer in 1948 (Schaefer, 1953) by utilising dry ice pellets to make holes in supercooled stratus via snow-out. This experiment provided compelling visual proof that seeding is beneficial, which encouraged more rain augmentation and hail avoidance initiatives all around the world.

Dr. Irving Langmuir, winner of the Nobel Prize in physics, and Dr. Vincent J. Schaefer worked together on those initial tests for the General Electric Research Laboratory. Langmuir claimed that, under ideal conditions, the energy released by 30 milligrams of silver iodide is equivalent to one atomic bomb, and that "weather control or rainmaking may be as successful as the atomic bomb in combat."

Langmuir stated that "the government should seize weather control phenomena in the same way that it seized atomic energy when Albert Einstein forewarned the late President Roosevelt in 1939 of the potential potency of an atom-splitting weapon." A dangerous cloud formation was seen travelling toward Waco on a meteorological station's radar in 1953, according to Captain Howard T. Orville, leader of the US President's Advisory Committee on Meteorological Control.

The cloud's morphology suggested a tornado may emerge. There were no adverse effects on persons or property from the storm's breakup. Even while it may seem impossible to imagine a tornado being destroyed in its early stages right now, it is extremely possible that it might happen within the next 40 years. Research may reveal ways to not only scatter approaching storms and tornadoes but also drastically affect all of our weather in the age of the H-bomb and supersonic flight.
