The U.N. plan to improve the world by 2030 is failing. Does that make it a failure?

What if you made a self-improvement plan and failed to meet your goals.

Imagine that in a moment of unusual optimism and resolve, you decided that the only way you were ever going to be the healthy, happy and productive person you want to be was by writing down a detailed list of goals and committing to accomplish them in the next 15 years.

Now imagine that eight years later, more than halfway through your 15-year life improvement plan, not only are you way off track when it comes to accomplishing most of what you committed to, but in some cases you've even slid backward. Maybe you faced an unexpected illness. Maybe you suffered a crushing breakup. Maybe you got some bad financial advice. Maybe you just didn't try hard enough.

What would you conclude? Were your goals a waste of time or would you be even worse off today without them? Should you scrap your detailed plan or double down and try to make up for lost time?

That's about where 193 world leaders at the United Nations in New York find themselves this week as they take stock of the sobering state of the Sustainable Development Goals at their halfway point along the road to 2030.

But late Tuesday, at nearly the last minute, eleven countries out of 160 filed a formal opposition to the pending proposal to accelerate Agenda 2030. They complained about "unilateral coercive measures," human rights issues, lack of transparency (secret agendas), and procedural complaints (rushing it through).

Now, take a look at which countries stopped Agenda 2030, the unlikeliest group of countries to which you'd think we'd ever owe a major debt of gratitude:

The Russian Federation, Belarus, Bolivia, Cuba, the Democratic People's Republic of Korea, Eritrea, the Islamic Republic of Iran, Nicaragua, the Syrian Arab Republic, Venezuela, and Zimbabwe.

'Ministry of Truth': Conservatives Warn About Washington State's 'Domestic Terrorism' Effort

Washington's Democratic attorney general released a report late last year urging the state to crack down on domestic terrorism and enlisting an analyst at an organization notorious for putting conservative groups on a "hate map" alongside chapters of the Ku Klux Klan, a map that has inspired at least one act of terrorism.

The attorney general, Bob Ferguson, called on the Washington Legislature to pass a bill launching a commission to study domestic terrorism and urging state action. That bill, HB 1333, stalled in committee earlier this year, but conservative groups in Washington state have raised the alarm that the effort remains a threat to their liberties, and those of anyone else who does not toe the party line.

"As a constitutional lawyer and member of the Washington State Bar Association, I believe this report poses a clear and present danger to the civil rights of those that law enforcement officials deem as holding 'anti-government ideologies' or who communicate 'online disinformation,'" Kevin Snider, chief counsel at a nonprofit law firm, the Pacific Justice Institute, told The Daily Signal in a statement Monday.

"The free speech and press clauses [of the Constitution] rise to their zenith when citizens communicate anti-government sentiments," he noted. "There are numerous laws in place to investigate and prosecute acts of violence. But consider that this report calls for family members to turn in 'someone they suspect may be on the path of radicalization,' government funding of journalists to 'combat misinformation and disinformation,' and recommends the establishment of 'mobile advisory centers' to provide 'advice and guidance on dealing with right-wing extremism."

"There can be little doubt that this report provides the building blocks for a police state," he warned.

HB 1333 "would criminalize certain forms of expression based on what members of a state commission consider to be their definition of 'domestic extremism,'" Washington Policy Center Director Liv Finne warned in a bill analysis earlier this year. "Creating a state-level 'Ministry of Truth' would not only undermine democratic norms, it would have a chilling effect on public debate, freedom of speech, and civic participation in Washington state."

The report faults the U.S. Code definition of "domestic terrorism" because it "fails to capture the full scope of the problem Washington State faces, which encompasses other forms of extremist and political violence; threats, coercion, and intimidation; online disinformation; extremist recruitment and government infiltration efforts; and the general spread of extreme white supremacist, antigovernment, and other ideologies" (emphasis added).

'Future Is Digital' — EU Chief Calls for Global Digital IDs and New U.N. Body to Govern Artificial Intelligence

The world needs international digital ID systems like coronavirus passports and Artificial Intelligence should be regulated by a global body similar to the United Nations' Intergovernmental Panel on Climate Change, European Commission President Ursula von der Leyen said on Sunday.

Speaking before the "One Future" session of the G20 Summit in India, the top Eurocrat declared that the "future will be digital" and therefore more globalist institutions will be needed to set boundaries and regulations.

The German politician, who before ascending to her unelected role as EU Commission President served as Berlin's Defence Minister, said: "Today I want to focus on AI and digital infrastructure. As it has been described, AI has risks but also offers tremendous opportunities. The crucial question is how to harness a rapidly changing technology."

During her speech in India, Ursula von der Leyen went on to argue for the global adoption of "digital public infrastructures" along the lines of the coronavirus passport system the EU developed during the Wuhan virus crisis.

"Many of you are familiar with the COVID-19 digital certificate. The EU developed it for itself. The model was so functional and so trusted that 51 countries on 4 continents adopted it for free."

"Today, the WHO uses it as a global standard to facilitate mobility in times of health threats. I want to thank Dr Tedros again for the excellent cooperation," she added.

The European Union is actively trying to introduce a bloc-wide "digital identity" app that would contain a citizen's passport, driver's licence, credit cards and other personal information.

Leaders of the G20 signed a treaty last week to rollout the WEF's "digital IDs" and "cashless societies" which will be mandatory for all people who wish to participate in society.

Sitharaman said world leaders believe cryptocurrencies cannot be regulated efficiently without total international cooperation.

"India's [G20] presidency has put on the table key issues related to regulating or understanding that there should be a framework for handling issues related to crypto assets," Sitharaman said before the G20 gathering.

The top items discussed at the New Delhi summit included "building Digital Public Infrastructure, Digital Economy, Cryptoassets, [Central Bank Digital Currencies]."

Billionaire entrepreneur Elon Musk's brain-chip startup Neuralink said on Tuesday it has received approval from an independent review board to begin recruitment for the first human trial of its brain implant for paralysis patients.

Those with paralysis due to cervical spinal cord injury or amyotrophic lateral sclerosis may qualify for the study, it said, but did not reveal how many participants would be enrolled in the trial, which will take about six years to complete.

Clorox products in short supply after cyberattack disrupts operations

A cyberattack at Clorox is causing wide-scale disruption of the company's operations, hampering its ability to make its cleaning materials, Clorox said Monday.

Clorox said some of its products are now in short supply as it has struggled to meet consumer demand during the disruption. Clorox didn't specify which of its products are affected.

The company on Monday revealed in a regulatory filing that it detected unauthorized activity in some of its information technology systems in August. Clorox said it immediately took action to stop the attack, including reducing its operations. It now believes the attack has been contained.

Still, Clorox has not been able to get its manufacturing operations back up to full speed. The company said it is fulfilling and processing orders manually. The company doesn't expect to begin the process of returning to normal operations until next week.
