Others included lassa fever, nipah and henipaviral diseases, zift Valley fever, and zika — as well as the unknown pathogen that would cause 'Disease X.'"

China continues experiments with 'lethal' COVID strain; experts raise alarm: 'This madness must be...'

Scientists in China have recently conducted experiments on a novel coronavirus strain, GX_P2V. It resulted in a 100% fatality rate in genetically-modified mice. This

strain is a mutation of GX/2017, a virus initially identified in Malaysian pangolins in 2017.

The study, originating from Beijing, notes the swift and lethal impact of GX_P2V on mice with human-like genetic structures. The virus, targetting multiple organs including the brain, led to rapid deterioration in the mice's condition, culminating in death within eight days.

The mice got very sick quickly. They lost a lot of weight, couldn't move well, and their eyes turned white before they died. This study is different because all the mice died, which is more than what happened in other studies about similar viruses.

This study is separate from the research in Wuhan, which was linked to different ideas about where COVID-19 came from. The origin of COVID-19 is still not known. The new study in China raises questions about doing risky experiments with viruses.

NIH Bankrolled Chinese Scientist Who Mapped SARS-CoV-2 Two Weeks Before China Told World About COVID

A Chinese researcher with ties to China's government and military — and to Dr. Anthony Fauci — mapped the genetic sequence of SARS-CoV-2 and submitted it to a U.S. government database in December 2019, two weeks before the virus' sequence was officially revealed.

The delay may have worsened the severity of the COVID-19 pandemic, some experts said.

The revelations arise from documents the U.S. Department of Health and Human Services (HHS) provided to the U.S. House of Representatives Energy & Commerce Committee last month as part of an ongoing investigation into the origins of COVID-19. The Wall Street Journal (WSJ) first reported the story on Jan. 17.

The researcher, Dr. Lili Ren, is affiliated with the Institute of Pathogen Biology in Beijing which, according to a statement by the committee, has ties to the Chinese Community Party (CCP) and the People's Liberation Army of China.

According to the WSJ, the institute is part of the state-affiliated Chinese Academy of Medical Sciences.

The documents show that Ren was on the payroll of the National Institutes of Health (NIH), the agency overseeing the National Institute of Allergy and Infectious Diseases (NIAID), directed at the time by Fauci.

"The Department of Health and Human Services (HHS) has confirmed that Dr. Ren's December 28, 2019 sequence was nearly identical to the sequence later made public by the China CDC on January 10, 2020, which at the time was the first known sequence," the committee said in its statement.

The documents raise "questions anew about what China knew in the pandemic's crucial early days," the WSJ said.

Amazon Prime rolls out cartoon sympathetic to Lucifer, depicting God's angels as 'heartless'

Amazon Prime prompted backlash on social media for rolling out a trailer for a new animated series that suggests the angels of God are "heartless" while sympathetically portraying demons, Lucifer and his mythological lover Lilith.

"Heaven and hell like you've never seen them before," Amazon Prime tweeted last week. "Here is the opening scene of #HazbinHotel, premiering Friday on Prime Video."

The trailer for "Hazbin Hotel," which depicts heavenly angels as the many-eyed, wheel-like beings in the Book of Ezekiel, describes Lucifer as "a dreamer with fantastical ideas for all of creation."

"But he was seen as a troublemaker by the elders of Heaven, for they felt his way of thinking was dangerous to the order of their world," the opening scene continues, which goes on to reference Lilith.

Lilith is a female demonic figure that features in Jewish folklore, according to the Encyclopedia Brittanica. Her name and personality are believed to have emerged from traditions regarding Mesopotamian demons, and some rabbinic literature depicts Lilith as the mother of Adam's demonic offspring.

Lilith fled the Garden of Eden after refusing to submit to her husband, after which God created Eve, according to the folklore.

Building on this mythology, the opening scene to "Hazbin Hotel" suggests that Lilith and Lucifer fell in love after she fled Eden and that the two were behind the temptation to eat the forbidden fruit because they wished "to share the magic of Free Will with humanity, offering the fruit of knowledge to Adam's new bride Eve, who gladly accepted."

For their act, Lucifer was cast into "the Dark Pit," where he was not allowed to see "the good that came from humanity," though Lilith "thrived, empowering humankind with her voice and her songs," the show continued.

The clip closed by suggesting that Heaven was "threatened" by the growing power of Hell, leading its forces to make the annual "heartless decision" to send an exterminating army "to ensure Hell and sinners could never rise against them."

The show is being organized to celebrate Wildflower Daydreams Boutique's third anniversary and will be hosted by Sacramento drag queen A La Mode.

"There have been false claims that this a drag show targeted at children. There have been claims that we're raising funds for ANTIFA," said owner Michelle Honath Tuesday. "It is a fashion show targeted towards adults."

Honath said that while A La Mode will give a performance, the focus of the event is a celebration of the business and that the event will be family-friendly for those who choose to bring their children.

"My goal was to make this event inclusive because I feel like there are not enough inclusive spaces in Rocklin," she said. "I really wanted everyone in the community to feel welcome."

Opponents of the event attended Tuesday's city council meeting, encouraging the council to stop the event and expressing concern the event would be held in a city-owned venue.

"We're standing. We're raising our voice. We're being heard and we're hoping our city council hears us," said Matthew Oliver of Rocklin, a pastor at The Family Church in Roseville. "Drag shows are sexual in nature and they're not for kids."

Oliver and other opponents of the event held signs against the show, with some speaking during the public comment portion of the meeting.

Oliver said he is specifically concerned with the fact that the event is open to all ages and is being held at the Rocklin Event Center.

"What you do in your own home, what you do in a private event, a private function. What you do as an 18+ event and function, that's not an issue here. The issue is when we start bringing in kids," Oliver said.

Democrats' Sweeping IVF Bill Aims To Stifle Regulation Of Unchecked Big Fertility Market

Democrats who want to stifle oversight and regulation of Big Fertility introduced legislation this month to protect the multi-billion-dollar assisted reproductive technology (ART) industry and punish states and health institutions that try to limit third-party child manufacturing.

Democrats Sen. Tammy Duckworth, Sen. Patty Murray, and Rep. Susan Wild introduced the "Access To Family Building Act" (AFBA) under the guise of protecting in vitro fertilization (IVF) for hopeful parents. In reality, the legislation seeks to ensure the unlimited creation and destruction of healthy eggs, sperm, and — most importantly —embryos in all 50 states by punishing any entity that tries to "unduly restrict access" to a range of reproductive technologies.

Duckworth's bill refuses to specifically define ART. Instead, it points to Section 8 of the 1992 Fertility Clinic Success Rate and Certification Act (FCSRCA). which lists "all treatments or procedures" that include eggs, sperm, and embryos; IVF; and surgical reproduction procedures like gamete and zygote intrafallopian transfer (GIFT and ZIFT) as eligible for protection under the Democrats' latest legislation.

The FCSRCA also includes a provision empowering the U.S. Secretary of Health and Human Services to expand the definition of ART to "such other specific technologies" as long as he publicizes his intent "in such manner as to facilitate comment from any person (including any Federal or other public agency)."

The sweeping and subjective categorizations in the FCSRCA mean that while manufacturing lifelong motherless and fatherless children, surrogacy, and experimental transhumanist technologies like artificial wombs, "gene editing," and sidelining women in reproduction are not explicitly mentioned in Duckworth's bill, they could easily be construed to fit within the parameters of protection.

If passed, Duckworth's bill would permit individuals and Big Fertility facilities to sue if any state moves to impose even globally accepted common sense limits on procedures like IVF, surrogacy, and oocyte sales. It would also give President Joe Biden's Department of Justice the justification to pursue action against any state, facility, or individual that tries to limit or regulate the use of past, present, and future babymaking tech.

'No cash accepted' signs are bad news for millions of Americans

How many people don't have a bank account? And just how difficult has it become to live without one?

These questions are becoming increasingly important as more businesses refuse to take cash in cities across the U.S. People without bank accounts are shut out from stores and restaurants that refuse to accept cash.

As it happens, a lot of people are still "unbanked": roughly 6 million in the U.S., the latest data shows, which is about the population of Wisconsin. And outside of the U.S., more than a billion people don't have a bank account.

I am a business school professor who researches society's transition from cash to electronic payments. I recently visited Seattle and was amazed by the mixed signals I saw in many storefronts. Numerous shops had one sign proudly proclaiming how welcoming and inclusive they were — next to another sign saying "No cash accepted." This tells people without bank accounts that they aren't welcome.
