The first church of artificial intelligence has shut its conceptual doors.

Anthony Levandowski, the former Google engineer who avoided an 18-month prison sentence after receiving a presidential pardon last month, has closed the church he created to understand and accept a godhead based on artificial intelligence.

The Way of the Future church, which Levandowski formed in 2015, was officially dissolved at the end of the year, according to state and federal records. However, the process had started months before in June 2020, documents filed with the state of California show. The entirety of the church's funds — exactly \$175,172 — were donated to the NAACP Legal Defense and Education Fund. The nonprofit corporation's annual tax filings with the Internal Revenue Service show it had \$175,172 in its account as far back as 2017.

Dugan began working for DARPA in 1996. Over the next 4 years, she led numerous multimillion-dollar research programs.

After leaving DARPA in March 2012, she was appointed to an executive position at Google. There, she led and created Advanced Technology and Projects (ATAP) at Motorola Mobility, a subsidiary of Google. In January 2014, it was announced that Motorola Mobility would be acquired by Lenovo. Dugan and her team were retained by Google. She later moved to Facebook, joining a team called Building 8. In October 2017, she announced that she would be leaving in early 2018 to pursue other endeavors.[4][5][6] In May 2020, she was announced as the CEO of Wellcome Leap.

Wellcome Leap aims to deliver breakthroughs that could fundamentally change science and transform human health over five to ten years.

Dugan partly attributes DARPA's success to an unwavering dedication to Pasteur's quadrant. The term, coined by political scientist Donald E. It is contrasted with Bohr's quadrant, which seeks foundational knowledge about the world without any consideration for practical application and with Edison's quadrant in which purely practical problem solving is attempted.

Computer engineers and tech-inclined political scientists have warned for years that cheap, powerful artificial intelligence tools would soon allow anyone to create fake images, video and audio that was realistic enough to fool voters and perhaps sway an election.

The synthetic images that emerged were often crude, unconvincing and costly to produce, especially when other kinds of misinformation were so inexpensive and easy to spread on social media. The threat posed by AI and so-called deepfakes always seemed a year or two away.

Sophisticated generative AI tools can now create cloned human voices and hyperrealistic images, videos and audio in seconds, at minimal cost. When strapped to powerful social media algorithms, this fake and digitally created content can spread far and fast and target highly specific audiences, potentially taking campaign dirty tricks to a new low.

The implications for the 2024 campaigns and elections are as large as they are troubling: Generative AI can not only rapidly produce targeted campaign emails, texts or videos, it also could be used to mislead voters, impersonate candidates and undermine elections on a scale and at a speed not yet seen.

A clinical trial of an experimental universal influenza vaccine developed by researchers at the National Institute of Allergy and Infectious Diseases' (NIAID) Vaccine Research Center (VRC), part of the National Institutes of Health, has begun enrolling volunteers at Duke University in Durham, North Carolina. This Phase 1 trial will test the experimental vaccine, known as H1ssF-3928 mRNA-LNP, for safety and its ability to induce an immune response.

A universal flu vaccine could serve as an important line of defense against the spread of a future flu pandemic."

A series of recently published preclinical study results show that the Spike Ferritin Nanoparticle (SpFN) COVID-19 vaccine developed by researchers at the Walter Reed Army Institute of Research External link (WRAIR) not only elicits a potent immune response but may also provide broad protection against SARS-CoV-2 variants of concern as well as other coronaviruses.

Scientists in WRAIR's Emerging Infectious Diseases Branch (EIDB) developed the SpFN nanoparticle vaccine, based on a ferritin platform, as part of a forward-thinking "pan-SARS" strategy that aims to address the current pandemic and acts as a first line of defense against variants of concern and similar viruses that could emerge in the future.

AI Chatbots Have Been Used to Create Dozens of News Content Farms A new report documents 49 new websites populated by AI tools like ChatGPT and posing as news outlets

The news-rating group NewsGuard has found dozens of news websites generated by AI chatbots proliferating online, according to a report published Monday, raising questions about how the technology may supercharge established fraud techniques.

The 49 websites, which were independently reviewed by Bloomberg, run the gamut. Some are dressed up as breaking news sites with generic-sounding names like News Live 79 and Daily Business Post, while others share lifestyle tips, celebrity news or publish sponsored content. But none disclose they're populated using AI chatbots such as OpenAI Inc.'s ChatGPT and potentially Alphabet Inc.'s Google Bard, which can generate detailed text based on simple user prompts. Many of the websites began publishing this year as the AI tools began to be widely used by the public.

Shock Poll: Results Show More Than Half Of Christians Are Deceiving Themselves

More than half of born-again Christians don't believe Jesus lived a sinless life.

That is what the respected George Barna survey tells us.

Many people want to blame this sorry state all on COVID-19, when 15 million people stopped attending church in America.

As the apologetics website Got Questions explains, Jesus being sinless is central to the hope Christians have in Him as Savior. It explains why it's so important to believe. If he was not God incarnate, Jesus would not be able to forgive sins.

Born-again Christians make up the backbone of church activity and a high level of commitment to their faith, but the study shows that between 2020 and 2023, the share of those who say they believe Jesus did not commit sins during his lifetime on Earth fell from 58% to 44%.

This shift in belief among born-again Christians was among six that showed a significant decline in the past three years, which Barna characterizes as "indefensible." Those include the findings that fewer than half of born-again Christians now believe they have a unique, God-given calling or purpose. The share of those who held that belief fell from 88 to 46% during the pandemic.
