California judge halts district policy requiring parents be told if kids change pronouns

A judge on Wednesday halted a Southern California school district from requiring parents to be notified if their children change their gender identification or pronouns at school.

San Bernardino County Superior Court Judge Thomas S. Garza ruled after California Attorney General Rob Bonta sued the Chino Valley Unified School District for adopting a policy requiring schools to tell parents when their children change their pronouns or use a bathroom of a gender other than the one listed on their official paperwork.

“Today’s decision by the San Bernardino Superior Court rightfully upholds the state rights of our LGBTQ+ students and protects kids from harm by immediately halting the board’s forced outing policy,” Attorney General Rob Bonta said in a statement.

The California Megachurch Pushing Public Schools to the Far Right

From fights over LGBT rights to prayer at school board meetings, Chino Valley public schools have become ground zero for the culture wars.

Outside the California State Capitol last month, a fitness trainer turned school board president fired up the crowd at a parental rights rally, telling them they were all fighters in “a spiritual battle” for their kids and must answer the call from God.

Sonja Shaw, who was elected to the Chino Valley Unified School District board of education last November with an assist from a local megachurch and its Christian nationalist pastor, didn’t equivocate in naming the enemy: state Democratic officials who are challenging her right-leaning policies—and drafting laws that hinder book bans and protect teachers from harassment.

“Today we stand here and declare in his almighty name that it’s only a matter of time before we take your seats and we be a God-fearing example to the nation, how God is

using California to lead the way,” Shaw crowed, adding, “We already know who has won this battle. You will be removed in Jesus’s name! You, Satan, are losing.”

But in Chino Valley, the school board’s new direction appears to be spurred on by a man behind the curtain: Shaw’s megachurch pastor Jack Hibbs.

Indeed, three of the board’s five members belong to his church, Calvary Chapel Chino Hills.

At the Sacramento rally, Hibbs boasted of his congregation’s work in electing Shaw. Calling her a “true modern-day Deborah,” Hibbs said the soccer mom “heeded the call to run for the school board” and that “when churches get involved and get informed, people vote.”

God, Hibbs said, installed Shaw into her position.

Israeli scientists grow human embryo models from stem cells  
Breakthrough could promote new research directions on early pregnancy failure, birth defects, infertility and the production of replacement tissues and organs.

Without needing human sperm to impregnate human eggs to create embryos, researchers at the Weizmann Institute of Science in Rehovot have created complete

models of human embryos from stem cells cultured in the lab and managed to grow them without a womb up to the 14th day.

The team built on their recent achievement of creating synthetic stem cell-based models of mouse embryos.

The team said their breakthrough could open new avenues of research into infertility, early pregnancy failure, birth defects, drug testing and growth of tissues for transplant – as well as help scientists peer into the dramatic first weeks of embryonic development.

Want your California driver's license on your smartphone? Here's how to sign up

Californians can sign up to be a part of the state's Department of Motor Vehicles' newly expanded mobile driver's license program.

The program allows users to have an official digital version of their driver's license on their smartphone.

During the pilot program, users can make age-restricted purchases at a limited number of locations and fly out of specific terminals at certain California airports.

Users will then be prompted to take a photo of the front and back of their physical driver's license using their phone's camera.

The app then seeks to verify the user's identity using the phone's front-facing camera to scan their face.

After that, the app will briefly process the data and if the user is approved their mobile driver's license will be immediately available.

State prosecutor makes final case to criminalise "insulting" Christian speech as Finnish Bible Trial concludes

The Finnish trial of the Bible has concluded before the Helsinki Court of Appeal, where longstanding parliamentarian and former government minister Päivi Räsänen stood trial on charges of "hate speech" on account of three expressions of her Christian faith – in a tweet, in a 2004 church pamphlet, and in a 2019 radio interview. The medical doctor and grandmother of ten was charged for "agitation against a minority group", a provision that falls under the section of the Finnish Criminal Code titled "War Crimes and Crimes Against Humanity."

"I'm hopeful that all these charges will be acquitted. It's a very important verdict for freedom of speech and of religion and Finland, and also has consequences across Europe, but I'm hopeful for a good result," said Räsänen upon leaving the court.

Räsänen's tweet, which began a lengthy police investigation which brought forth three charges, challenged her Church leadership as to their justification for sponsoring a Pride event. She attached a picture of a Bible verse from Romans.

The court is expected to deliver a verdict by November 30th.

Liberty Safe Confirms They Gave Feds Access Code to Gun Safe During Raid on January 6 Protester

Liberty Safe, "America's #1 heavy-duty home and gun safe manufacturer," according to their website, issued a statement late Tuesday night confirming that they'd given the FBI an access code to a customer's gun safe in response to a request on August 30, 2023. That request came during a raid on the home of a man who'd attended a protest on January 6.

The incident they're referring to is the arrest of Nathan Hughes in Arkansas on August 30, 2023, after an FBI raid related to Hughes' attendance at the January 6 protests. On Monday evening the Hodgetwins tweeted out Hughes' story, including that "the feds called the manufacturer of his Liberty Gun Safe and got the passcode to get into it too."

Last week, a friend of ours was raided by the feds over J6, his name is Nathan Hughes and he's from Fayetteville, Arkansas. Nate was raided by the FBI and arrested at gun point. His girlfriend (who just had a miscarriage) was held at gun point and put in handcuffs. The FBI turned off his security cameras, unplugged his internet, and flipped his house upside down in a search. The feds called the manufacturer of his Liberty Gun Safe and got the passcode to get into it too. All for protesting at the Capitol over 2 1/2 years ago.

He is being charged with crimes related to January 6th. He didn't assault anyone and he didn't vandalize anything. He is being labeled a domestic terrorist and a traitor to his country by woke leftists and the media.

California to pay over \$192K to settle free speech lawsuit with pro-life group

The state of California will have to pay more than \$192,000 in expenses and legal fees to settle a lawsuit filed by a pro-life group over a law that restricted protests at vaccination sites.

In an order released this week, Right to Life of Central California and the office of California Attorney General Rob Bonta agreed to a settlement in which the state would not enforce Senate Bill 742 against the pro-life group or any other speaker. Additionally,



the state agreed to pay the plaintiff "\$192,706 in reasonable attorneys' fees and expenses."

The Right to Life filed suit against California after the state passed SB 742 in October 2021, which restricted protests outside of vaccination sites, including a local Planned Parenthood clinic that provided vaccines for human papillomavirus.

"The First Amendment protects every Californian, regardless of their viewpoint. Now Right to Life's staff and volunteers can continue their critical mission of serving vulnerable women in the central California region with their free, life-giving services."

Signed into law by Democratic Gov. Gavin Newsom, SB 742 made it illegal to approach and harass a person who is "within 100 feet of the entrance or exit of a vaccination site and is seeking to enter or exit a vaccination site."

## California moves to decriminalize use of magic mushrooms and other natural psychedelics

California lawmakers on Thursday narrowly approved a bill supported by veterans and criminal justice reform advocates to decriminalize the possession and personal use of a limited list of natural psychedelics, including "magic mushrooms."

Gov. Gavin Newsom will now decide the fate of Senate Bill 58, which would remove criminal penalties for the possession and use of psilocybin and psilocin, the active ingredients in psychedelic mushrooms, mescaline and dimethyltryptamine, or DMT, known as ayahuasca. The bill also would require the California Health and Human Services Agency to study the therapeutic use of psychedelics and submit a report with its findings and recommendations to the Legislature.

The measure passed the Senate 21 to 14, with several Democrats opposing.

“California’s veterans, first responders, and others struggling with PTSD, depression, and addiction deserve access to these promising plant medicines,” state Sen. Scott Wiener (D-San Francisco) said in a statement after the bill passed the Assembly in a bipartisan 42-11 vote. “It’s time to stop criminalizing people who use psychedelics for healing or personal well-being.”
