I. The Root of Murder: Anger in the Heart (vv. 21–22)

Jesus takes the Sixth Commandment "You shall not murder" and exposes that the sin of murder begins not with a physical act, but with a heart posture.

 The Problem with Shallow Righteousness (v. 21): The Pharisees reduced the Law to mere external behavior. Jesus corrects this.

- It is not enough to simply avoid physical murder. We must examine whether we harbor the seeds of murder: anger, resentment, coldness, or passive hatred.

 The Warning Against Internal Anger (v. 22): Jesus, speaking as the divine Lawgiver, shows that the Law is spiritual, reaching motives and affections.

- Sinful Anger is Murder in Seed Form:
 Unresolved anger is not a small thing; it is a spiritual emergency that poisons relationships.

- Contemptuous Speech is a Violation: Insults like "Raca" or "You fool" reveal a corrupt heart because the tongue reveals the heart.

- Contemptuous Speech is a Violation: Insults like "Raca" or "You fool" reveal a corrupt heart because the tongue reveals the heart.
- The Consequence is Eschatological: Jesus links internal anger and contempt to eschatological judgment (the "fiery hell"), not just earthly consequences.

- Application: We must identify and repent of sinful anger quickly. Confess the silent grudges and murderous thoughts that never show on your face.

II. The Requirement of Reconciliation: Making Things Right (vv. 23–24)

 Reconciliation Before Worship (v. 23): If you are presenting your offering (worship) and you remember that your brother has something against you:

- Application: Refuse to separate personal holiness from public worship. Let conviction interrupt your routine.

 Prioritize Reconciliation (v. 24): We must leave our offering, first be reconciled, and then come and present our offering.

 - Reconciliation must be prioritized, not postponed.

II. The Requirement of Reconciliation: Making Things Right (vv. 23–24)

- Prioritize Reconciliation (v. 24): We must leave our offering, first be reconciled, and then come and present our offering.

 - Take the first step, even if the other person may be partly wrong.

- Seek genuine restoration and relational repair, not just quick, superficial peace. Be willing to pay the relational cost (humility, time, vulnerability).

• Urgency of Repentance (v. 25): The journey "on the way to court" symbolizes the believer's journey toward the final judgment.

- Application: Treat unresolved conflict as an urgent spiritual danger. Do not wait for the "right moment"—go now.

 The High Cost of Sin (v. 26): The inability to pay the "last quadrans" symbolizes the impossibility of escaping divine justice without repentance.
